



LOCAL LIMITS OF SPATIAL INHOMOGENEOUS RANDOM GRAPHS

Abstract

Consider a set of n vertices, where each vertex has a location in \mathbb{R}^d that is sampled uniformly from the unit cube in \mathbb{R}^d , and a weight associated to it. Construct a random graph by placing edges independently for each vertex pair with a probability that is a function of the distance between the locations and the vertex weights.

Under appropriate integrability assumptions on the edge probabilities that imply sparseness of the model, after appropriately blowing up the locations, we prove that the local limit of this random graph sequence is the (countably) infinite random graph on \mathbb{R}^d with vertex locations given by a homogeneous Poisson point process, having weights which are independent and identically distributed copies of limiting vertex weights. Our set-up covers many sparse geometric random graph models from the literature, including geometric inhomogeneous random graphs (GIRGs), hyperbolic random graphs, continuum scale-free percolation, and weight-dependent random connection models.

We prove that the limiting degree distribution is mixed Poisson and the typical degree sequence is uniformly integrable, and we obtain convergence results on various measures of clustering in our graphs as a consequence of local convergence. Finally, as a byproduct of our argument, we prove a doubly logarithmic lower bound on typical distances in this general setting.

1. Introduction and main results

Random graphs with underlying geometry are becoming the model of choice when it comes to modeling and understanding real-world networks [6, 12, 18, 25] (see also [22, Section 9.5]). The presence of an ambient geometric space enables one to model the natural tendency for connections to form between entities that are *close* to each other, where *closeness* is measured in terms of the underlying geometry. The power of these models is the inherent diversity of the geometric component. It can encode actual physical distance, such as two servers in adjacent cities, as well as a more abstract form of similarity, e.g., users with similar interests or hobbies.

Spatial networks have been employed to study social networks [33]. Empirical research shows that the spatial positions of individuals often play a role in the formation of friendships among them [1, 28, 31, 32].

The prototypical random graph model in this setting is the random geometric graph, first introduced by Gilbert [16] and later popularized by Penrose [29]. Here the graph is formed by placing edges between pairs of points of some Poisson point process on a Euclidean space, if and only if their metric distance is smaller than some fixed parameter. In general, one can consider models in which the connection probabilities are a decreasing function of the distance between pairs of vertices. Since nearby vertices are more likely to be connected in these spatial models, they naturally exhibit *clustering*, which captures the tendency for a connection to exist between two entities having a common neighbor, a feature that is often observed in real-world networks.

Other than clustering, experimental studies suggest that most real-world networks are *sparse* (i.e., the number of connections is often of the same order as the number of individuals) and that they are small worlds (i.e., for most pairs of nodes, it takes only a small number of connection steps to reach one from the other). Finally, many networks have highly inhomogeneous degree distributions (i.e., many vertices have only a few connections, while a small proportion of vertices have a lot of connections). The most notable spatial random graph models capable of capturing all these features are scale-free percolation [12], geometric inhomogeneous random graphs [8], and hyperbolic random graphs [25].

When studying network models, one is often interested in the limits of specific network measures, e.g., degree distribution, average path length, or clustering coefficients. There is plenty of literature analyzing limits of such measures for a wide variety of models. Here, however, one first must prove convergence. Suppose that instead we have a limit object for our graph models, which implies convergence of the network measures of interest. Then we no longer have to worry about convergence and can instead focus on actually analyzing the limit measures. For sparse graphs such a framework exists under the name of local weak convergence [2, 4]. At a high level, if a model has a local weak limit, then any local property converges to an associated measure on the limit graph. Therefore, if we know the local graph limit, we immediately obtain the limits of a wide variety of local network measures [22, Chapter 2]. Furthermore, sometimes conclusions about sufficiently global properties of the graph can also be obtained from its local behavior (see [21] and [22, Chapter 2]).

In this paper, we study local convergence of a general class of spatial random graphs, which cover as particular cases many well-known models that are sparse, have inhomogeneous degree distributions, have short path lengths, and exhibit non-vanishing clustering. We establish that the typical local behavior in these ensembles matches the expected local behavior of the natural infinite version of the model. Our results immediately imply convergence of several local network measures, such as the degree distribution of a random vertex and the local clustering coefficient.

Organization of the paper. In the rest of this section, we review the basics of local convergence of graphs, introduce our model, and state our main results. Next, in Section 2, we present examples of models that are covered, as well as results on degrees and clustering in our graphs, and a small discussion on typical distances in our models. All the proofs are deferred to Section 3.

1.1. The space of rooted graphs and local convergence

The notion of local convergence of graphs was first introduced by Benjamini and Schramm [4] and independently by Aldous and Steele [2]. Intuitively, this notion studies the asymptotic local properties of a graph sequence, as observed from a typical vertex.

A (possibly infinite) graph $G = (V(G), E(G))$ is called *locally finite* when every vertex has finite degree. A rooted locally finite graph is a tuple (G, o) , where $G = (V(G), E(G))$ is a locally finite graph, with a designated vertex $o \in V(G)$ called *the root*.

Definition 1. (*Rooted isomorphism.*) For rooted locally finite graphs (G_1, o_1) and (G_2, o_2) where $G_1 = (V(G_1), E(G_1))$ and $G_2 = (V(G_2), E(G_2))$, we say that (G_1, o_1) is rooted isomorphic to (G_2, o_2) when there exists a graph isomorphism between G_1 and G_2 mapping o_1 to o_2 , i.e., when there exists a bijective function $\phi: V(G_1) \rightarrow V(G_2)$ such that

$$\{u, v\} \in E(G_1) \iff \{\phi(u), \phi(v)\} \in E(G_2),$$

and such that $\phi(o_1) = o_2$.

We use the notation

$$(G_1, o_1) \cong (G_2, o_2)$$

to denote that there is a rooted isomorphism between (G_1, o_1) and (G_2, o_2) .

Let \mathcal{G}_\star be the space of all rooted isomorphic equivalence classes of locally finite rooted graphs; i.e., \mathcal{G}_\star consists of the equivalence classes $[(G, o)]$ of rooted locally finite graphs, where two rooted locally finite graphs (G_1, o_1) and (G_2, o_2) belong to the same class if they are rooted isomorphic to each other. We often omit the equivalence class notation, and just write (G, o) for an element of \mathcal{G}_\star .

Fix a graph $G = (V(G), E(G))$. We denote the graph distance in G by d_G ; i.e., for any two vertices $u, v \in V(G)$, $d_G(u, v)$ equals the length of the shortest path in G from u to v , and we adopt the convention that $d_G(u, v) = \infty$ whenever u and v are not connected by a sequence of edges.

Definition 2. (*Neighborhood of the root.*) For any $R \geq 1$ and $(G, o) \in \mathcal{G}_\star$ where $G = (V(G), E(G))$, we call the element $(B_o^G(R), o)$ of \mathcal{G}_\star the *R-neighborhood of o in G*, where $B_o^G(R)$ is the subgraph of G induced by

$$\{v \in V(G) : d_G(o, v) \leq R\}.$$

We sometimes abbreviate $(B_o^G(R), o)$ as $B_o^G(R)$.

The space \mathcal{G}_\star is usually endowed with the *local topology*, which is the smallest topology that makes the functions of the form $(G, o) \mapsto \mathbb{1}_{\{B_o^G(K) \cong (G', o')\}}$ for $K \geq 1$ and $(G', o') \in \mathcal{G}_\star$ continuous. This topology is metrizable with an appropriate metric d_\star (see [22, Definition 2.4]), and $(\mathcal{G}_\star, d_\star)$ is a Polish space, which enables one to do probability on it. We omit further details on this.

For the next two definitions, we assume that $(G_n)_{n \geq 1}$ with $G_n = (V(G_n), E(G_n))$ is a sequence of (possibly random) graphs that are (almost surely) finite, i.e., $|V(G_n)| \stackrel{a.s.}{<} \infty$ for all $n \geq 1$, and, conditionally on G_n , U_n is a uniformly chosen random vertex of G_n . Note then that (G_n, U_n) is a random variable taking values in \mathcal{G}_\star . Local weak convergence of such random variables is defined as follows.

Definition 3. (*Local weak convergence.*) The sequence of graphs $(G_n)_{n \geq 1}$ is said to converge locally weakly to the random element $(G, o) \in \mathcal{G}_\star$ having law μ_\star , as $n \rightarrow \infty$, when, for every $r > 0$, and for every $(G_\star, o_\star) \in \mathcal{G}_\star$,

$$\mathbb{P} \left(B_{U_n}^{G_n}(r) \cong (G_\star, o_\star) \right) \rightarrow \mu_\star \left(B_o^G(r) \cong (G_\star, o_\star) \right),$$

as $n \rightarrow \infty$.

Definition 3 is in fact equivalent to saying that the sequence $((G_n, U_n))_{n \geq 1}$ of random variables taking values in \mathcal{G}_\star converges in distribution to the random variable (G, o) taking values in \mathcal{G}_\star as $n \rightarrow \infty$, under the topology induced by the metric d_\star on \mathcal{G}_\star (for a proof of this fact, see [22, Definition 2.10 and Theorem 2.13]).

This concept of *local convergence* can be adapted to the setting of convergence in probability. For a sequence of random variables $Z, (Z_n)_{n \geq 1}$, we write $Z_n \xrightarrow{\mathbb{P}} Z$ to indicate that Z_n converges in probability to Z , as $n \rightarrow \infty$.

Definition 4. (*Convergence locally in probability.*) The sequence of graphs $(G_n)_{n \geq 1}$ is said to converge locally in probability to the (possibly random) element $(G, o) \in \mathcal{G}_\star$ having (possibly random) law μ if for any $r > 0$ and any $(G_\star, o_\star) \in \mathcal{G}_\star$,

$$\mathbb{P} \left(B_{U_n}^{G_n}(r) \cong (G_\star, o_\star) \mid G_n \right) = \frac{1}{|V(G_n)|} \sum_{i \in V(G_n)} \mathbb{1}_{\{B_i^{G_n}(r) \cong (G_\star, o_\star)\}} \xrightarrow{\mathbb{P}} \mu \left(B_o^G(r) \cong (G_\star, o_\star) \right),$$

as $n \rightarrow \infty$.

For more on local convergence, we refer the reader to [22, Chapter 2].

1.2. Model description and assumptions

Let S be either $[n] = \{1, \dots, n\}$ or $\mathbb{N} \cup \{0\}$.

Consider a sequence $\mathbf{X} = (X_i)_{i \in S}$ of (possibly random) points in \mathbb{R}^d , a sequence of (possibly random) reals $\mathbf{W} = (W_i)_{i \in S}$, and a function $\kappa : \mathbb{R}_+ \times \mathbb{R} \times \mathbb{R} \rightarrow [0, 1]$ which is symmetric in its second and third arguments.

Conditionally on \mathbf{X} and \mathbf{W} , form the (undirected) random graph $G = (V(G), E(G))$ with vertex set $V(G) = S$, and with each possible edge $\{i, j\} \in E(G) \subset S \times S$ being included independently with probability

$$\kappa(\|X_i - X_j\|, W_i, W_j). \quad (1)$$

Note that the requirement of symmetry is necessary since the probability of including the edge $\{i, j\}$ has to be the same as the probability of including the edge $\{j, i\}$. For each vertex i , we think of X_i as the *spatial location* of the vertex, and W_i as the *weight* associated to it.

We call such a graph G a **spatial inhomogeneous random graph**, or **SIRG** for short, and we use the notation

$$G(\mathbf{X}, \mathbf{W}, \kappa) \quad (2)$$

to denote the SIRG corresponding to the location sequence \mathbf{X} , weight sequence \mathbf{W} , and connection function κ .

Remark 1. (*Non-spatial inhomogeneous random graphs.*) In the setting of (non-spatial) inhomogeneous random graph as proposed by Bollobás, Janson and Riordan in [5], the vertex locations of the SIRGs can be thought of as *types* associated to each vertex. However, the type

space in [5] was taken to be an abstract space without any structure. In our model, these are locations in a Euclidean space, with connections depending upon distances between vertex locations, incorporating the underlying metric structure. In particular, in our models, the edge probabilities are large for nearby vertices, while in [5], edge probabilities are typically of the order $1/n$. This allows for non-trivial clustering to be present in our models, unlike in [5], where the local limits are multitype branching processes; see [22, Chapter 3].

Consider a sequence $G_n = (V(G_n) = [n], E(G_n)) = G(\mathbf{X}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ of SIRGs of size n . Then $\mathbf{X}^{(n)} = (X_i^{(n)})_{i \in [n]}$ and $\mathbf{W}^{(n)} = (W_i^{(n)})_{i \in [n]}$ are the location and weight sequences, respectively, while κ_n is the sequence of connection functions. If $\mathbf{X}^{(n)}$, $\mathbf{W}^{(n)}$, and κ_n have limits \mathbf{X} , \mathbf{W} , and κ , respectively, as $n \rightarrow \infty$ and in some appropriate sense, it is natural to expect the sequence of random graphs $G(\mathbf{X}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ to have the graph $G(\mathbf{X}, \mathbf{W}, \kappa)$ as its limit. Our main contribution formalizes this intuition using local convergence, under appropriate convergence assumptions on $\mathbf{X}^{(n)}$, $\mathbf{W}^{(n)}$, and κ_n , which we discuss next.

Assumption 1. (*Law of vertex locations.*) Define the box

$$I := \left[-\frac{1}{2}, \frac{1}{2}\right]^d. \tag{3}$$

For each $n \in \mathbb{N}$, the collection $(X_i^{(n)})_{i \in [n]}$ is a collection of independent and uniformly distributed random variables on the box I .

Assumption 2. (*Weight distributions.*) Let $\mathbf{W}^{(n)} = (W_i^{(n)})_{i \in [n]}$ be the sequence of weights associated to the vertices of G_n , and assume that $\mathbf{W}^{(n)}$ is independent of $\mathbf{X}^{(n)}$. Furthermore, we assume that there exists a random variable W , with distribution function $F_W(x) := \mathbb{P}(W \leq x)$, such that for every continuity point x of $F_W(x)$,

$$\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{W_i^{(n)} \leq x\}} \xrightarrow{\mathbb{P}} F_W(x), \tag{4}$$

as $n \rightarrow \infty$. That is, we assume convergence in probability of the (possibly random) empirical distribution function to the (deterministic) distribution function F_W of some limiting weight random variable W .

The above assumption on the weights in our model is natural. Note that if we let U_n be uniform on $[n] = \{1, \dots, n\}$, then (4) is equivalent to the convergence in distribution of the typical weight $W_{U_n}^{(n)}$, conditionally on the entire weight sequence $(W_i^{(n)})_{i \in [n]}$, to W . Such regularity conditions are essential for understanding the behavior of the typical vertex, which is what local convergence aims to understand. Similar regularity assumptions on the weight of a typical vertex are also required for generalized random graphs (see e.g. [20, Condition 6.4]) to make sure the typical degree distribution has a limit.

In most spatial random graph models, one starts with an infinite weight sequence and assigns the first n entries of this sequence as weights to the vertices of G_n . This infinite weight sequence usually is deterministic, or is an independent and identically distributed (i.i.d.) sequence of weights from some given distribution. Note that for the latter, the above assumption is satisfied using the strong law of large numbers, and for the former case, (4) ensures that we have convergence in distribution of the typical weight.

We also need some convergence assumptions for the sequence of connection functions κ_n .

Assumption 3. (Connection functions.)

1. There exists a function $\kappa : \mathbb{R}_+ \times \mathbb{R} \times \mathbb{R} \rightarrow [0, 1]$ such that for every pair of real sequences $x_n \rightarrow x$ and $y_n \rightarrow y$, and for almost every $t \in \mathbb{R}_+$,

$$\kappa_n(n^{1/d}t, x_n, y_n) \rightarrow \kappa(t, x, y), \quad (5)$$

as $n \rightarrow \infty$.

2. Let $W^{(1)}$ and $W^{(2)}$ be two i.i.d. copies of the limiting weight random variable W . Then there exist $t_0 > 0$, $\alpha > 0$, such that, for any $t \in \mathbb{R}_+$ with $t > t_0$,

$$\mathbb{E} \left[\kappa(t, W^{(1)}, W^{(2)}) \right] \leq t^{-\alpha}. \quad (6)$$

Before stating our results, let us reflect on Assumption 3 a little. The term $n^{1/d}$ in the first argument of κ_n is required, because to obtain a local limit, we need to blow up the vertex locations from being uniform on I (recall (3)) to being uniform on

$$I_n := \left[-\frac{n^{1/d}}{2}, \frac{n^{1/d}}{2} \right]^d. \quad (7)$$

This is done via the transformation $x \mapsto n^{1/d}x$, and the $n^{1/d}$ term in (5) ensures convergence of κ_n after this transformation.

Next, the ‘strong’ form of continuity in (5) is required so that the connection function sequence κ_n is continuous with respect to convergence of weights as formulated in (4). To explain this, let $j \in \mathbb{N}$, and consider a sequence $(h_n)_{n \geq 1}$ of bounded continuous functions $h_n : \mathbb{R}^j \rightarrow \mathbb{R}$, converging to a bounded continuous function $h : \mathbb{R}^j \rightarrow \mathbb{R}$ in the following ‘strong’ sense analogous to (5): for any collection $\{(x_n^i)_{n \geq 1} : 1 \leq i \leq j\}$ of j real sequences satisfying $x_n^i \rightarrow x_i$ as $n \rightarrow \infty$ for $1 \leq i \leq j$, $h_n(x_n^1, \dots, x_n^j) \rightarrow h(x_1, \dots, x_j)$. Then, if for each $n \in \mathbb{N}$ we let $U_{n,1}, \dots, U_{n,j}$ be j independent uniformly distributed random variables on $[n]$ and let $W^{(1)}, \dots, W^{(j)}$ be j i.i.d. copies of the limiting weight random variable W , (4) implies that

$$\mathbb{E} \left[h_n(W_{U_{n,1}}^{(n)}, \dots, W_{U_{n,j}}^{(n)}) \right] \rightarrow \mathbb{E} \left[h(W^{(1)}, \dots, W^{(j)}) \right], \quad (8)$$

as $n \rightarrow \infty$. In particular, as a consequence of (5) and (4), one can take h_n in (8) to be κ_n , or products of κ_n , which will enable us to compute probabilities that paths exist in our finite graphs G_n . Note that (8) is not true in general if we just assume that the function h_n is continuous on \mathbb{R}^j for each fixed $n \in \mathbb{N}$.

The above strong sense of continuity is in line with the assumption of *graphical kernels* in [5] (see [5, (2.10)]). In the setting of [5], if we now consider the weights (instead of vertex locations as in Remark 1) associated to each vertex as vertex types, then we merely require the connection kernels to be continuous with respect to convergence of types, which is one of the key properties of graphical kernels in [5].

Finally, let us discuss the technicality of having the convergence (5) hold for almost every $t \in \mathbb{R}_+$, instead of all t . This is a purely technical condition, to avoid pathological examples. For example, consider the sequence of connection functions $\kappa_n(t, x, y) := \mathbb{1}_{\{t < n^{1/d}xy\}}$. We naturally want the limit of this sequence of connection functions to be $\mathbb{1}_{\{t < xy\}}$. It is easily verified that for

any pair of real sequences $x_n \rightarrow x$ and $y_n \rightarrow y$, (5) holds, except possibly for $t \in \{xy\}$, a set of measure zero, with limiting connection function $\kappa(t, x, y) = \mathbb{1}_{\{t < xy\}}$. In particular, Assumption 3(1) holds. Typically, t will be replaced by $\|X_i^{(n)} - X_j^{(n)}\|$, with $X_i^{(n)}, X_j^{(n)}$ being the respective locations of two vertices i and j . Since, under Assumption 1, the random variable $\|X_i^{(n)} - X_j^{(n)}\|$ is a continuous random variable, it will avoid sets of measure zero, and Assumption 3(1) will continue to hold in our probabilistic statements.

1.3. Statement of main results

Let us now formally discuss the limit of the SIRG model. As mentioned before, we shall consider the ‘blown-up’ SIRG sequence $\mathbb{G}_n = G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$, where $\mathbf{Y}^{(n)} = (Y_i^{(n)})_{i \in [n]}$, with $Y_i^{(n)} = n^{1/d} X_i^{(n)}$ for all $i \in [n]$, and $\mathbf{X}^{(n)} = (X_i^{(n)})_{i \in [n]}$ satisfies Assumption 1, i.e., the locations of \mathbb{G}_n are now i.i.d. uniform variables on I_n (recall (7)).

For convenience, we also define the point process on \mathbb{R}^d , corresponding to the spatial locations of \mathbb{G}_n , as

$$\Gamma_n(\cdot) := \sum_{i=1}^n \delta_{Y_i^{(n)}}(\cdot), \tag{9}$$

where δ_x denotes the Dirac measure at $x \in \mathbb{R}^d$.

If \mathbb{G}_n has a local limit, then it is natural to expect that the weights associated to each vertex in this limit are i.i.d. copies of the limiting weight random variable W because of Assumption 2, and that the limiting connection function is κ . For the locations, it is standard that the sequence Γ_n , viewed as random measures on \mathbb{R}^d , converges to a unit-rate homogeneous Poisson point process on \mathbb{R}^d (see [23]), whose points will serve as the locations of the vertices of the limiting graph.

To this end, let us consider a unit-rate homogeneous Poisson point process Γ , and write its atoms as $\Gamma = \{Y_i\}_{i \in \mathbb{N}}$ (such an enumeration is possible by [27, Corollary 6.5]). Define the point process

$$\Gamma_\infty := \Gamma \cup \{\mathbf{0}\} \tag{10}$$

(where $\mathbf{0} = (0, 0, \dots, 0) \in \mathbb{R}^d$), which is the Palm version of Γ , and write the sequence of its atoms as $\mathbf{Y} = (Y_i)_{i \in \mathbb{N} \cup \{0\}}$, where $Y_0 = \mathbf{0}$. Also let $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$ be a collection of i.i.d. copies of the limiting weight random variable W . Then we define the *infinite SIRG*, whose vertex set is given by $\mathbb{N} \cup \{\mathbf{0}\}$, as $\mathbb{G}_\infty = G(\mathbf{Y}, \mathbf{W}, \kappa)$.

Our first result establishes that \mathbb{G}_n converges locally weakly to \mathbb{G}_∞ .

Theorem 1. (Convergence of SIRGs in the local weak sense.) *Consider the sequence $(\mathbb{G}_n)_{n \geq 1} = (G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n))_{n \geq 1}$ of SIRGs, where $Y_i^{(n)} = n^{1/d} X_i^{(n)}$ for each n and each $i \in [n]$, with $\mathbf{X}^{(n)} = (X_i^{(n)})_{i \in [n]}$, $\mathbf{W}^{(n)} = (W_i^{(n)})_{i \in [n]}$, and κ_n satisfying Assumptions 1, 2, and 3, respectively, with the parameter α in (6) satisfying*

$$\alpha > d.$$

Then $(\mathbb{G}_n)_{n \geq 1}$ converges locally weakly to the infinite rooted SIRG $(\mathbb{G}_\infty, 0)$, rooted at vertex 0, where $\mathbb{G}_\infty = G(\mathbf{Y}, \mathbf{W}, \kappa)$.

Remark 2. (Regularly varying connection functions.) Note that if $\mathbb{E}[\kappa(t, W^{(1)}, W^{(2)})]$, as a function of t , either is itself, or is dominated by, a regularly varying function in t , with some exponent greater than d , then by Potter’s theorem (see e.g. [30]), Assumption 3(2) is satisfied, with some $\alpha > d$. Hence, for such connection functions, Theorem 1 goes through.

Theorem 1 is equivalent to the statement that if U_n is uniformly distributed on $[n]$, then the random rooted graph (\mathbb{G}_n, U_n) converges in distribution to the random rooted graph $(\mathbb{G}_\infty, 0)$, in the space (\mathcal{G}_*, d_*) .

The condition $\alpha > d$ is required to avoid non-integrability of $z \mapsto \mathbb{E} [\kappa(\|z\|, W^{(1)}, W^{(2)})]$ as a function on \mathbb{R}^d . Integrability of $\mathbb{E} [\kappa(\|z\|, W^{(1)}, W^{(2)})]$ implies that the degrees in \mathbb{G}_∞ have finite mean, which ensures that our random graph model is sparse. It also ensures that \mathbb{G}_∞ is locally finite almost surely, which we need for local weak convergence to make sense.

There are two main challenges in proving Theorem 1. The first is to formulate the probability that the rooted subgraph induced by vertices whose locations fall inside a Euclidean ball with some fixed radius centered at the location $Y_{U_n}^{(n)}$ of U_n is isomorphic to a given graph, in terms of suitable functionals of the spatial locations of the vertices. The latter have nice limiting behavior owing to vague convergence of the spatial locations to a homogeneous Poisson process. The second is a careful path-counting analysis to conclude that the expected number of paths starting at U_n , containing vertices with spatial locations far away from the location of U_n , can be made arbitrarily small.

The result of Theorem 1 can be improved to local convergence in probability, as follows.

Theorem 2. (Convergence of SIRGs locally in probability.) *Under the assumptions of Theorem 1, the sequence of SIRGs $(\mathbb{G}_n)_{n \geq 1}$ converges locally in probability to the infinite rooted SIRG $(\mathbb{G}_\infty, 0)$, where $\mathbb{G}_\infty = G(\mathbf{Y}, \mathbf{W}, \kappa)$.*

The improvement in Theorem 2 is achieved via a second moment analysis on neighborhood counts. The required independence essentially follows from the fact that the spatial locations of two uniformly chosen vertices of \mathbb{G}_n are with high probability far apart from each other.

2. Consequences and discussion

In this section, we discuss implications of Theorems 1 and 2. We first discuss some standard examples that are covered under our setting. We then discuss how local convergence implies convergence of interesting graph functionals. We focus our attention on the degree and clustering structure of our SIRGs. Finally we provide a lower bound on typical distances in our graphs.

2.1. Examples

In this section, we discuss examples of spatial random graph models that are covered under our set-up.

2.1.1. *Product SIRGs.* We begin by discussing a particular type of SIRG, in which the connection has a product form.

Definition 5. (*Product SIRGs.*) For a SIRG $G(\mathbf{X}, \mathbf{W}, \kappa)$, if the connection function κ has the product form

$$\kappa(t, x, y) = 1 \wedge f(t)g(x, y), \tag{11}$$

for some non-negative functions $f: \mathbb{R}_+ \rightarrow \mathbb{R}_+$ and $g: \mathbb{R}^2 \rightarrow \mathbb{R}_+$, where g is symmetric, then we call the SIRG a *product SIRG*, or PSIRG for short, and we call κ a product kernel.

Theorem 1 can be directly adapted to the PSIRG setting under appropriate conditions on the product kernel.

Assumption 4. (PSIRG connection functions.) Let $\kappa: \mathbb{R}_+ \times \mathbb{R} \times \mathbb{R} \rightarrow [0, 1]$ be a product kernel $\kappa(t, x, y) = 1 \wedge f(t)g(x, y)$ such that the following hold:

1. There exist $\alpha_p > 1$ and $t_1 \in \mathbb{R}_+$ such that for all $t > t_1$,

$$f(t) \leq t^{-\alpha_p}.$$

2. There exist $\beta_p > 0$ and $t_2 \in \mathbb{R}_+$ such that for all $t > t_2$,

$$\mathbb{P} \left(g(W^{(1)}, W^{(2)}) > t \right) \leq t^{-\beta_p},$$

where $W^{(1)}, W^{(2)}$ are i.i.d. copies of the limiting weight random variable W in (4).

Let $W^{(1)}$ and $W^{(2)}$ be two i.i.d. copies of W (see Assumption 2). The following lemma derives a useful bound on product kernels that satisfy Assumption 4.

Lemma 1. (Bound on product kernel.) Under Assumption 4, for any $\epsilon > 0$, there exists $t_0 = t_0(\epsilon) > 0$ such that whenever $t > t_0$,

$$\mathbb{E} \left[\kappa(t, W^{(1)}, W^{(2)}) \right] \leq t^{-\min\{\alpha_p, \alpha_p \beta_p\} + \epsilon}.$$

In other words, if the limiting connection function κ in Theorem 2 satisfies Assumption 4, it also satisfies Assumption 3(3), with $\alpha = \min\{\alpha_p, \alpha_p \beta_p\} - \epsilon$ for any $\epsilon > 0$. So, if

$$\gamma_p := \min\{\alpha_p, \alpha_p \beta_p\} > d,$$

then using Lemma 1, we have that κ satisfies Assumption 3(3) with some $\alpha > d$, by choosing $\epsilon > 0$ sufficiently small. Hence we obtain the following direct corollary to Theorem 2, whose proof we omit. Recall the vector $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$ of i.i.d. copies of the limiting weight variable W (see (4)), and $\mathbf{Y} = (Y_i)_{i \in \mathbb{N} \cup \{0\}}$ the atoms of Γ_∞ (see (10)), with $Y_0 = \mathbf{0}$.

Corollary 1. (Convergence of PSIRGs locally in probability.) Consider the sequence $(\mathbb{G}_n)_{n \geq 1} = (G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n))_{n \geq 1}$ of SIRGs, where, for each n and each $i \in [n]$, $Y_i^{(n)} = n^{1/d} X_i^{(n)}$, with $\mathbf{X}^{(n)} = (X_i^{(n)})_{i \in [n]}$ and $\mathbf{W}^{(n)} = (W_i^{(n)})_{i \in [n]}$ satisfying Assumptions 1 and 2, κ_n satisfying Assumption 3(1), κ satisfying Assumption 4, and

$$\gamma_p := \min\{\alpha_p, \alpha_p \beta_p\} > d.$$

Then $(\mathbb{G}_n)_{n \geq 1}$ converges locally in probability to the infinite rooted SIRG $(\mathbb{G}_\infty, \mathbf{0})$, rooted at vertex $\mathbf{0}$, where $\mathbb{G}_\infty = G(\mathbf{Y}, \mathbf{W}, \kappa)$.

Remark 3. (Regularly varying product forms.) Note that if $f(t)$ and $\mathbb{P} (g(W^{(1)}, W^{(2)}) > t)$ are regularly varying functions of t outside some compact sets, with respective exponents $\alpha_p > 0$ and $\beta_p > 0$ with $\min\{\alpha_p, \alpha_p \beta_p\} > d$, then by Potter’s theorem (see [30]), they respectively satisfy Assumptions 4(1) and 4(2) with some exponents $\bar{\alpha}_p > 0$ and $\bar{\beta}_p > 0$, with $\min\{\bar{\alpha}_p, \bar{\alpha}_p \bar{\beta}_p\} > d$. Hence for these kinds of connection functions, Lemma 1, and hence Corollary 1, continue to be true.

Remark 4. (Dominance by PSIRG connections.) Note that even if κ is not of product form, but instead is dominated by $1 \wedge f(t)g(x, y)$, with f and g respectively satisfying Assumptions 4(1) and 4(2), with $\gamma_p > d$, then Lemma 1, and hence Corollary 1, continue to be true.

Next we discuss several known models which are all examples of PSIRGs, or of SIRGs with connection functions dominated by PSIRG connection functions. The results that follow are presented as corollaries of Theorem 2, and their proofs are in Section 3.7.

2.1.2. *Geometric inhomogeneous random graphs.* Geometric inhomogeneous random graphs (GIRGs) [6–8] were motivated as spatial versions of the classic Chung–Lu random graphs [9, 10]. Although Chung–Lu random graphs with suitable parameters are scale-free and exhibit small-world properties, they fail to capture clustering, a ubiquitous property of real-world networks.

GIRGs have four parameters: the number of vertices n , $\alpha_G \in (1, \infty]$, $\beta_G > 2$, and the dimension $d \geq 1$. To each vertex $i \in \mathbb{N}$, one associates an independent, uniformly distributed random location $X_i^{(n)}$ on I (recall (3)) and a real weight $W_i^{(n)}$ (possibly random) such that (4) holds. Here the limiting weight variable W has a power-law tail with exponent β_G : there exists $t_G \in \mathbb{R}_+$ such that

$$C_G z^{1-\beta_G} \leq \mathbb{P}(W > z) \leq C_G z^{1-\beta_G}, \tag{12}$$

whenever $z > t_G$, for some absolute constants $C_G, C_G > 0$. In particular, we have $\mathbb{E}[W] < \infty$. Conditionally on $(X_i^{(n)})_{i \in [n]}$ and $(W_i^{(n)})_{i \in [n]}$, each edge $\{i, j\}$ is included independently with probability $p_{i,j}$ given by

$$p_{i,j} = \begin{cases} 1 \wedge \left(\frac{W_i^{(n)} W_j^{(n)}}{\sum_{i \in [n]} W_i^{(n)}} \right)^{\alpha_G} \frac{1}{\|X_i^{(n)} - X_j^{(n)}\|^{d\alpha_G}} & \text{if } 1 < \alpha_G < \infty, \\ \mathbb{1} \left\{ \left(\frac{W_i^{(n)} W_j^{(n)}}{\sum_{i \in [n]} W_i^{(n)}} \right)^{1/d} > \|X_i^{(n)} - X_j^{(n)}\| \right\} & \text{if } \alpha_G = \infty. \end{cases} \tag{13}$$

We denote the resulting random graph by

$$\text{GIRG}_{n,\alpha_G,\beta_G,d}.$$

Remark 5. (*Relationship to GIRGs in [8].*) Our formulation of GIRGs is closer to the formulation adopted in [24] than to that of [8]. In the original definition of GIRGs (see [8]), the connection function is only assumed to be bounded above and below by multiples of (13), and vertex locations are assumed to be uniform on the torus \mathbb{T}_n which is obtained by identifying the boundaries of I . However, to define a local limit, we need the connection function to converge to a limiting function, for which we have taken the explicit form (13). Finally, using the observation that only a negligible proportion of vertex locations fall near the boundary of I , our results can easily be transferred to the torus setting.

Now consider the infinite SIRG $G(\mathbf{Y}, \mathbf{W}, \kappa^{\alpha_G})$, where $\mathbf{Y} = (Y_i)_{i \in \mathbb{N} \cup \{0\}}$ is the sequence of atoms of $\Gamma \cup \{0\}$ (with $Y_0 = 0$), Γ is a unit-rate homogeneous Poisson point process on \mathbb{R}^d , $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$ is an i.i.d. collection of limiting weight random variables W , and $\kappa^{(\alpha_G)}$ is the connection function

$$\kappa^{(\alpha_G)}(t, x, y) = \begin{cases} 1 \wedge \left(\frac{xy}{\mathbb{E}[W]} \right)^{\alpha_G} t^{-d\alpha_G} & \text{if } 1 < \alpha_G < \infty, \\ \mathbb{1} \left\{ \left(\frac{xy}{\mathbb{E}[W]} \right)^{1/d} > t \right\} & \text{if } \alpha_G = \infty. \end{cases} \tag{14}$$

As a corollary to Theorem 2, we establish the local limit of the GIRG sequence to be $(G(\mathbf{Y}, \mathbf{W}, \kappa^{\alpha_G}), 0)$. This answers a question posed in [24] (see [24, Section 2.1]) in the affirmative. We call the above infinite SIRG the *infinite GIRG*, and denote it by $\text{GIRG}_{\infty,\alpha_G,\beta_G,d}$.

Corollary 2. (Convergence of GIRGs locally in probability.) *As $n \rightarrow \infty$, the sequence $(\text{GIRG}_{n,\alpha_G,\beta_G,d})_{n \geq 1}$ converges locally in probability to the rooted infinite GIRG $(\text{GIRG}_{\infty,\alpha_G,\beta_G,d}, 0)$, rooted at 0, where $\alpha_G \in (1, \infty]$, $\beta_G > 2$, $d \in \mathbb{N}$.*

2.1.3. *Hyperbolic random graphs.* Hyperbolic random graphs (HRGs) were first proposed by Krioukov *et al.* in 2010 [25], as a model that captures the three main properties of most real-world networks: scale-free, small distances, and non-vanishing clustering coefficient.

HRGs have three parameters, namely the number of vertices n , $\alpha_H > \frac{1}{2}$, and $\nu > 0$, which are fixed constants. Let

$$R_n := 2 \log \frac{n}{\nu}. \tag{15}$$

The vertex set of the graph is the set of n i.i.d. points $u_1^{(n)}, \dots, u_n^{(n)}$ on the hyperbolic plane \mathbb{H} , where $u_i^{(n)} = (r_i^{(n)}, \theta_i^{(n)})$ is the polar representation of $u_i^{(n)}$. The angular component vector $(\theta_i^{(n)})_{i=1}^n$ is a vector with i.i.d. coordinates, each coordinate having the uniform distribution on $[-\pi, \pi]$. The radial component vector $(r_i^{(n)})_{i=1}^n$ is independent of $(\theta_i^{(n)})_{i=1}^n$ and has i.i.d. coordinates, with cumulative distribution function

$$F_{\alpha_H,\nu}^{(n)}(r) = \begin{cases} 0 & \text{if } r < 0, \\ \frac{\cosh \alpha_H r - 1}{\cosh \alpha_H R_n - 1} & \text{if } 0 \leq r \leq R_n, \\ 1 & \text{if } r > R_n. \end{cases} \tag{16}$$

Given $(u_i^{(n)})_{i=1}^n = ((r_i^{(n)}, \theta_i^{(n)}))_{i=1}^n$, one forms the *threshold HRG (THRG)* by placing edges between all pairs of vertices $u_i^{(n)}$ and $u_j^{(n)}$ with conditional probability

$$p_{\text{THRG}}^{(n)}(u_i^{(n)}, u_j^{(n)}) := \mathbb{1}_{\{d_{\mathbb{H}}(u_i^{(n)}, u_j^{(n)}) < R_n\}}, \tag{17}$$

where $d_{\mathbb{H}}$ denotes the distance in the hyperbolic plane \mathbb{H} ; i.e., the edge between $u_i^{(n)}$ and $u_j^{(n)}$ is included if and only if $d_{\mathbb{H}}(u_i^{(n)}, u_j^{(n)}) < R_n$.

Similarly, one forms a parametrized version of the THRG (see [25, Section 6]), which we call the *parametrized HRG (PHRG)*, by placing edges independently between $u_i^{(n)}$ and $u_j^{(n)}$ with conditional probability

$$p_{\text{PHRG}}^{(n)}(u_i^{(n)}, u_j^{(n)}) := \left(1 + \exp \left(\frac{d_{\mathbb{H}}(u_i^{(n)}, u_j^{(n)}) - R_n}{2T_H} \right) \right)^{-1}, \tag{18}$$

where $T_H > 0$ is another parameter.

We denote the THRG model with parameters n, α_H, ν by $\text{THRG}_{n,\alpha_H,\nu}$, and the PHRG model with parameters n, α_H, T_H, ν by $\text{PHRG}_{n,\alpha_H,T_H,\nu}$.

Both the THRG and PHRG models can be seen as finite SIRGs, which gives us the local limits for these models, as a corollary to Theorem 2.

Corollary 3. (Convergence of HRGs locally in probability.) *Let $\alpha_H > \frac{1}{2}$, $0 < T_H < 1$, and $n \in \mathbb{N}$. Let \mathbf{Y} be the sequence of atoms of (10). Then there exists a random variable W having a*

power-law distribution with exponent $2\alpha_H + 1$, such that if $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$ is a sequence of i.i.d. copies of W , the following hold:

- (a) The sequence $(\text{THRG}_{n,\alpha_H,v})_{n \geq 1}$ converges locally in probability to the infinite SIRG $G(\mathbf{Y}, \mathbf{W}, \kappa_{\text{THRG},\infty})$, where

$$\kappa_{\text{THRG},\infty}(t, x, y) := \mathbb{1}_{\{t \leq \frac{vxy}{\pi}\}}.$$

- (b) The sequence $(\text{PHRG}_{n,\alpha_H,T_H,v})_{n \geq 1}$ converges locally in probability to the infinite SIRG $G(\mathbf{Y}, \mathbf{W}, \kappa_{\text{PHRG},\infty})$, where

$$\kappa_{\text{PHRG},\infty}(t, x, y) := \left(1 + \left(\frac{\pi t}{vxy} \right)^{1/T_H} \right)^{-1}.$$

2.1.4. *Continuum scale-free percolation.* The continuum scale-free percolation (CSFP) model [13] was introduced as a continuum analogue of the discrete scale-free percolation (SFP) model [12], a model that captures power-law degree distributions while preserving non-zero clustering and logarithmic typical distances.

We now formally define the model following [13]. The vertex set is the set of points of a homogeneous Poisson point process $(Y_i)_{i \in \mathbb{N}}$, marked with i.i.d. weights $(W_i)_{i \in \mathbb{N}}$ which have a Pareto distribution with power-law tail parameter $\beta > 0$ and scale parameter 1:

$$\mathbb{P}(W > w) = w^{-\beta}, \tag{19}$$

whenever $w > 1$. Conditionally on $(Y_i)_{i \in \mathbb{N}}$ and $(W_i)_{i \in \mathbb{N}}$, each edge $\{Y_i, Y_j\}$ is included independently with probability

$$1 - \exp\left(-\frac{\lambda W_i W_j}{\|Y_i - Y_j\|^\alpha}\right),$$

where $\lambda > 0$ is a parameter. Here we remark that in the original definition in [13], instead of a homogeneous Poisson process $(Y_i)_{i \in \mathbb{N}}$, a Poisson process with some constant intensity $v > 0$ was considered. By standard scaling arguments, this does not make any difference in our results.

Considering the Palm version $(Y_i)_{i \in \mathbb{N} \cup \{0\}}$ of $(Y_i)_{i \in \mathbb{N}}$, where $Y_0 = \mathbf{0} \in \mathbb{R}^d$, marking Y_0 with an independent weight W_0 , and rooting the resulting graph at 0, it is immediate that the resulting rooted infinite CSFP model is the rooted SIRG $(G(\mathbf{Y}, \mathbf{W}, \kappa), 0)$, where $\mathbf{Y} = (Y_i)_{i \in \mathbb{N} \cup \{0\}}$, $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$, and $\kappa(t, x, y) := 1 - \exp\left(-\frac{\lambda xy}{r^\alpha}\right)$.

For each $n \geq 1$, let $\mathbf{X}^{(n)} = (X_i^{(n)})_{i \in [n]}$ satisfy Assumption 1, and consider the ‘blown-up’ finite CSFP model $G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$, where $Y_i^{(n)} = n^{1/d} X_i^{(n)}$ for $i \in [n]$, $\mathbf{W}^{(n)} = (W_i^{(n)})_{i \in [n]}$ is a vector of i.i.d. weight variables having law (19), and $\kappa_n(t, x, y) = 1 - \exp\left(-\frac{\lambda xy}{n^{-\frac{d}{\alpha}} r^\alpha}\right)$. Then as corollary to Theorem 2, we have that the infinite CSFP is the local limit of finite CSFPs under suitable assumptions.

Corollary 4. (Convergence of CSFPs locally in probability.) *Let*

$$\min\{\alpha, \alpha\beta\} > d.$$

Then, as $n \rightarrow \infty$, the graph sequence $G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ converges locally in probability to the infinite rooted CSFP $(G(\mathbf{Y}, \mathbf{W}, \kappa), 0)$.

2.1.5. *Weight-dependent random connection models.* Another very general class of spatial random graph model, called the weight-dependent random connection model (WDRCM), was first introduced in [18], motivated by the study of recurrence and transience properties of general geometric graphs, which we briefly discuss.

To construct the graph, one takes a unit-rate Poisson process on $\mathbb{R}^d \times [0, 1]$, conditionally on which edges between pairs of vertices (\mathbf{x}, s) and (\mathbf{y}, t) are placed independently with probability

$$\rho(h(s, t, \|\mathbf{x} - \mathbf{y}\|)),$$

for some *profile function* $\rho : \mathbb{R}_+ \rightarrow [0, 1]$ and a suitable *kernel* $h : [0, 1] \times [0, 1] \times \mathbb{R}_+ \rightarrow \mathbb{R}_+$. The vertex (\mathbf{x}, s) is thought of as being located at $\mathbf{x} \in \mathbb{R}^d$, and having a weight of s^{-1} associated to it.

Including the point $\mathbf{r} = (\mathbf{0}, U) \in \mathbb{R}^d \times [0, 1]$, where U is uniformly distributed on $[0, 1]$ and independent of the weights and locations of other vertices, and rooting the graph at \mathbf{r} , we obtain the infinite rooted SIRG $(G(\mathbf{Y}, \mathbf{W}, \kappa), 0)$, where $\mathbf{Y} = (Y_i)_{i \in \mathbb{N} \cup \{0\}}$ are the atoms of (10), $\mathbf{W} = (W_i)_{i \in \mathbb{N} \cup \{0\}}$ is a sequence of i.i.d. random weights that are uniform on $[0, 1]$, and $\kappa = \rho \circ h$.

For $n \geq 1$, let $(X_i^{(n)})_{i \in [n]}$ satisfy Assumption 1, let $(W_i^{(n)})_{i \in [n]}$ be a collection of n i.i.d. weights that are uniform on $[0, 1]$, and let $\kappa_n : \mathbb{R} \times \mathbb{R} \times \mathbb{R}_+ \rightarrow [0, 1]$ be defined as $\kappa_n(t, x, y) = \rho(h(x, y, n^{-1/d}t))$, with $\kappa(t, x, y) = \rho(g(x, y, t))$ satisfying Assumption 3(2). Then as a direct consequence of Theorem 2 we have the following corollary, whose proof we omit.

Corollary 5. (Convergence of WDRCMs locally in probability.) *Let $\mathbf{Y}^{(n)} = (Y_i^{(n)})_{i \in [n]} = (n^{1/d}X_i^{(n)})_{i \in [n]}$. Then, as $n \rightarrow \infty$, the sequence of SIRGS $G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ converges locally in probability to the infinite rooted WDRCM $(G(\mathbf{Y}, \mathbf{W}, \kappa), 0)$.*

2.2. Consequences of local convergence: degrees

Theorem 2 is equivalent to the statement that for any subset $A \subset \mathcal{G}_*$,

$$\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{(G_n, i) \in A\}}$$

converges in probability to $\mathbb{P}((G_\infty, 0) \in A)$ (see e.g. [22, (2.3.5)]).

In particular, for fixed $k \in \mathbb{N}$, one can take A_k to be the subset of those rooted graphs (G, o) for which the root o has degree k in G , to conclude that

$$\frac{N_k(G_n)}{n} \xrightarrow{\mathbb{P}} \mathbb{P}(D = k),$$

where $N_k(G_n)$ is the number of vertices with degree k in G_n , and where D is the degree of 0 in G_∞ .

Taking expectation and applying dominated convergence, we have that for any $k \in \mathbb{N}$, $\mathbb{P}(D_n = k) \rightarrow \mathbb{P}(D = k)$ as $n \rightarrow \infty$, where D_n is the degree of U_n in G_n , which implies

$$D_n \xrightarrow{d} D, \tag{20}$$

(where \xrightarrow{d} means convergence in distribution) as $n \rightarrow \infty$. We next give a description of the random variable D . For this, let W_0 be the weight of 0 in \mathbb{G}_∞ , and let $W^{(1)}$ be an independent copy of W_0 .

Proposition 1. (Degree distribution.) *Under the assumptions of Theorem 1, the random variable D is distributed as*

$$\text{Poi} \left(\int_{\mathbb{R}^d} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz \right);$$

i.e. it has a mixed Poisson distribution with mixing parameter

$$\int_{\mathbb{R}^d} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz.$$

Note that Proposition 1, Assumption 3(3), and Fubini’s theorem imply that

$$\mathbb{E} [D] = \int_{\mathbb{R}^d} \mathbb{E} \left[\kappa(\|x\|, W_0, W^{(1)}) \right] dx,$$

which is finite. Since the expectation of the mixing parameter is finite, the mixing parameter is finite almost surely, and hence Proposition 1 makes sense.

In particular, when the mixing parameter $\int_{\mathbb{R}^d} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz$ is regularly varying with some exponent $\zeta > 0$, the random variable D is also regularly varying with the same exponent $\zeta > 0$. This allows for the existence of power-law degree distributions in spatial random graphs.

Recall that D_n is the degree of the uniform vertex U_n in \mathbb{G}_n .

Proposition 2. (Uniform integrability of typical degree sequence.) *Under the assumptions of Theorem 1, the sequence $(D_n)_{n \geq 1}$ is a uniformly integrable sequence of random variables.*

The proof is given in Section 3.8. This result is of independent interest. Uniform integrability of the typical degree sequence in general does not follow from local convergence, even when the limiting degree distribution has finite mean; see for example [22, Exercise 2.14].

Combining Proposition 2 with (20), we note that

$$\mathbb{E} [D_n] \rightarrow \mathbb{E} [D],$$

as $n \rightarrow \infty$. Note that one cannot directly conclude this from Theorem 1, because the function $D : \mathcal{G}_\star \rightarrow \mathbb{R}_+$ defined by

$$D((G, o)) := \text{degree of } o \text{ in } G$$

is continuous, but not necessarily bounded.

2.3. Consequences of local convergence: clustering

In this section, we discuss convergence of various clustering measures of SIRGs.

For any graph $G = (V(G), E(G))$, we let

$$\mathcal{W}_G := \sum_{v_1, v_2, v_3 \in V(G)} \mathbb{1}_{\{\{v_1, v_2\}, \{v_2, v_3\} \in E(G)\}} = \sum_{v \in V(G)} d_v(d_v - 1) \tag{21}$$

(where d_v is the degree of v in G) be twice the number of *wedges* in the graph G , and we let

$$\Delta_G := \sum_{v_1, v_2, v_3 \in V(G)} \mathbb{1}_{\{\{v_1, v_2\}, \{v_2, v_3\}, \{v_3, v_1\} \in E(G)\}} \tag{22}$$

be six times the number of *triangles* in the graph G , where the sums in (21) and (22) are over distinct vertices $v_1, v_2, v_3 \in V(G)$.

Then the *global clustering coefficient* CC_G of the graph G is defined as

$$CC_G := \frac{\Delta_G}{W_G}. \tag{23}$$

We next discuss a local notion of clustering. For $v \in V(G)$, define

$$CC_G(v) := \begin{cases} \frac{\Delta_v(G)}{d_v(d_v-1)} & \text{if } d_v \geq 2, \\ 0 & \text{otherwise,} \end{cases}$$

where

$$\Delta_v(G) = \sum_{v_1, v_2 \in V(G)} \mathbb{1}_{\{\{v_1, v\}, \{v_2, v\}, \{v_1, v_2\} \in E(G)\}}$$

is twice the number of triangles in G containing the vertex v , and d_v , as before, is the degree of v in G . The *local clustering coefficient* \overline{CC}_G of G is then defined as

$$\overline{CC}_G := \frac{1}{n} \sum_{v \in V(G)} CC_G(v). \tag{24}$$

Finally, we discuss a notion of clustering contribution from only vertices of a certain degree. For $k \in \mathbb{N}$, define the *clustering function* to be

$$k \mapsto CC_{G,k},$$

where $CC_{G,k}$ is defined as

$$CC_{G,k} := \begin{cases} \frac{1}{N_k(G)} \sum_{v \in V(G), d_v=k} \frac{\Delta_v(G)}{k(k-1)} & \text{if } N_k(G) > 0, \\ 0 & \text{otherwise,} \end{cases} \tag{25}$$

where $N_k(G)$ is the total number of vertices in G with degree k . Thus, $CC_{G,k}$ measures the proportion of wedges that are triangles, where one of the participant vertices has degree k .

We now present the results on convergence of these various clustering measures for SIRGs.

Corollary 6. (Convergence of clustering coefficients of SIRGs.) *Under the assumptions of Theorem 1, as $n \rightarrow \infty$, the following hold:*

1. If $\alpha > 2d$, then

$$CC_{G_n} \xrightarrow{\mathbb{P}} \frac{\mathbb{E}[\Delta_0]}{\mathbb{E}[D(D-1)]}, \tag{26}$$

where $\Delta_0 := \sum_{i,j \in \mathbb{N}} \mathbb{1}_{\{\{0,i\}, \{0,j\}, \{i,j\} \in E(\mathbb{G}_\infty)\}}$ is twice the number of triangles containing 0 in \mathbb{G}_∞ , and D is the degree of 0 in \mathbb{G}_∞ .

2. We have

$$\overline{CC}_{\mathbb{G}_n} \xrightarrow{\mathbb{P}} \mathbb{E} \left[\frac{\Delta_0}{D(D-1)} \right]. \tag{27}$$

3. For any $k \in \mathbb{N}$,

$$CC_{G,k} \xrightarrow{\mathbb{P}} \frac{1}{\binom{k}{2}} \mathbb{E} [\Delta_0 | D = k]. \tag{28}$$

Parts 2 and 3 of Corollary 6 are direct consequences of local convergence (see [22, Section 2.4.2]). For Corollary 6(1), we need an additional uniform convergence property of the *square* of the degree of a uniform vertex, which we prove is implied by the condition $\alpha > 2d$.

Remark 6. (*Condition on α .*) The condition $\alpha > 2d$ in Corollary 6(1) is not optimal, as will be evident in the proof. Our purpose is not to find the optimal conditions under which the global clustering coefficient converges, but to demonstrate how local convergence of graphs implies convergence of the global clustering coefficient.

Recently, in [15], precise results have been obtained concerning convergence of clustering coefficients and scaling of the clustering function as k grows to infinity for hyperbolic random graphs. Also, it was shown in [11] that under suitable conditions, the CSFP model has non-zero clustering in the limit.

2.4. Consequences of our local convergence proof: distance lower bound

Finally, we provide a result on typical distances in our graphs. Let $U_{n,1}$ and $U_{n,2}$ be two i.i.d. uniformly distributed vertices of \mathbb{G}_n , so that $d_{\mathbb{G}_n}(U_{n,1}, U_{n,2})$ is the graph distance in \mathbb{G}_n between $U_{n,1}$ and $U_{n,2}$. Recall that by convention we let $d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) = \infty$ when $U_{n,1}$ and $U_{n,2}$ are not in the same connected component of \mathbb{G}_n , so that $d_{\mathbb{G}_n}(U_{n,1}, U_{n,2})$ is a well-defined random variable.

Theorem 3. (Lower bound on typical distances.) *Under the assumptions of Theorem 1, for any $C \in \left(0, \frac{1}{\log(\frac{\alpha}{\alpha-d})}\right)$,*

$$\mathbb{P} \left(d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) > C \log \log n \right) \rightarrow 1,$$

as $n \rightarrow \infty$.

In fact, we believe that the limit in the above display holds with C replaced by $\frac{1}{\log(\frac{\alpha}{\alpha-d})}$, but our method of proof does not allow us to establish this improvement. As we will see, the proof is a direct byproduct of the proof of the local weak limit in Theorem 1. Note that as α approaches d , the lower bound in Theorem 3 becomes trivial.

If, instead of a regularly varying domination as in Assumption 3(2), we have that $\mathbb{E}[\kappa(t, W_0, W_1)]$ itself is regularly varying in t with exponent α , then it follows from Proposition 1 that the expectation of the limiting degree distribution D is infinite in the regime $\alpha \in (0, d)$. We conjecture that the distances are of constant order in this regime.

Conjecture 1. (Constant distances for $\alpha \in (0, d)$.) *Let $\mathbb{G}_n = G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ satisfy the assumptions of Theorem 1 except for Assumption 3(2), instead of which we assume that the limiting connection function κ is such that $\mathbb{E}[\kappa(t, W_0, W_1)]$ is regularly varying with*

exponent $\alpha \in (0, d)$. Then if $U_{n,1}$ and $U_{n,2}$ are two uniformly chosen vertices in the SIRG $\mathbb{G}_n = G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$, conditionally on the event that $U_{n,1}$ and $U_{n,2}$ are connected in \mathbb{G}_n ,

$$d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) \xrightarrow{\mathbb{P}} K(\alpha, d),$$

as $n \rightarrow \infty$, where $K(\alpha, d)$ is a constant depending only on the exponent α and dimension d .

For the case $\alpha = d$, we do not expect universal behavior, and the question then becomes model-dependent. Results for constant distances when the limiting degree distribution has infinite mean are known for lattice models such as long-range percolation (see [3, Example 6.1]), for scale-free percolation (see [19, Theorem 2.1]), and for the configuration model [14], which is a model without geometry.

Theorem 3 poses the following question: when are the typical distances exactly doubly logarithmic? Interestingly, distances can be larger than doubly logarithmic, even when the limiting degree distribution has infinite second moment, $\mathbb{E}[D^2] = \infty$, as was shown in [17]; see for example [17, Theorem 1.1(a)]. We conjecture that if certain lower-order moments below a (model-dependent) critical threshold are infinite, this implies ultra-small distances. This is also the behavior that the authors of [17] observe, for a special class of models, but we believe this behavior is universal.

Conjecture 2. (Ultra-small distances.) *Under the assumptions of Theorem 3, there is a constant $\varepsilon_* \in (0, 1)$, depending on the model parameters, such that for any $\varepsilon > \varepsilon_*$, $\mathbb{E}[D^{2-\varepsilon}] = \infty$ implies that there is a constant $C(\alpha, d) > 0$ such that*

$$\mathbb{P}\left(d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) < C(\alpha, d) \log \log n \mid U_{n,1} \text{ and } U_{n,2} \text{ are connected in } \mathbb{G}_n\right) \rightarrow 1,$$

as $n \rightarrow \infty$.

3. Proofs

In this section we give all the proofs. We start, in Section 3.1, by defining the notation that we use throughout this section, and by outlining the general proof strategy for our main results, Theorems 1 and 2. Sections 3.2 and 3.3 contain proofs of some of the key tools that we employ to prove our main results. The proofs of Theorems 1 and 2 can be found in Sections 3.4 and 3.5 respectively. The proof of Theorem 3 can be found in Section 3.6. Proofs of results on examples covered under our set-up are in Section 3.7. Proofs of degree and clustering results can be found respectively in Sections 3.8 and 3.9.

3.1. Notation and general proof strategy for Theorems 1 and 2

Recall the SIRGs $\mathbb{G}_n = G(\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \kappa_n)$ and $\mathbb{G}_\infty = G(\mathbf{Y}, \mathbf{W}, \kappa)$ from Theorem 1. We first define some notation which we will use throughout. Recall that \mathbb{G}_n has vertex set $V(\mathbb{G}_n) = [n]$, and \mathbb{G}_∞ has vertex set $V(\mathbb{G}_\infty) = \mathbb{N} \cup \{0\}$.

For $r > 0$, define the set

$$A_n^r := \left[-\frac{n^{1/d}}{2} + r, \frac{n^{1/d}}{2} - r \right]^d. \tag{29}$$

Thus, A_n^r is a sub-box of the box I_n , such that for any point in A_n^r the open Euclidean ball of radius r around that point is contained in the box I_n . Hence, the number of points of the binomial process Γ_n (recall (9)) falling in this open ball has the same distribution as the number

of points of Γ_n falling in the open ball of radius r around the origin $\mathbf{0} \in \mathbb{R}^d$. We will use this property of A_n^r in a suitable manner, which we formally explain next.

To this end, for any $x \in \mathbb{R}^d$, define the ball

$$\mathcal{B}_x^r := \{y \in \mathbb{R}^d : \|x - y\| < r\}. \tag{30}$$

Then if we let $\partial(I_n) = I_n \setminus \text{int}(I_n)$ denote the boundary of the set I_n , where $\text{int}(I_n)$ is the interior of I_n , i.e. the union of all open subsets of I_n , we note that for any vertex $j \in V(\mathbb{G}_n)$ with location $Y_j^{(n)} \in A_n^r$, the ball $\mathcal{B}_{Y_j^{(n)}}^r$ does not intersect the boundary $\partial(I_n)$ of I_n , i.e. $\mathcal{B}_{Y_j^{(n)}}^r \subset \text{int}(I_n)$. As a result, the distribution of the number of vertices of \mathbb{G}_n (other than j) with locations in $\mathcal{B}_{Y_j^{(n)}}^r$ does not depend on $Y_j^{(n)}$, and it follows a $\text{Bin}\left(n - 1, \frac{\lambda_d(\mathcal{B}_{\mathbf{0}}^r)}{n}\right)$ distribution (where λ_d denotes the Lebesgue measure on \mathbb{R}^d).

In particular, since $\frac{\lambda_d(I_n \setminus A_n^r)}{n} \rightarrow 0$ as $n \rightarrow \infty$, the location $Y_{U_n}^{(n)}$ of the uniformly chosen vertex U_n of \mathbb{G}_n will with high probability fall in A_n^r . We will condition on this good event, under which the number of points of Γ_n in $\mathcal{B}_{Y_{U_n}^{(n)}}^r$ follows a $\text{Bin}\left(n - 1, \frac{\lambda_d(\mathcal{B}_{\mathbf{0}}^r)}{n}\right)$ distribution, and this will simplify our computations.

Definition 6. (*Euclidean graph neighborhoods around a vertex.*) For a vertex $i \in V(\mathbb{G}_n)$, we define $(F_i^{\mathbb{G}_n}(r), i)$ to be the rooted subgraph of \mathbb{G}_n rooted at i , induced by those vertices j whose locations $Y_j^{(n)}$ satisfy $Y_j^{(n)} \in \mathcal{B}_{Y_i^{(n)}}^r$.

Similarly, we define $(F_0^{\mathbb{G}_\infty}(r), 0)$ to be the rooted subgraph of G_∞ rooted at 0 , induced by the vertices $j \in V(\mathbb{G}_\infty)$ whose locations Y_j satisfy $Y_j \in \mathcal{B}_{Y_0}^r = \mathcal{B}_{\mathbf{0}}^r$.

For $i \in [n]$, we will sometimes abbreviate the rooted graph $(F_i^{\mathbb{G}_n}(r), i)$ as simply $F_i^{\mathbb{G}_n}(r)$, and similarly for $F_0^{\mathbb{G}_\infty}(r)$.

For any graph $G = (V(G), E(G))$, edge $e = \{v_1, v_2\} \in E(G)$, and vertex $v \in V(G)$, by the *graph distance* of the edge $e = \{v_1, v_2\}$ from v we mean the number

$$\min\{d_G(v_1, v), d_G(v_2, v)\}, \tag{31}$$

where d_G is the graph distance on G .

Having introduced the main notation, we next discuss the main ingredients and the proof strategy for Theorems 1 and 2.

Local convergence of Euclidean graph neighborhoods. Recall the graphs $F_{U_n}^{\mathbb{G}_n}(r)$ and $F_0^{\mathbb{G}_\infty}(r)$ from Definition 6. In Section 3.2, we will prove that the typical local graph structure in any deterministic Euclidean ball around the root location is asymptotically what it should be, i.e., for any r , $(F_{U_n}^{\mathbb{G}_n}(r), U_n)$ is close in distribution to $(F_0^{\mathbb{G}_\infty}(r), 0)$.

Proposition 3. (*Local convergence of Euclidean graph neighborhoods.*) *For any fixed rooted finite graph $H_* = (H, h) \in \mathcal{G}_*$, and for any $r > 0$,*

$$\mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h)\right) \rightarrow \mathbb{P}\left((F_0^{\mathbb{G}_\infty}(r), 0) \cong (H, h)\right),$$

as $n \rightarrow \infty$, where U_n is uniformly distributed on $V(\mathbb{G}_n) = [n]$.

Path-counting analysis. Next, in Section 3.3, we do a path-counting analysis. We begin by proving a technical lemma that will help us in implementing this path-counting analysis. To state this lemma, we first introduce some more notation to keep things neat. Recall that U_n is uniformly distributed on $[n]$.

For $n, j \in \mathbb{N}$, $v_1, \dots, v_j \in [n]$, and $\vec{x} = (x_0, \dots, x_j) \in (\mathbb{R}^d)^{j+1}$, we define

$$\mathbb{W}_n^{v_1, \dots, v_j}(\vec{x}) := \mathbb{E} \left[\kappa_n \left(\|x_1 - x_0\|, W_{U_n}^{(n)}, W_{v_1}^{(n)} \right) \cdots \kappa_n \left(\|x_j - x_{j-1}\|, W_{v_{j-1}}^{(n)}, W_{v_j}^{(n)} \right) \right], \tag{32}$$

and for $j \in \mathbb{N}$, $u_1, \dots, u_j \in \mathbb{N}$, $x_0, \dots, x_j \in \mathbb{R}^d$, we define

$$\mathbb{W}_j(\vec{x}) := \mathbb{E} \left[\kappa \left(\|x_1 - x_0\|, W_0, W_{u_1} \right) \cdots \kappa \left(\|x_j - x_{j-1}\|, W_{u_{j-1}}, W_{u_j} \right) \right]. \tag{33}$$

Note that the values of the expectations on the right-hand sides of (32) and (33), respectively, do not depend on the values of the v_i 's and u_i 's.

Then our main path-counting tool is the following lemma.

Lemma 2. (Path-counting estimate.) *For any $j \geq 1$, $a > 1$, we have*

$$\begin{aligned} \lim_{m \rightarrow \infty} \limsup_{n \rightarrow \infty} \frac{1}{n} \int_{I_n} \cdots \int_{I_n} \frac{1}{n^j} \sum_{v_1, \dots, v_j \in [n]} \mathbb{W}_n^{v_1, \dots, v_j}(\vec{x}) \\ \times \left(\prod_{i=0}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \right) \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{m^j}\}} dx_0 \cdots dx_j = 0 \end{aligned} \tag{34}$$

and

$$\begin{aligned} \lim_{m \rightarrow \infty} \int_{\mathbb{R}^d} \cdots \int_{\mathbb{R}^d} \mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j) \\ \times \mathbb{1}_{\{\|x_1\| < a^m\}} \left(\prod_{i=1}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \right) \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{m^j}\}} dx_1 \cdots dx_j = 0. \end{aligned} \tag{35}$$

As a corollary to Lemma 2, we will show that for any fixed $K \in \mathbb{N}$ and $a, m > 1$, if we choose

$$r = r(a, m, K) = a^m + a^{m^2} + a^{m^3} + \cdots + a^{m^K}, \tag{36}$$

then as $m \rightarrow \infty$, with high probability, the K -neighborhood of the rooted graph $(F_{U_n}^{\mathbb{G}_n}(r), U_n)$ will be the K -neighborhood $B_{U_n}^{\mathbb{G}_n}(K)$ of (\mathbb{G}_n, U_n) , and a similar result holds for $(\mathbb{G}_\infty, 0)$. This will help us in proving Theorems 1 and 2. To state the result, we again introduce some shorthand notation:

$$\begin{aligned} B_n &:= B_{U_n}^{\mathbb{G}_n}(K), & B &:= B_0^{\mathbb{G}_\infty}(K), & F_{n,r} &:= F_{U_n}^{\mathbb{G}_n}(r), & F_r &:= F_0^{\mathbb{G}_\infty}(r), \\ BF_{n,r} &:= B_{U_n}^{F_{n,r}}(K), & BF_r &:= B_0^{F_r}(K). \end{aligned} \tag{37}$$

Remark 7. (Spatial and graph neighborhoods.) At this point, we emphasize that we rely on two kinds of neighborhoods around the root U_n (respectively 0) of \mathbb{G}_n (respectively \mathbb{G}_∞). These are the graph $F_{n,r}$ (respectively F_r), which is the subgraph induced by those vertices

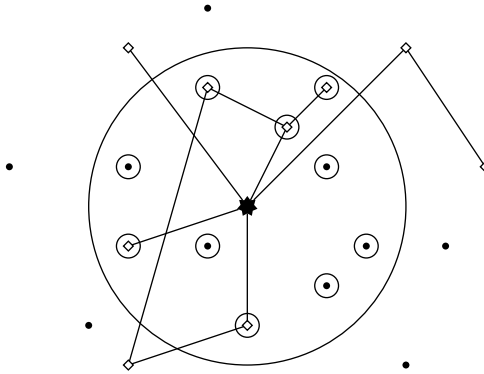


FIGURE 1. Illustration to distinguish between the two kinds of neighborhoods. The star in the middle is the location $Y_{U_n}^{(n)}$ of the root U_n , and the big circle around it is the boundary of the Euclidean ball centered at $Y_{U_n}^{(n)}$ of radius r , in \mathbb{R}^d . Diamonds are the vertices of the graph neighborhood $B_{U_n}^{G_n}(2)$ of radius 2 around the root. Black dots are the vertices which are not in $B_{U_n}^{G_n}(2)$. The circled vertices are the vertices of $F_{U_n}^{G_n}(r)$. The circled diamonds are the vertices of $BF_{n,r}$, the graph neighborhood of radius 2 about the root U_n , of the graph $F_{U_n}^{G_n}(r)$.

whose *spatial locations* are within Euclidean distance r of the root location $Y_{U_n}^{(n)}$ (respectively Y_0), and the graph B_n (respectively B), which is the *graph neighborhood* of radius K around the root U_n (respectively 0) (see Figure 1). The difference between these two kinds of *neighborhoods* should be understood clearly. For example, the graph $F_{n,r}$ may possibly be disconnected, while B_n is always a connected graph. Moreover, $BF_{n,r}$ (respectively BF_r) is the graph neighborhood of radius K , of the rooted graph $(F_{n,r}, U_n)$ (respectively $(F_r, 0)$).

We have the following corollary to Lemma 2.

Corollary 7. (Coupling spatial and graph neighborhoods.) *Let $BF_{n,r}, B_n, BF_r, B$ be as in (37), where $r = r(a, m, K)$ is as in (36). Then*

$$\lim_{m \rightarrow \infty} \limsup_{n \rightarrow \infty} \mathbb{P}(BF_{n,r} \neq B_n) = 0 \tag{38}$$

and

$$\lim_{m \rightarrow \infty} \mathbb{P}(BF_r \neq B) = 0. \tag{39}$$

In proving Corollary 7, we perform a careful path-counting analysis to bound the expected number of K -paths of \mathbb{G}_n which are not K -paths in $F_{U_n}^{G_n}(r)$ by the integral expression (34), and to obtain the similar bound (35) for \mathbb{G}_∞ . Corollary 7 then follows directly using the technical Lemma 2.

In the course of proving Corollary 7, we develop a general path estimate, where for $r = r(a, m, K)$ as in (36), we can have $a = a_n, K = K_n$ be n dependent sequences, while m does not depend on n . This general estimate will be used in the proof of Theorem 3.

Proof strategy for Theorem 1. In Section 3.4, we prove Theorem 1. Recall that, to conclude Theorem 1, we need to show that for any $K \in \mathbb{N}$, the K -neighborhoods of (\mathbb{G}_n, U_n) and $(\mathbb{G}_\infty, 0)$

are close in distribution in \mathcal{G}_* . Consequently, to conclude Theorem 1, using Corollary 7, it will be enough to show that the K -neighborhoods of $(F_{U_n}^{\mathbb{G}_n}(r), U_n)$ and $(F_0^{\mathbb{G}_\infty}(r), 0)$ are close in distribution. This we will observe to be an easy consequence of Proposition 3.

Proof strategy for Theorem 2. In Section 3.5, we prove Theorem 2. The first step is to show that the empirical Euclidean graph neighborhood distribution concentrates. That is, for $H_* = (H, h) \in \mathcal{G}_*$, where $h \in V(H)$, and for any $r > 0$, we define the random variables

$$C_{r,n}(H, h) := \mathbb{P} \left(F_{U_n}^{\mathbb{G}_n}(r) \cong (H, h) \mid \mathbb{G}_n \right) = \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{F_i^{\mathbb{G}_n}(r) \cong (H, h)\}}, \tag{40}$$

and show these random variables concentrate, as follows.

Lemma 3. (Concentration of empirical Euclidean graph neighborhood measure.) *For any $r > 0$ and a locally finite rooted graph $H_* = (H, h) \in \mathcal{G}_*$, the variance of the random variable $C_{r,n}(H, h)$ converges to 0 as $n \rightarrow \infty$, i.e.*

$$\left| \mathbb{E} \left[C_{r,n}(H, h)^2 \right] - \mathbb{E} \left[C_{r,n}(H, h) \right]^2 \right| \rightarrow 0,$$

as $n \rightarrow \infty$.

The key observation in proving this lemma is that the Euclidean graph neighborhoods around two uniformly chosen vertices of \mathbb{G}_n are asymptotically independent, which is a consequence of the fact that the distance between the locations of two uniformly chosen vertices of \mathbb{G}_n in \mathbb{R}^d diverges in probability, as $n \rightarrow \infty$.

Next, we combine Lemma 3 with Corollary 7 to show that the empirical neighborhood distribution of \mathbb{G}_n also concentrates. That is, for any $K \in \mathbb{N}$ and $G_* = (G, g) \in \mathcal{G}_*$, if we define random variables

$$B_n(G, g) := \mathbb{P} \left(B_{U_n}^{\mathbb{G}_n}(K) \cong (G, g) \mid \mathbb{G}_n \right) = \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \cong (G, g)\}}, \tag{41}$$

for $n \in \mathbb{N}$, then these random variables also concentrate. This is achieved by first using Lemma 3 and taking a sum over all rooted graphs $H_* = (H, h)$ with $B_n^H(K) \cong (G, g)$, to show that the random variables

$$\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\left\{ B_i^{F_i^{\mathbb{G}_n}(r)}(K) \cong (G, g) \right\}}$$

concentrate, and then employing Corollary 7 to obtain the same conclusion for the variables $B_n(G, g)$. Theorem 2 is then a direct consequence of these observations, combined with Proposition 3.

3.2. Proof of Proposition 3

Let us first discuss the proof strategy informally. We make use of the following two key observations:

- The number of vertices in $F_{U_n}^{\mathbb{G}_n}(r)$ converges in distribution to the number of vertices in $F_0^{\mathbb{G}_\infty}(r)$.

- Conditionally on the number of vertices of $F_{U_n}^{\mathbb{G}_n}(r)$ (respectively $F_0^{\mathbb{G}_\infty}(r)$) other than the root, their locations are uniform on $\mathcal{B}_{Y_{U_n}^r}$ (respectively \mathcal{B}_0^r). It will then follow that any ‘not so bad’ translation-invariant function, evaluated at the locations of the vertices of $F_{U_n}^{\mathbb{G}_n}(r)$, should have nice limiting behavior.

In particular, we define functions $\mathcal{F}_{(H,h)}^n$ and $\mathcal{F}_{(H,h)}^\infty$ (see (52)), which for a given rooted graph $(H, h) \in \mathcal{G}_\star$ count the number of rooted isomorphisms between (H, h) and $F_{U_n}^{\mathbb{G}_n}(r)$, and between (H, h) and $F_0^{\mathbb{G}_\infty}(r)$. We show that for any such rooted graph $(H, h) \in \mathcal{G}_\star$, the probability of the event $\{\mathcal{F}_{(H,h)}^n > 0\}$ converges to that of the event $\{\mathcal{F}_{(H,h)}^\infty > 0\}$. In turn, this implies that the random rooted graph $F_{U_n}^{\mathbb{G}_n}(r)$ converges in distribution to the random rooted graph $F_0^{\mathbb{G}_\infty}(r)$, on the space \mathcal{G}_\star . We now go into the details.

Proof of Proposition 3. The random variable $Y_{U_n}^{(n)}$ is uniformly distributed on I_n . We write

$$\begin{aligned} & \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h)\right) \\ &= \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \in A_n^r\right) + \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \notin A_n^r\right) \end{aligned}$$

and observe that, as $n \rightarrow \infty$,

$$\mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \notin A_n^r\right) \leq \mathbb{P}\left(Y_{U_n}^{(n)} \notin A_n^r\right) \leq \frac{2d(r(n^{(d-1)/d}))}{n} \rightarrow 0. \tag{42}$$

Therefore, it is enough to show that, as $n \rightarrow \infty$,

$$\mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \in A_n^r\right) \rightarrow \mathbb{P}\left((F_0^{\mathbb{G}_\infty}(r), 0) \cong (H, h)\right). \tag{43}$$

Note that

$$\begin{aligned} & \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \in A_n^r\right) \\ &= \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)|\right), \end{aligned}$$

and so we can repeatedly condition to rewrite

$$\begin{aligned} & \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h), Y_{U_n}^{(n)} \in A_n^r\right) \\ &= \mathbb{P}\left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h) \mid |V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)|, Y_{U_n}^{(n)} \in A_n^r\right) \\ & \quad \times \mathbb{P}\left(|V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)| \mid Y_{U_n}^{(n)} \in A_n^r\right) \mathbb{P}\left(Y_{U_n}^{(n)} \in A_n^r\right). \end{aligned} \tag{44}$$

Using (42), the last term in the right-hand side of (44) tends to 1 as $n \rightarrow \infty$. Observe that

$$\mathbb{P}\left(|V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)| \mid Y_{U_n}^{(n)} \in A_n^r\right) = \mathbb{P}\left(\mathcal{Y}_n = |V(H)| - 1\right),$$

where \mathcal{Y}_n follows a $\text{Bin}(n - 1, \lambda_d(\mathcal{B}_0^r)/n)$ distribution.

Since \mathcal{Y}_n converges in distribution to $\mathcal{Y} \sim \text{Poi}(\lambda_d(\mathcal{B}_0^r))$, and since \mathcal{Y} is equal in distribution to $\Gamma(\mathcal{B}_0^r)$ (recall Γ from (10)), it follows that $\mathcal{Y}_n \xrightarrow{d} \Gamma(\mathcal{B}_0^r)$, as $n \rightarrow \infty$.

Observe that $\Gamma(\mathcal{B}_0^r) \stackrel{d}{=} |V(F_0^{\mathbb{G}_\infty}(r))| - 1$, so that

$$\begin{aligned} \lim_{n \rightarrow \infty} \mathbb{P} \left(|V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)| \mid Y_{U_n}^{(n)} \in A_n^r \right) &= \lim_{n \rightarrow \infty} \mathbb{P} (\mathcal{N}_n = |V(H)| - 1) \\ &= \mathbb{P} \left(|V(F_0^{\mathbb{G}_\infty}(r))| - 1 = |V(H)| - 1 \right) \\ &= \mathbb{P} \left(|V(F_0^{\mathbb{G}_\infty}(r))| = |V(H)| \right). \end{aligned}$$

Hence, from (44), we note that to conclude (43), it is enough to show that

$$\begin{aligned} \lim_{n \rightarrow \infty} \mathbb{P} \left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \cong (H, h) \mid |V(F_{U_n}^{\mathbb{G}_n}(r))| = |V(H)|, Y_{U_n}^{(n)} \in A_n^r \right) \\ = \mathbb{P} \left((F_0^{\mathbb{G}_\infty}(r), 0) \cong (H, h) \mid |V(F_0^{\mathbb{G}_\infty}(r))| = |V(H)| \right). \end{aligned} \tag{45}$$

For the remainder of the proof, we assume $|V(H)| = l + 1$. We continue by making some observations on the locations and weights of the vertices of the graph $F_{U_n}^{\mathbb{G}_n}(r)$ (respectively $F_0^{\mathbb{G}_\infty}(r)$), conditionally on $\{|V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1, Y_{U_n}^{(n)} \in A_n^r\}$ (respectively $\{|V(F_0^{\mathbb{G}_\infty}(r))| = l + 1\}$).

Locations of $F_{U_n}^{\mathbb{G}_n}(r)$. Since $(Y_i^{(n)})_{i \in [n]}$ is an i.i.d. collection of uniform random variables on I_n , conditionally on the event $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$, the locations P_1, \dots, P_l of the l vertices of \mathbb{G}_n (in some order) falling in $\mathcal{B}_{Y_{U_n}^{(n)}}^r$, other than $Y_{U_n}^{(n)}$, are at independent uniform locations in the ball $\mathcal{B}_{Y_{U_n}^{(n)}}^r$, given $Y_{U_n}^{(n)}$. Hence, conditionally on $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$, the random variables $P_1 - Y_{U_n}^{(n)}, \dots, P_l - Y_{U_n}^{(n)}$ are independently, uniformly distributed on the ball \mathcal{B}_0^r .

Conditionally on $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$, let the locations of all the vertices of \mathbb{G}_n falling in $\mathcal{B}_{Y_{U_n}^{(n)}}^r$ (including $Y_{U_n}^{(n)}$) be P_0, P_1, \dots, P_l , where $Y_{U_n}^{(n)} = P_0$. So, conditionally on $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$, the random matrix $(\|P_i - P_j\|)_{0 \leq i, j \leq l; i \neq j}$ is equal in distribution to $(\|Y_i - Y_j\|)_{0 \leq i, j \leq l; i \neq j}$, where the set $\{Y_i : 1 \leq i \leq l\}$ consists of l i.i.d. uniform points in \mathcal{B}_0^r (independent of $\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \mathbf{Y}, \mathbf{W}$) and $Y_0 = \mathbf{0}$.

Locations of $F_0^{\mathbb{G}_\infty}(r)$. Again, conditionally on the event $\{\Gamma_\infty(\mathcal{B}_0^r) = l + 1\} = \{|V(F_0^{\mathbb{G}_\infty}(r))| = l + 1\}$, the locations of the l vertices of \mathbb{G}_∞ in \mathcal{B}_0^r other than 0 are i.i.d. uniform on \mathcal{B}_0^r (since Γ is a homogeneous Poisson point process). So if Z_0, \dots, Z_l are the locations of the $l + 1$ vertices of \mathbb{G}_∞ in \mathcal{B}_0^r (in some order), where $Z_0 = \mathbf{0}$, the random matrix $(\|Z_i - Z_j\|)_{0 \leq i, j \leq l; i \neq j}$ is also equal in distribution to $(\|Y_i - Y_j\|)_{0 \leq i, j \leq l; i \neq j}$, where the set $\{Y_i : 1 \leq i \leq l\}$ consists of l i.i.d. uniform points in \mathcal{B}_0^r (independent of $\mathbf{Y}^{(n)}, \mathbf{W}^{(n)}, \mathbf{Y}, \mathbf{W}$) and $Y_0 = \mathbf{0}$.

We conclude that

$$\begin{aligned} & (\|P_i - P_j\|)_{0 \leq i, j \leq l; i \neq j} \mid \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\} \\ & \stackrel{d}{=} (\|Y_i - Y_j\|)_{1 \leq i, j \leq l+1; i \neq j} \\ & \stackrel{d}{=} (\|Z_i - Z_j\|)_{0 \leq i, j \leq l; i \neq j} \mid \{\Gamma_\infty(\mathcal{B}_0^r) = l + 1\}. \end{aligned} \tag{46}$$

Weights of $F_{U_n}^{\mathbb{G}_n}(r)$. Next, conditionally on $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$, for $0 \leq i \leq l$, let $W_{n,i}$ denote the weight of the vertex of $F_{U_n}^{\mathbb{G}_n}(r)$ with location P_i . Then $(W_{n,0}, \dots, W_{n,l})$ has the distribution of $l + 1$ uniformly chosen weights from the weight set $\{W_1^{(n)}, \dots, W_n^{(n)}\}$ without replacement, in some arbitrary order. This is because for any $i_0, \dots, i_l \in [n]$,

$$\begin{aligned} & \mathbb{P} \left((W_{n,0}, \dots, W_{n,l}) = (W_{i_0}^{(n)}, \dots, W_{i_l}^{(n)}) \mid Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1 \right) \\ &= \frac{\mathbb{P} \left((W_{n,0}, \dots, W_{n,l}) = (W_{i_0}^{(n)}, \dots, W_{i_l}^{(n)}) \mid Y_{U_n}^{(n)} \in A_n^r \right)}{\mathbb{P} \left(|V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1 \mid Y_{U_n}^{(n)} \in A_n^r \right)}, \end{aligned} \tag{47}$$

where in the second step we use the fact that the event that the vector of weights of the vertices of $F_{U_n}^{\mathbb{G}_n}(r)$ is of length $l + 1$ is contained in the event that $\{|V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\}$. The numerator in (47) is

$$\frac{1}{n} \times \mathbb{P} \left(Y_{i_p}^{(n)} \in \mathcal{B}_{Y_{i_0}^{(n)}}^r \forall p \in [l], Y_{i_q}^{(n)} \notin \mathcal{B}_{Y_{i_0}^{(n)}}^r \forall i_q \in [n] \setminus \{i_0, i_1, \dots, i_l\} \mid Y_{i_0}^{(n)} \in A_n^r \right) \times \frac{1}{l!},$$

where the term $1/n$ is just the probability that $U_n = i_0$, and the term $\frac{1}{l!}$ accounts for the choice of the ordering $P_k = Y_{i_k}^{(n)}$ for $1 \leq k \leq l$ among all $l!$ possible labelings. This evaluates to

$$\frac{1}{n} \times \left(\frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^l \times \left(1 - \frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^{n-1-l} \times \frac{1}{l!}.$$

The denominator in (47) is just the probability that a $\text{Bin} \left(n - 1, \frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)$ random variable takes the value l , which evaluates to

$$\binom{n-1}{l} \times \left(\frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^l \times \left(1 - \frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^{n-1-l}.$$

Combining, we get that

$$\begin{aligned} & \mathbb{P} \left((W_{n,0}, \dots, W_{n,l}) = (W_{i_0}^{(n)}, \dots, W_{i_l}^{(n)}) \mid Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1 \right) \\ &= \frac{1}{n(n-1) \dots (n-l)}. \end{aligned} \tag{48}$$

We also make the observation that the random vector $(W_{n,0}, \dots, W_{n,l})$ is permutation-invariant: for any $\sigma \in S(l + 1)$, where $S(l + 1)$ denotes the set of all permutations of $\{0, \dots, l\}$,

$$(W_{n,0}, \dots, W_{n,l}) \stackrel{d}{=} (W_{n,\sigma(0)}, \dots, W_{n,\sigma(l)}). \tag{49}$$

Weights of $F_0^{\mathbb{G}_\infty}(r)$. Again, conditionally on $\{\Gamma_\infty(\mathcal{B}_0^r) = l + 1\}$, for $0 \leq i \leq l$, let $W_{\infty,i}$ denote the weight of the vertex of $F_0^{\mathbb{G}_\infty}(r)$ with location Z_i . Since the weights in the limiting graph \mathbb{G}_∞ are i.i.d., it immediately follows that the random weight vector $(W_{\infty,0}, \dots, W_{\infty,l})$ is permutation-invariant, i.e. for any $\sigma \in S(l + 1)$,

$$(W_{\infty,0}, \dots, W_{\infty,l}) \stackrel{d}{=} (W_{\infty,\sigma(0)}, \dots, W_{\infty,\sigma(l)}), \tag{50}$$

and that given $\{\Gamma_\infty(\mathcal{B}_0^r) = l + 1\}$, the vector $(W_{\infty,0}, \dots, W_{\infty,l}) \stackrel{d}{=} (W_0, \dots, W_l)$, where each entry of the vector (W_0, \dots, W_l) is an i.i.d. copy of the limiting weight variable W (recall (4)).

We now continue with the proof.

Convergence of weights of $F_{U_n}^{\mathbb{G}_n}(r)$ to the weights of $F_0^{\mathbb{G}_\infty}(r)$. We also note that

$$\begin{aligned} & (W_{n,0}, \dots, W_{n,l}) \Big| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1\} \\ & \xrightarrow{d} (W_{\infty,0}, \dots, W_{\infty,l}) \Big| \{\Gamma_\infty(\mathcal{B}_0^r) = l + 1\}. \end{aligned} \tag{51}$$

This is because for any continuity set $A_0 \times \dots \times A_l$ of (W_0, \dots, W_l) , by (48),

$$\begin{aligned} & \mathbb{P} \left((W_{n,0}, \dots, W_{n,l}) \in A_0 \times \dots \times A_l \Big| Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1 \right) \\ & \geq \mathbb{E} \left[\sum_{j_0, \dots, j_l} \frac{1}{n^l} \prod_{k=0}^l \mathbb{1}_{\{W_{j_k}^{(n)} \in A_k\}} \right] = \mathbb{E} \left[\prod_{k=0}^l \left(\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{W_i^{(n)} \in A_k\}} \right) \right] \end{aligned}$$

and

$$\begin{aligned} & \mathbb{P} \left((W_{n,0}, \dots, W_{n,l}) \in A_0 \times \dots \times A_l \Big| Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l + 1 \right) \\ & \leq \mathbb{E} \left[\sum_{j_0, \dots, j_l} \frac{1}{(n-l)^l} \prod_{k=0}^l \mathbb{1}_{\{W_{j_k}^{(n)} \in A_k\}} \right] = \mathbb{E} \left[\prod_{k=0}^l \left(\frac{1}{n-l} \sum_{i=1}^n \mathbb{1}_{\{W_i^{(n)} \in A_k\}} \right) \right], \end{aligned}$$

where the sums in the last two displays are taken over all cardinality- $(l + 1)$ subsets $\{j_0, \dots, j_l\}$ of $[n]$. Since the right-hand sides of the last two displays are bounded from above by 1, we use dominated convergence and apply (4) to conclude that both right-hand sides converge to

$$\begin{aligned} & \prod_{k=0}^l \mathbb{P}(W \in A_k) = \mathbb{P}((W_0, \dots, W_l) \in A_0 \times \dots \times A_l) \\ & = \mathbb{P} \left((W_{\infty,0}, \dots, W_{\infty,l}) \in A_0 \times \dots \times A_l \Big| \Gamma_\infty(\mathcal{B}_0^r) = l + 1 \right). \end{aligned}$$

Functions counting rooted isomorphisms, and their symmetry properties. Now we proceed to define the functions we use to count the number of isomorphisms between the given rooted graph (H, h) and the Euclidean graph neighborhoods $F_{U_n}^{\mathbb{G}_n}(r), F_0^{\mathbb{G}_\infty}(r)$. Let the vertices of (H, h) be v_0, \dots, v_l , where $h = v_0$. Let us denote the subset of the set of permutations $S(l + 1)$ of $\{0, 1, \dots, l\}$ that fix 0 by $S_0(l + 1)$; i.e., for all $\sigma \in S_0(l + 1)$, $\sigma(0) = 0$.

Let $M_{l+1}^S(\mathbb{R})$ denote the space of all symmetric square matrices of order $l + 1$ with entries in \mathbb{R} . For each $n \in \mathbb{N}$, define the function $\mathcal{F}_{(H,h)}^n : (\mathbb{R}^d)^{l+1} \times (\mathbb{R}^d)^{l+1} \times M_{l+1}^S(\mathbb{R}) \rightarrow \mathbb{R}$ by

$$\begin{aligned} & \mathcal{F}_{(H,h)}^n \left(\vec{x}, \vec{y}, (a_{ij})_{i,j=0}^l \right) \\ & := \sum_{\pi \in S_0(l+1)} \prod_{\{v_i, v_j\} \in E(H)} \left(\mathbb{1}_{\{a_{\pi(i)\pi(j)} < \kappa_n(\|x_{\pi(i)} - x_{\pi(j)}\|, y_{\pi(i)}, y_{\pi(j)})\}} \right) \\ & \quad \times \prod_{\{v_i, v_j\} \notin E(H)} \left(\mathbb{1}_{\{a_{\pi(i)\pi(j)} > \kappa_n(\|x_{\pi(i)} - x_{\pi(j)}\|, y_{\pi(i)}, y_{\pi(j)})\}} \right), \end{aligned} \tag{52}$$

for $\vec{x} = (x_0, \dots, x_l), \vec{y} = (y_0, \dots, y_l) \in (\mathbb{R}^d)^{l+1}$ and $(a_{ij})_{i,j=0}^l \in M_{l+1}^S(\mathbb{R})$. Similarly define the function $\mathcal{F}_{(H,h)}^\infty : (\mathbb{R}^d)^{l+1} \times (\mathbb{R}^d)^{l+1} \times M_{l+1}^S(\mathbb{R}) \rightarrow \mathbb{R}$, where $\mathcal{F}_{(H,h)}^\infty$ is just $\mathcal{F}_{(H,h)}^n$ with κ_n replaced by κ .

Heuristically, we want the indicators

$$\mathbb{1}_{\{a_{\pi(i)\pi(j)} < \kappa_n(\|x_{\pi(i)} - x_{\pi(j)}\|, y_{\pi(i)}, y_{\pi(j)})\}}$$

to be the indicators of the events {the edge $\{\pi(i), \pi(j)\}$ is present}. Since in our graphs these events occur independently, each with probability $\kappa_n(\|x_{\pi(i)} - x_{\pi(j)}\|, y_{\pi(i)}, y_{\pi(j)})$ when the locations and weights of the vertices $\pi(i)$ and $\pi(j)$ are respectively $(x_{\pi(i)}, y_{\pi(i)})$ and $(x_{\pi(j)}, y_{\pi(j)})$, we will take the matrix $(a_{ij})_{i,j=0}^l$ to be a symmetric i.i.d. uniform matrix. Before that, we first discuss some symmetry properties of the functions $\mathcal{F}_{(H,h)}^n$ and $\mathcal{F}_{(H,h)}^\infty$.

Observe the following symmetry: for any permutation $\pi \in S_0(l+1)$, and for \bullet being either n or ∞ ,

$$\begin{aligned} \mathcal{F}_{(H,h)}^\bullet &\left((x_0, \dots, x_l), (y_0, \dots, y_l), (a_{ij})_{i,j=0}^l \right) \\ &= \mathcal{F}_{(H,h)}^\bullet \left((x_{\pi(0)}, \dots, x_{\pi(l)}), (y_{\pi(0)}, \dots, y_{\pi(l)}), (a_{\pi(i)\pi(j)})_{i,j=0}^l \right). \end{aligned}$$

Recall the permutation-invariance of the weights of $F_{U_n}^{\mathbb{G}_n}(r)$ and $F_0^{\mathbb{G}_\infty}(r)$ from (49) and (50), and note that for $(x_0, \dots, x_l), (z_0, \dots, z_l) \in (\mathbb{R}^d)^{l+1}$, if there exists a permutation $\pi \in S_0(l+1)$ such that

$$(\|x_i - x_j\|)_{i,j=0}^l = (\|z_{\pi(i)} - z_{\pi(j)}\|)_{i,j=0}^l \text{ (entrywise),}$$

then for any $(a_{ij})_{i,j=0}^l \in M_{l+1}^S(\mathbb{R})$, conditionally on $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l+1\}$,

$$\begin{aligned} \mathcal{F}_{(H,h)}^n &\left((x_0, \dots, x_l), (W_{n,0}, \dots, W_{n,l}), (a_{ij})_{i,j=0}^l \right) \\ &\stackrel{d}{=} \mathcal{F}_{(H,h)}^n \left((z_0, \dots, z_l), (W_{n,0}, \dots, W_{n,l}), (a_{ij})_{i,j=0}^l \right), \end{aligned} \tag{53}$$

and a similar distributional equality holds for $\mathcal{F}_{(H,h)}^\infty$, conditionally on $\{\Gamma_\infty(\mathcal{B}_0^r) = l+1\}$.

Simplifying the events $\{F_{U_n}^{\mathbb{G}_n}(r) \cong (H, h)\}$ and $\{F_0^{\mathbb{G}_\infty}(r) \cong (H, h)\}$. Now, let $(U_{ij})_{i,j=0}^l$ and $(U'_{ij})_{i,j=0}^l$ be two i.i.d. random elements of $M_{l+1}^S(\mathbb{R})$ which are also independent from $\mathbf{X}^{(n)}, \mathbf{W}^{(n)}, \mathbf{X}, \mathbf{W}$, and $\{Y_i : 0 \leq i \leq l\}$, where for each $i < j$, $U_{ij} \sim U([0, 1])$, all the entries above the diagonal of the random matrix $(U_{ij})_{i,j=1}^{l+1}$ are independent, and for each i , $U_{ii} := 0$ (the diagonal elements will not come into the picture and can be defined arbitrarily). Let

$$\mathcal{A}_n := \mathbb{1}_{\{F_{U_n}^{\mathbb{G}_n}(r) \cong (H,h)\}} \Big| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l+1\} \tag{54}$$

and

$$\mathcal{A}_\infty := \mathbb{1}_{\{F_0^{\mathbb{G}_\infty}(r) \cong (H,h)\}} \Big| \{|V(F_0^{\mathbb{G}_\infty}(r))| = l+1\}. \tag{55}$$

Note from (45) that our target is to show that $\mathbb{E}[\mathcal{A}_n] \rightarrow \mathbb{E}[\mathcal{A}_\infty]$, as $n \rightarrow \infty$.

Recall (46). Observe that

$$\mathcal{A}_n \stackrel{d}{=} \mathbb{1}_{\{\mathcal{F}_{(H,h)}^n((P_0, \dots, P_l), (W_{n,0}, \dots, W_{n,l}), (U_{ij})_{i,j=0}^l) > 0\}} \Big| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{\mathbb{G}_n}(r))| = l+1\}, \tag{56}$$

since, conditionally on the event $\{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{G_n}(r))| = l + 1\}$, if for some $\pi \in S_0(l + 1)$ the corresponding term in the sum in $\mathcal{F}_{(H,h)}^n$ is positive, then $v_i \mapsto P_{\pi(i)}$ gives a rooted isomorphism (note that the fact that every permutation in $S_0(l + 1)$ fixes 0 ensures that the isomorphism is rooted), and if there is a rooted isomorphism $\phi: G \rightarrow F_{U_n}^{G_n}(r)$, then the term in the sum corresponding to the permutation $\sigma \in S_0(l + 1)$ is positive, where $\phi(v_i) = P_{\sigma(i)}$.

Using the symmetry (53) with (46), we obtain

$$\begin{aligned} \mathcal{A}_n &\stackrel{d}{=} \mathbb{1}_{\left\{ \mathcal{F}_{(H,h)}^n((Y_0, \dots, Y_l), (W_{n,0}, \dots, W_{n,l}), (U_{ij})_{i,j=0}^l) > 0 \right\}} \left| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{G_n}(r))| = l + 1\} \right. \\ &=: \mathcal{A}_n. \end{aligned} \tag{57}$$

Using exactly similar arguments for the random variable \mathcal{A}_∞ and the function $\mathcal{F}_{(H,h)}^\infty$, we obtain

$$\mathcal{A}_\infty \stackrel{d}{=} \mathbb{1}_{\left\{ \mathcal{F}_{(H,h)}^\infty((Y_0, \dots, Y_l), (W_{\infty,0}, \dots, W_{\infty,l}), (U'_{ij})_{i,j=0}^l) > 0 \right\}} \left| \{|V(F_0^{G_\infty}(r))| = l + 1\} \right. \tag{58}$$

Finally, using that $(U'_{ij})_{i,j=0}^l \stackrel{d}{=} (U_{ij})_{i,j=0}^l$ and that both the matrices U_{ij} and U'_{ij} are independent of everything else, it is easy to see that

$$\mathcal{A}_\infty \stackrel{d}{=} \mathbb{1}_{\left\{ \mathcal{F}_{(H,h)}^\infty((Y_0, \dots, Y_l), (W_{\infty,0}, \dots, W_{\infty,l}), (U_{ij})_{i,j=0}^l) > 0 \right\}} \left| \{|V(F_0^{G_\infty}(r))| = l + 1\} \right. =: \mathcal{A}_\infty. \tag{59}$$

Conclusion. Using (51), and using the convergence of connection functions (5), for any $(x_0, \dots, x_l) \in (\mathbb{R}^d)^{l+1}$ such that the collection of positive reals $\{\|x_i - x_j\| : 1 \leq i, j, \leq l, i \neq j\}$ avoids some set of measure zero, and for any $(a_{ij})_{i,j=0}^l \in M_{l+1}^S([0, 1])$, as $n \rightarrow \infty$,

$$\begin{aligned} &\mathcal{F}_{(H,h)}^n \left((x_0, \dots, x_l), (W_{n,0}, \dots, W_{n,l}), (a_{ij})_{i,j=0}^l \right) \left| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{G_n}(r))| = l + 1\} \right. \\ &\xrightarrow{d} \mathcal{F}_{(H,h)}^\infty \left((x_0, \dots, x_l), (W_{\infty,0}, \dots, W_{\infty,l}), (a_{ij})_{i,j=0}^l \right) \left| \{|V(F_0^{G_\infty}(r))| = l + 1\} \right., \end{aligned} \tag{60}$$

which implies that, as $n \rightarrow \infty$, writing $\vec{x} = (x_0, x_1, \dots, x_n)$,

$$\begin{aligned} &\mathbb{P} \left(\mathcal{F}_{(H,h)}^n(\vec{x}, (W_{n,0}, \dots, W_{n,l}), (a_{ij})_{i,j=0}^l) > 0 \left| \{Y_{U_n}^{(n)} \in A_n^r, |V(F_{U_n}^{G_n}(r))| = l + 1\} \right. \right) \\ &\rightarrow \mathbb{P} \left(\mathcal{F}_{(H,h)}^\infty(\vec{x}, (W_{\infty,0}, \dots, W_{\infty,l}), (a_{ij})_{i,j=0}^l) > 0 \left| \{|V(F_0^{G_\infty}(r))| = l + 1\} \right. \right). \end{aligned} \tag{61}$$

Combining (61) with the fact that both (Y_0, \dots, Y_l) and $(U_{ij})_{i,j=0}^l$ are independent of $\mathbf{W}^{(n)}$ and \mathbf{W} , and the fact that the random variables $\|Y_i - Y_j\|$ for $1 \leq i, j \leq l$ with $i \neq j$ are continuous random variables and hence almost surely avoid sets of measure 0, we have (recalling \mathcal{A}_n and \mathcal{A}_∞ from (57) and (59))

$$\mathbb{E} \left[\mathcal{A}_n \mid (Y_0, \dots, Y_l), (U_{ij})_{i,j=0}^l \right] \xrightarrow{\text{a.s.}} \mathbb{E} \left[\mathcal{A}_\infty \mid (Y_0, \dots, Y_l), (U_{ij})_{i,j=0}^l \right],$$

which implies, using dominated convergence (note that domination by 1 works), that

$$\mathbb{E} [\mathcal{A}_n] \rightarrow \mathbb{E} [\mathcal{A}_\infty],$$

as $n \rightarrow \infty$.

Hence, again using (57) and (59), we have $\mathbb{E}[\mathcal{A}_n] \rightarrow \mathbb{E}[\mathcal{A}_\infty]$, which is just (45), as can be seen by recalling the definition of \mathcal{A}_n from (54) and the definition of \mathcal{A}_∞ from (55). This completes the proof of Proposition 3. \square

3.3. Proofs of path-counting results: Lemma 2 and Corollary 7

Proof of Lemma 2. Recall the notation \mathcal{B}'_x from (30), which denotes the open Euclidean ball of radius r in \mathbb{R}^d centered at $x \in \mathbb{R}^d$. We first prove (35).

We first bound $\mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j)$ from above by $\mathbb{E}[\kappa(\|x_j - x_{j-1}\|, W_0, W_1)]$, where W_0 and W_1 are i.i.d. copies of the limiting weight distribution W (recall (4)). Then we apply the change of variables

$$z_i = x_i - x_{i-1}, \quad 1 \leq i \leq j,$$

where $x_0 = \mathbf{0}$, and apply Fubini’s theorem to obtain

$$\begin{aligned} & \int_{\mathbb{R}^d} \cdots \int_{\mathbb{R}^d} \mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j) \\ & \quad \mathbb{1}_{\{\|x_1\| < a^m\}} \prod_{i=1}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{mj}\}} dx_1 \cdots dx_j \\ & \leq \int_{\mathcal{B}_0^{a^m}} \cdots \int_{\mathcal{B}_0^{a^{m^{j-1}}}} \int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a^{mj}}} \mathbb{E}[\kappa(\|z_j\|, W_0, W_1)] dz_j dz_{j-1} \cdots dz_1 \\ & \leq C_0 (a^m)^d \cdots (a^{m^{j-1}})^d \int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a^{mj}}} \mathbb{E}[\kappa(\|z\|, W_0, W_1)] dz, \end{aligned} \tag{62}$$

for some constant $C_0 > 0$. Recall the polynomial domination from (6) and the assumption $\alpha > d$ in Theorem 1.

We note, by first making a change of variables to bring the integral

$$\int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a^{mj}}} \mathbb{E}[\kappa(\|z\|, W_0, W_1)] dz$$

down to an integral on \mathbb{R} , and then using (6), that for any m sufficiently large so that $a^{mj} > t_0$,

$$\int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a^{mj}}} \mathbb{E}[\kappa(\|z\|, W_0, W_1)] dz \leq C_1 \frac{1}{a^{(\alpha-d)m^j}}, \tag{63}$$

for some constant $C_1 > 0$.

Combining (63) with (62), we note that for some constant $C_2 > 0$,

$$\begin{aligned} & \int_{\mathbb{R}^d} \cdots \int_{\mathbb{R}^d} \mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j) \\ & \quad \mathbb{1}_{\{\|x_1\| < a^m\}} \prod_{i=1}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{mj}\}} dx_1 \cdots dx_j \\ & \leq C_2 \frac{1}{a^{dm^j \left(\frac{\alpha}{d} - 1 - \frac{1}{m} - \cdots - \frac{1}{m^{j-1}}\right)}} \rightarrow 0, \end{aligned} \tag{64}$$

as $m \rightarrow \infty$, since $\frac{\alpha}{d} > 1$. This finishes the proof of (35).

We next go into the proof of (34). Recall the definition of $\mathbb{W}_n^{v_1, \dots, v_j}(x_0, x_1, \dots, x_j)$ from (32), where $v_0 = U_n$ is the uniformly chosen vertex of \mathbb{G}_n .

We use the notation

$$\vec{v} = v_1, \dots, v_j; \vec{x} = (x_0, x_1, \dots, x_j).$$

For fixed $x_0, \dots, x_j \in \mathbb{R}^d$, we define the function $\mathcal{W}_n^{\vec{x}}: \mathbb{R}^{j+1} \rightarrow \mathbb{R}$ by

$$\mathcal{W}_n^{\vec{x}}(\vec{t}) := \kappa_n(\|x_1 - x_0\|, t_0, t_1) \cdots \kappa_n(\|x_j - x_{j-1}\|, t_{j-1}, t_j), \tag{65}$$

for $\vec{t} = (t_0, t_1, \dots, t_j) \in \mathbb{R}^{j+1}$.

Note that

$$\frac{1}{n^j} \sum_{v_1, \dots, v_j \in [n]} \mathbb{W}_n^{\vec{v}}(\vec{x}) = \mathbb{E} \left[\frac{1}{n^{j+1}} \sum_{i_0, i_1, \dots, i_j} \mathcal{W}_n^{\vec{x}}(W_{i_0}^{(n)}, \dots, W_{i_j}^{(n)}) \right], \tag{66}$$

where we have used (32) and the fact that $v_0 = U_n$ is uniformly distributed over n .

Since clearly

$$\mathbb{E} \left[\frac{1}{n^{j+1}} \sum_{i_0, i_1, \dots, i_j} \mathcal{W}_n^{\vec{x}}(W_{i_0}^{(n)}, \dots, W_{i_j}^{(n)}) \right] = \mathbb{E} \left[\mathcal{W}_n^{\vec{x}}(W_{U_{n,0}}^{(n)}, \dots, W_{U_{n,j}}^{(n)}) \right],$$

where $U_{n,0}, \dots, U_{n,j}$ is an i.i.d. collection of uniformly distributed random variables on $[n] = \{1, \dots, n\}$, we can take h_n in (8) to be $\mathcal{W}_n^{\vec{x}}$ and conclude (recalling the definition of $\mathbb{W}_j(\vec{x}) = \mathbb{W}_j(x_0, x_1, \dots, x_j)$ from (33)) that

$$\frac{1}{n^j} \sum_{v_1, \dots, v_j \in [n]} \mathbb{W}_n^{\vec{v}}(\vec{x}) = \mathbb{E} \left[\mathcal{W}_n^{\vec{x}}(W_{U_{n,0}}^{(n)}, \dots, W_{U_{n,j}}^{(n)}) \right] \rightarrow \mathbb{W}_j(\vec{x}), \tag{67}$$

as $n \rightarrow \infty$. Now, (34) can be concluded using (67), a routine change of variables, Fatou’s lemma, and (35). □

Remark 8. (*Efficacy of our bounds.*) In the proof of Lemma 2, we have bounded $\mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j)$ from above by

$$\mathbb{E} \left[\kappa(\|x_j - x_{j-1}\|, W_0, W_1) \right].$$

That is, we have bounded all except the last term in the product inside the expectation $\mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j)$ by 1. This is usually a poor bound. However, as we see in the proof, this loss is well compensated by the strong double-exponential growth of $r = r(a, m, K)$ (recall (36)). In particular, for our purpose, we have been able to avoid the question of how correlated the random variables $\kappa(\|x_0 - x_1\|, W^{(0)}, W^{(1)})$ and $\kappa(\|x_1 - x_2\|, W^{(1)}, W^{(2)})$ are, where $x_0, x_1, x_2 \in \mathbb{R}^d$, and $W^{(0)}, W^{(1)}, W^{(2)}$ are i.i.d. copies of the limiting weight distribution. We believe this question to be hard to tackle in general, under our general assumptions on κ as formulated in Assumption 3.

Next we go into the proof of Corollary 7.

Proof of Corollary 7. Recall the definition of the distance of an edge from a vertex from (31). Also recall the abbreviations in (37).

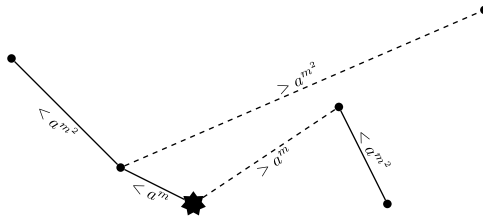


FIGURE 2. Illustration demonstrating bad edges. The star is the root. The dashed edges are bad: each of them connects a pair of vertices whose locations are at least $a^{m^{L+1}}$ apart, where L is the distance of the edge from the root. The solid edges are good.

We begin by analyzing the event $\{BF_{n,r} \neq B_n\}$. Note that if $\|Y_i^{(n)} - Y_j^{(n)}\| < a^{m^{L+1}}$ for every edge $\{i, j\}$ in B_n that is at graph distance L ($0 \leq L \leq K - 1$) from the root U_n , then B_n is a subgraph of $F_{n,r}$ with the same root U_n , which implies that $BF_{n,r} = B_n$. Hence, the event $\{BF_{n,r} \neq B_n\}$ implies the event

$$\mathbf{Bad}_{r,n} := \{\text{there is some bad edge in } B_n\}, \tag{68}$$

where a *bad edge* is an edge $\{i, j\}$ in B_n with $\|Y_i^{(n)} - Y_j^{(n)}\| > a^{m^{L+1}}$, where $0 \leq L \leq K - 1$ is the graph distance of the edge $\{i, j\}$ from the root U_n of B_n .

Therefore,

$$\mathbb{P}(BF_{n,r} \neq B_n) \leq \mathbb{P}(\mathbf{Bad}_{r,n}). \tag{69}$$

By a similar argument,

$$\mathbb{P}(BF_r \neq B) \leq \mathbb{P}(\mathbf{Bad}_r), \tag{70}$$

where the event \mathbf{Bad}_r is similarly defined for the rooted graph $(\mathbb{G}_\infty, 0)$.

Define the event $\mathcal{I}_{n,j}$, for $n \in \mathbb{N}, j \in [n]$, as

$$\begin{aligned} \mathcal{I}_{n,j} := & \{\exists v_1, \dots, v_j \in V(\mathbb{G}_n) = [n] : \{v_0, v_1, \dots, v_j\} \text{ is a } j\text{-path in } (\mathbb{G}_n, U_n) \text{ starting from} \\ & \text{the root } v_0 = U_n, \|Y_{v_{i-1}}^{(n)} - Y_{v_i}^{(n)}\| < a^{m^i} \forall i \in [j - 1], \|Y_{v_{j-1}}^{(n)} - Y_{v_j}^{(n)}\| > a^{m^j}\}. \end{aligned} \tag{71}$$

A simple union bound gives

$$\mathbb{P}(\mathbf{Bad}_{r,n}) \leq \sum_{j=1}^K \mathbb{P}(\mathcal{I}_{n,j}). \tag{72}$$

Similarly,

$$\mathbb{P}(\mathbf{Bad}_r) \leq \sum_{j=1}^K \mathbb{P}(\mathcal{I}_j), \tag{73}$$

where the event \mathcal{I}_j for $j \in \mathbb{N}$ is similarly defined for the rooted graph $(\mathbb{G}_\infty, 0)$.

Note that since K is fixed, it suffices to prove that $\lim_{m \rightarrow \infty} \limsup_{n \rightarrow \infty} \mathbb{P}(\mathcal{I}_{n,j}) = 0$ and $\lim_{m \rightarrow \infty} \limsup_{n \rightarrow \infty} \mathbb{P}(\mathcal{I}_j) = 0$ for $1 \leq j \leq K$.

We proceed by bounding the probabilities $\mathbb{P}(\mathcal{I}_{n,j})$ and $\mathbb{P}(\mathcal{I}_j)$. Recall that we use v_0 to denote the typical vertex U_n of \mathbb{G}_n from the definition of the event $\mathcal{I}_{n,j}$ from (71). Note that, by Markov’s inequality, using the notation $\vec{v} = (v_0, v_1, \dots, v_n)$,

$$\begin{aligned} \mathbb{P}(\mathcal{I}_{n,j}) \leq & \sum_{v_1, \dots, v_j \in [n]} \mathbb{P}(\vec{v} \text{ is a } j\text{-path, } \|Y_{v_{i-1}}^{(n)} - Y_{v_i}^{(n)}\| < a^{m^i} \forall i \in [j - 1], \|Y_{v_{j-1}}^{(n)} - Y_{v_j}^{(n)}\| > a^{m^j}). \end{aligned} \tag{74}$$

For convenience, for $v_0, \dots, v_j \in [n]$, we define the event

$$\mathcal{E}_{n,j}(\vec{v}) := \{\|Y_{v_{i-1}}^{(n)} - Y_{v_i}^{(n)}\| < a^{m^i} \forall i \in [j-1], \|Y_{v_{j-1}}^{(n)} - Y_{v_j}^{(n)}\| > a^{m^j}\}. \tag{75}$$

We compute

$$\begin{aligned} & \mathbb{P}\left(\{v_0, v_1, \dots, v_j\} \text{ } j\text{-path}, \|Y_{v_{i-1}}^{(n)} - Y_{v_i}^{(n)}\| < a^{m^i} \forall i \in [j-1], \|Y_{v_{j-1}}^{(n)} - Y_{v_j}^{(n)}\| > a^{m^j}\right) \\ &= \mathbb{E}\left[\mathbb{1}_{\mathcal{E}_{n,j}(\vec{v})} \mathbb{P}\left(\{v_0, v_1, \dots, v_j\} \text{ } j\text{-path} \left| Y_{v_0}^{(n)}, \dots, Y_{v_j}^{(n)}, W_{v_0}^{(n)}, \dots, W_{v_j}^{(n)} \right.\right)\right] \\ &= \mathbb{E}\left[\mathbb{1}_{\mathcal{E}_{n,j}(\vec{v})} \kappa_n\left(\|Y_{v_0}^{(n)} - Y_{v_1}^{(n)}\|, W_{v_0}^{(n)}, W_{v_1}^{(n)}\right) \cdots \kappa_n\left(\|Y_{v_{j-1}}^{(n)} - Y_{v_j}^{(n)}\|, W_{v_{j-1}}^{(n)}, W_{v_j}^{(n)}\right)\right]. \end{aligned} \tag{76}$$

Recall the notation $\mathbb{W}_n^{v_1, \dots, v_j}$ from (32). Using Fubini’s theorem and the fact that $\{Y_{v_0}^{(n)}, Y_{v_1}^{(n)}, \dots, Y_{v_j}^{(n)}\}$ is an i.i.d. collection of $j + 1$ uniform random variables on I_n , recalling (75), and using the notation $\vec{x} = (x_0, x_1, \dots, x_j)$, we find that (76) becomes

$$\frac{1}{n^{j+1}} \int_{I_n} \cdots \int_{I_n} \mathbb{W}_n^{v_1, \dots, v_j}(\vec{x}) \prod_{i=0}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{m^j}\}} dx_0 \cdots dx_j. \tag{77}$$

Using (74) and (77), we have

$$\begin{aligned} \mathbb{P}(\mathcal{I}_{n,j}) &\leq \frac{1}{n^{j+1}} \int_{I_n} \cdots \int_{I_n} \sum_{v_1, \dots, v_j \in [n]} \mathbb{W}_n^{v_1, \dots, v_j}(\vec{x}) \\ &\quad \times \prod_{i=0}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{m^j}\}} dx_0 \cdots dx_j. \end{aligned} \tag{78}$$

Recall the notation \mathbb{W}_j from (33). Similarly, by the multivariate Mecke formula for Poisson processes [27, Theorem 4.4],

$$\begin{aligned} \mathbb{P}(\mathcal{I}_j) &\leq \int_{\mathbb{R}^d} \cdots \int_{\mathbb{R}^d} \mathbb{W}_j(\mathbf{0}, x_1, \dots, x_j) \mathbb{1}_{\{\|x_1\| < a^m\}} \\ &\quad \times \prod_{i=1}^{j-2} \mathbb{1}_{\{\|x_{i+1} - x_i\| < a^{m^{i+1}}\}} \mathbb{1}_{\{\|x_j - x_{j-1}\| > a^{m^j}\}} dx_1 \cdots dx_j. \end{aligned} \tag{79}$$

Now we apply Lemma 2 for the bounds (79) and (77), and use the bounds (69), (70), (72), and (73) to conclude Corollary 7. □

Remark 9. (A general estimate.) Recall the notation (37), and recall $r(a, m, K)$ from (36). Note that the bound (69) is true even when one has $a = a_n$ and $K = K_n$ in $r = r(a_n, m, K_n)$, and so is the simple union bound (72). The integral bound (78) also works in this generality. Recalling the definition of the function $\mathcal{W}_n^{(x_0, \dots, x_j)}$ from (65), the equality (66), and the display below it, bounding $\mathbb{E}\left[\mathcal{W}_n^{(x_0, \dots, x_j)}(W_{U_{n,0}}^{(n)}, \dots, W_{U_{n,j}}^{(n)})\right]$ from above by $\mathbb{E}\left[\kappa_n(\|x_j - x_{j-1}\|, W_{U_{n,j}}^{(n)}, W_{U_{n,j-1}}^{(n)})\right]$

(where $U_{n,0}, \dots, U_{n,j}$ are i.i.d. uniformly distributed random variables on $[n]$), and making an easy change of variable, we obtain the general bound

$$\begin{aligned} & \mathbb{P} \left(B_{U_n}^{F_{U_n}^{\mathbb{G}_n}(r_n)}(K_n) \neq B_{U_n}^{\mathbb{G}_n}(K_n) \right) \\ & \leq \sum_{j=1}^{K_n} \int_{\mathcal{B}_0^{a_n^m}} \cdots \int_{\mathcal{B}_0^{a_n^{j-1}}} \int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a_n^j}} \mathbb{E} \left[\kappa_n(\|z_j\|, W_{U'_{n,1}}^{(n)}, W_{U'_{n,2}}^{(n)}) \right] dz_j \cdots dz_1, \end{aligned} \tag{80}$$

where $U'_{n,1}$ and $U'_{n,2}$ are two i.i.d. uniform elements in $[n]$. Below, we will use the bound (80) with suitable choices of $a = a_n$ and $K = K_n$ to prove Theorem 3.

3.4. Proof of Theorem 1

Proposition 3 implies that the random rooted graph $(F_{U_n}^{\mathbb{G}_n}(r), U_n)$ converges in distribution to the random rooted graph $(F_0^{\mathbb{G}_\infty}(r), 0)$ in the space \mathcal{G}_* . The proof of this fact can be carried out in the same manner as [22, Theorem 2.13] is proved assuming [22, Definition 2.10], and so we leave this for the reader to check. In particular, as a consequence of Proposition 3,

$$\mathbb{P} \left((F_{U_n}^{\mathbb{G}_n}(r), U_n) \in A \right) \rightarrow \mathbb{P} \left((F_0^{\mathbb{G}_\infty}(r), U_n) \in A \right), \tag{81}$$

for any subset $A \subset \mathcal{G}_*$.

Proof of Theorem 1. Recall the definition of local weak convergence from Definition 3. Recall the abbreviations in (37). Let $G_* = (G, g) \in \mathcal{G}_*$.

Fix $K \in \mathbb{N}$ and $\varepsilon > 0$. To conclude Theorem 1, we need to find an $N \in \mathbb{N}$ such that for all $n > N$,

$$\left| \mathbb{P} \left(B_{U_n}^{\mathbb{G}_n}(K) \cong (G, g) \right) - \mathbb{P} \left(B_0^{\mathbb{G}_\infty}(K) \cong (G, g) \right) \right| < \varepsilon, \tag{82}$$

that is

$$|\mathbb{P}(B_n \cong (G, g)) - \mathbb{P}(B \cong (G, g))| < \varepsilon.$$

Note that

$$\begin{aligned} & |\mathbb{P}(B_n \cong (G, g)) - \mathbb{P}(B \cong (G, g))| \\ & \leq |\mathbb{P}(BF_{n,r} \cong (G, g)) - \mathbb{P}(BF_r \cong (G, g))| + |\varepsilon_{n,r}| + |\varepsilon_r|, \end{aligned} \tag{83}$$

where

$$\varepsilon_{n,r} = \mathbb{P}(B_n \cong (G, g), BF_{n,r} \neq B_n) - \mathbb{P}(BF_{n,r} \cong (G, g), BF_{n,r} \neq B_n) \tag{84}$$

and

$$\varepsilon_r = \mathbb{P}(B \cong (G, g), BF_r \neq B) - \mathbb{P}(BF_r \cong (G, g), BF_r \neq B). \tag{85}$$

Clearly,

$$|\varepsilon_{n,r}| \leq \mathbb{P}(BF_{n,r} \neq B_n) \tag{86}$$

and

$$|\varepsilon_r| \leq \mathbb{P}(BF_r \neq B). \tag{87}$$

For the rest of the proof, we fix $m > 0$ and $n_0 \in \mathbb{N}$ such that, for all $n \geq n_0$,

$$|\varepsilon_{n,r}| + |\varepsilon_r| < \varepsilon/2, \tag{88}$$

which is possible by Corollary 7.

Note that

$$\mathbb{P}(BF_{n,r} \cong (G, g)) = \mathbb{P}(F_{n,r} \in A(K, (G, g))),$$

where $A(K, (G, g)) \subset \mathcal{G}_\star$ is defined as

$$A(K, (G, g)) := \{(H, h) \in \mathcal{G}_\star : B_h^H(K) \cong (G, g)\}. \tag{89}$$

By (81), as $n \rightarrow \infty$,

$$\mathbb{P}(F_{n,r} \in A(K, (G, g))) \rightarrow \mathbb{P}(F_r \in A(K, (G, g))) = \mathbb{P}(BF_r \cong (G, g)). \tag{90}$$

Combining (90) with (88) and (83), we can choose $n_1 \in \mathbb{N}$ such that for all $n > N = \max\{n_1, n_0\}$, (82) holds. This completes the proof of Theorem 1. \square

3.5. Proof of Theorem 2

For $(H, h) \in \mathcal{G}_\star$ and $r > 0$, recall the empirical Euclidean graph neighborhood distribution as defined in (40). We first give the proof of Lemma 3.

Proof of Lemma 3. To ease notation, let us write $C_{r,n}$ for $C_{r,n}(H, h)$.

Note that

$$\begin{aligned} C_{r,n}^2 &= \frac{1}{n^2} \sum_{i,j=1}^n \mathbb{1}_{\{F_i^{\mathbb{G}_n}(r) \cong (H, h)\}} \mathbb{1}_{\{F_j^{\mathbb{G}_n}(r) \cong (H, h)\}} \\ &= \mathbb{P}\left(F_{U_{n,1}}^{\mathbb{G}_n}(r) \cong (H, h), F_{U_{n,2}}^{\mathbb{G}_n}(r) \cong (H, h) \mid \mathbb{G}_n\right), \end{aligned}$$

where $U_{n,1}, U_{n,2}$ are i.i.d. uniformly distributed random variables on $[n]$. Therefore,

$$\mathbb{E}\left[C_{r,n}^2\right] = \mathbb{P}\left(F_{U_{n,1}}^{\mathbb{G}_n}(r) \cong (H, h), F_{U_{n,2}}^{\mathbb{G}_n}(r) \cong (H, h)\right). \tag{91}$$

We introduce the following abbreviations, which we will use throughout this proof to keep notation concise (recall the point process Γ_n of the locations of the vertices of \mathbb{G}_n from (9), the set A_n^r from (29), and the ball \mathcal{B}_x^r from (30)):

$$\begin{aligned} \mathcal{E} &:= \left\{F_{U_{n,1}}^{\mathbb{G}_n}(r) \cong (H, h)\right\}, & \mathcal{F} &:= \left\{F_{U_{n,2}}^{\mathbb{G}_n}(r) \cong (H, h)\right\}, \\ \mathcal{U} &:= \left\{\Gamma_n\left(\mathcal{B}_{Y_{U_{n,1}}^{(n)}}^r\right) = |V(H)|\right\}, & \mathcal{V} &:= \left\{\Gamma_n\left(\mathcal{B}_{Y_{U_{n,2}}^{(n)}}^r\right) = |V(H)|\right\}, \\ \mathcal{J} &:= \left\{\mathcal{B}_{Y_{U_{n,1}}^{(n)}}^r \cap \mathcal{B}_{Y_{U_{n,2}}^{(n)}}^r = \emptyset\right\}, & \mathcal{W} &:= \{U_{n,1}, U_{n,2} \in A_n^r\}. \end{aligned} \tag{92}$$

Recall that the target is to show

$$|\mathbb{P}(\mathcal{E} \cap \mathcal{F}) - \mathbb{P}(\mathcal{E})\mathbb{P}(\mathcal{F})| = |\mathbb{P}(\mathcal{E} \cap \mathcal{F}) - \mathbb{P}(\mathcal{E})^2| \rightarrow 0, \tag{93}$$

as $n \rightarrow \infty$ (note that conditionally on \mathbb{G}_n , the random variables $\mathbb{1}_{\mathcal{E}}$ and $\mathbb{1}_{\mathcal{F}}$ are identically distributed, so that they have the same conditional expectation, and hence the same expectation).

First we write

$$\mathbb{P}(\mathcal{E} \cap \mathcal{F}) = \mathbb{P}\left(\mathcal{E} \cap \mathcal{F} \mid \mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}\right) \mathbb{P}(\mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}) \tag{94}$$

$$+ \mathbb{P}\left(\{\mathcal{E} \cap \mathcal{F}\} \cap \{\mathcal{J}^c \cup \mathcal{U}^c \cup \mathcal{V}^c \cup \mathcal{W}^c\}\right). \tag{95}$$

Note that the term in (95) is bounded from above by

$$\mathbb{P}\left(\{\mathcal{E} \cap \mathcal{F}\} \cap \{\mathcal{U}^c \cup \mathcal{V}^c\}\right) + \mathbb{P}(\mathcal{J}^c) + \mathbb{P}(\mathcal{W}^c),$$

and it is easily observed that the first term is equal to 0, while the last term tends to 0 as $n \rightarrow \infty$ by (42). Also note that

$$\mathbb{P}(\mathcal{J}^c) \leq \mathbb{P}\left(Y_{U_{n,1}}^{(n)} \in \mathcal{B}_{Y_{U_{n,2}}^{(n)}}^{2r} \cap I_n\right).$$

Clearly,

$$\mathbb{P}\left(Y_{U_{n,1}}^{(n)} \in \mathcal{B}_{Y_{U_{n,2}}^{(n)}}^{2r} \cap I_n \mid Y_{U_{n,2}}^{(n)}\right) \stackrel{\text{a.s.}}{\leq} \frac{\lambda_d(\{y \in \mathbb{R}^d : \|y\| < 2r\})}{n},$$

which tends to 0 as $n \rightarrow \infty$. Hence, taking expectations of both sides in the last display and letting $n \rightarrow \infty$, we get $\mathbb{P}(\mathcal{J}^c) \rightarrow 0$. Hence the term in (95) tends to 0 as $n \rightarrow \infty$.

To analyze the term in (94), we observe that, conditionally on $\mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}$, the random variables $\mathbb{1}_{\mathcal{E}}$ and $\mathbb{1}_{\mathcal{F}}$ are independent, since they are just functions of the locations of the $|V(H)|$ points falling in $\mathcal{B}_{Y_{U_{n,1}}^{(n)}}^r$ and $\mathcal{B}_{Y_{U_{n,2}}^{(n)}}^r$, and these locations are independent (since the locations of different vertices of \mathbb{G}_n are independent). Hence,

$$(94) = \mathbb{P}\left(\mathcal{E} \mid \mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}\right) \mathbb{P}\left(\mathcal{F} \mid \mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}\right) \mathbb{P}(\mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}).$$

Now note that \mathcal{E} is independent of \mathcal{V} , conditionally on $\{\mathcal{J} \cap \mathcal{U} \cap \mathcal{W}\}$. Similarly, \mathcal{F} is independent of \mathcal{U} , conditionally on $\{\mathcal{J} \cap \mathcal{V} \cap \mathcal{W}\}$.

Hence,

$$(94) = \mathbb{P}\left(\mathcal{E} \mid \mathcal{J} \cap \mathcal{U} \cap \mathcal{W}\right) \mathbb{P}\left(\mathcal{F} \mid \mathcal{J} \cap \mathcal{V} \cap \mathcal{W}\right) \mathbb{P}(\mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}).$$

As argued earlier, $\mathbb{P}(\mathcal{J}^c) \rightarrow 0$, so $\mathbb{P}(\mathcal{J}) \rightarrow 1$, and it is easy to observe that $\mathbb{P}(\mathcal{W}) \rightarrow 1$ using (42). Hence we can forget about the ‘almost’ certain events \mathcal{W} and \mathcal{J} for the first two terms from the last display, and condition on $\mathcal{J} \cap \mathcal{W}$ for the third term, to conclude that (recall (94))

$$\begin{aligned} & \left| \mathbb{P}\left(\mathcal{E} \cap \mathcal{F} \mid \mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}\right) \mathbb{P}(\mathcal{J} \cap \mathcal{U} \cap \mathcal{V} \cap \mathcal{W}) \right. \\ & \left. - \mathbb{P}\left(\mathcal{E} \mid \mathcal{U}\right) \mathbb{P}\left(\mathcal{F} \mid \mathcal{V}\right) \mathbb{P}\left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W}\right) \right| \rightarrow 0; \end{aligned} \tag{96}$$

that is, the difference between (94) and $\mathbb{P}\left(\mathcal{E} \mid \mathcal{U}\right) \mathbb{P}\left(\mathcal{F} \mid \mathcal{V}\right) \mathbb{P}\left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W}\right)$ tends to 0.

We claim that to conclude the proof, it suffices to check that

$$\left| \mathbb{P} \left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W} \right) - \mathbb{P}(\mathcal{U}) \mathbb{P}(\mathcal{V}) \right| \rightarrow 0. \tag{97}$$

This is because (97), combined with (96) and the observations that $\mathcal{E} \subset \mathcal{U}$ and $\mathcal{F} \subset \mathcal{V}$, implies that the difference between the expression (94) and $\mathbb{P}(\mathcal{E}) \mathbb{P}(\mathcal{F})$ goes to 0. Combining this with the fact that the expression in (95) goes to 0, we obtain (93).

We now show (97). Recall that $|V(H)|$ denotes the size of the vertex set of the graph H . Observe that

$$\mathbb{P} \left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W} \right) = \mathbb{P} \left((M_1, M_2, M_3) = (|V(H)| - 1, |V(H)| - 1, n - 2|V(H)|) \right),$$

where $\mathbf{M} = (M_1, M_2, M_3)$ is a multinomial vector with parameters

$$\left(n - 2; \frac{\lambda_d(\mathcal{B}_0^r)}{n}, \frac{\lambda_d(\mathcal{B}_0^r)}{n}, 1 - 2 \frac{\lambda_d(\mathcal{B}_0^r)}{n} \right).$$

Hence,

$$\begin{aligned} & \mathbb{P} \left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W} \right) \\ &= \frac{n!}{(|V(H)| - 1)! (|V(H)| - 1)! (n - 2|V(H)|)!} \\ & \times \left(\frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^{|V(H)| - 1} \left(\frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^{|V(H)| - 1} \left(1 - 2 \frac{\lambda_d(\mathcal{B}_0^r)}{n} \right)^{n - 2|V(H)|}. \end{aligned}$$

It is an easy analysis to check that this converges to $\mathbb{P}(Y = |V(H)| - 1)^2$, where $Y \sim \text{Poi}(\lambda_d(\mathcal{B}_0^r))$.

Again,

$$\mathbb{P} \left(\mathcal{U} \mid Y_{U_{n,1}}^{(n)} \in A_n^r \right) \mathbb{P} \left(\mathcal{V} \mid Y_{U_{n,2}}^{(n)} \in A_n^r \right) = \mathbb{P}(Y'_n = |V(H)| - 1)^2,$$

where $Y'_n \sim \text{Bin}(n - 1, \frac{\lambda_d(\mathcal{B}_0^r)}{n})$.

Since $\mathbb{P}(Y'_n = |V(H)| - 1)^2 \rightarrow \mathbb{P}(Y = |V(H)| - 1)^2$, and both

$$\mathbb{P} \left(Y_{U_{n,1}}^{(n)} \in A_n^r \right), \mathbb{P} \left(Y_{U_{n,2}}^{(n)} \in A_n^r \right) \geq \mathbb{P}(\mathcal{W}) \rightarrow 1$$

(using (42)), we have shown that

$$\begin{aligned} & \left| \mathbb{P} \left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W} \right) - \mathbb{P}(\mathcal{U}) \mathbb{P}(\mathcal{V}) \right| \\ & \leq \left| \mathbb{P} \left(\mathcal{U} \cap \mathcal{V} \mid \mathcal{J} \cap \mathcal{W} \right) - \mathbb{P} \left(\mathcal{U} \mid Y_{U_{n,1}}^{(n)} \in A_n^r \right) \mathbb{P} \left(\mathcal{V} \mid Y_{U_{n,2}}^{(n)} \in A_n^r \right) \right| \\ & + \left| \mathbb{P} \left(\mathcal{U} \mid Y_{U_{n,1}}^{(n)} \in A_n^r \right) \mathbb{P} \left(\mathcal{V} \mid Y_{U_{n,2}}^{(n)} \in A_n^r \right) - \mathbb{P}(\mathcal{U}) \mathbb{P}(\mathcal{V}) \right| \rightarrow 0. \end{aligned}$$

This completes the proof of (97) and hence of Lemma 3. □

Note that using Lemma 3 with Proposition 3, a direct application of Chebyshev’s inequality gives, for any $(H, h) \in \mathcal{G}_\star$,

$$C_{r,n}(H, h) \xrightarrow{\mathbb{P}} \mathbb{P} \left(F_0^{\mathbb{G}^\infty}(r) \cong (H, h) \right).$$

In particular, this implies that the empirical Euclidean graph neighborhood measure of \mathbb{G}_n converges in probability to the measure induced by the random element $(F_0^{\mathbb{G}^\infty}(r), 0)$ in \mathcal{G}_\star : for any subset $A \subset \mathcal{G}_\star$ and for any $r > 0$ (recall the Euclidean graph neighborhoods from Definition 6),

$$\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{(F_i^{\mathbb{G}_n}(r), i) \in A\}} \xrightarrow{\mathbb{P}} \mathbb{P} \left((F_0^{\mathbb{G}^\infty}(r), 0) \in A \right), \tag{98}$$

as $n \rightarrow \infty$. We now use (98) to prove Theorem 2.

Proof of Theorem 2. For $K \in \mathbb{N}$ and $(G, g) \in \mathcal{G}_\star$, recall the random variables $B_n(G, g)$ as defined in (41). Furthermore, recall the definition of local convergence in probability from Definition 4.

Fix $\varepsilon > 0$. Note that the target is to show that, for every $\varepsilon > 0$, there exists $N \in \mathbb{N}$ such that for all $n > N$,

$$\mathbb{P} \left(\left| B_n(G, g) - \mathbb{P} \left(B_0^{\mathbb{G}^\infty}(K) \cong (G, g) \right) \right| > \varepsilon \right) < \varepsilon. \tag{99}$$

We abbreviate the Euclidean graph neighborhoods $F^{n,r,i} := F_i^{\mathbb{G}_n}(r)$, with $r = r(a, m, K)$ as in (36), and $i \in V(\mathbb{G}_n) = [n]$. We note that

$$\begin{aligned} B_n(G, g) &= \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \cong (G, g)\}} \\ &= \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \cong (G, g)\}} \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) = B_i^{F^{n,r,i}}(K)\}} \end{aligned} \tag{100}$$

$$+ \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \cong (G, g)\}} \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \neq B_i^{F^{n,r,i}}(K)\}}. \tag{101}$$

Writing the first term on the right-hand side of (101) as

$$\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{F^{n,r,i}}(K) \cong (G, g)\}} - \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{F^{n,r,i}}(K) \cong (G, g)\}} \mathbb{1}_{\{B_i^{\mathbb{G}_n}(K) \neq B_i^{F^{n,r,i}}(K)\}}, \tag{102}$$

we note from (101) that

$$B_n(G, g) = \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{F^{n,r,i}}(K) \cong (G, g)\}} + \varepsilon'_{n,r}, \tag{103}$$

where (recall the event **Bad** $_{r,n}$ from (68)) the expectation $\mathbb{E} [|\varepsilon'_{n,r}|]$ of the absolute value of the error $\varepsilon'_{n,r}$ is bounded from above by $2\mathbb{P}(\mathbf{Bad}_{r,n})$.

It can be shown using a similar argument that (recall the notation (37))

$$\mathbb{P} \left(B_0^{\mathbb{G}^\infty}(K) \cong (G, g) \right) = \mathbb{P} (BF_r \cong (G, g)) + \varepsilon'_r, \tag{104}$$

where $\mathbb{E} [|\varepsilon'_r|]$ is bounded from above by $2\mathbb{P}(\mathbf{Bad}_r)$.

Using Corollary 7, it is easy to see that there exists $n_0 \in \mathbb{N}$ such that for $m > 0$ sufficiently large (recall $r = r(a, m, K)$), for all $n > n_0$,

$$2\mathbb{P}(\mathbf{Bad}_{r,n}) + 2\mathbb{P}(\mathbf{Bad}_r) < \varepsilon/2. \tag{105}$$

Recall the subset $A(K, (G, g)) \subset \mathcal{G}_*$ from (89). Note that using (98),

$$\begin{aligned} \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{F_{n,r,i}}(K) \cong (G,g)\}} &= \frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{(F_{n,r,i},i) \in A(K,(G,g))\}} \\ &\xrightarrow{\mathbb{P}} \mathbb{P}\left((F_0^{\mathbb{G}_\infty}(r), 0) \in A(K, (G, g))\right) \\ &= \mathbb{P}(BF_r \cong (G, g)), \end{aligned}$$

and so there exists $n_1 \in \mathbb{N}$ such that for all $n > n_1$ we have

$$\mathbb{P}\left(\left|\frac{1}{n} \sum_{i=1}^n \mathbb{1}_{\{B_i^{F_{n,r,i}}(K) \cong (G,g)\}} - \mathbb{P}(BF_r \cong (G, g))\right| > \varepsilon/2\right) < \varepsilon/2. \tag{106}$$

Hence, for all $n > N = \max\{n_0, n_1\}$, we note that by (105) and (106), (99) holds. This completes the proof of Theorem 2. □

3.6. Proof of Theorem 3

The main idea in this proof is that the first result of Corollary 7 can be pushed to the case when $K = K_n$ is allowed to grow in a doubly logarithmic manner, instead of being fixed. For this, we need a finer analysis of the error terms we encounter while proving Lemma 2. We now go into the formal argument.

Proof. Recall $C \in \left(0, \frac{1}{\log(\frac{\alpha}{\alpha-d})}\right)$. Fix some $\bar{C} \in \left(C, \frac{1}{\log(\frac{\alpha}{\alpha-d})}\right)$, and let

$$m := e^{1/\bar{C}}. \tag{107}$$

Since $\bar{C} < \frac{1}{\log(\frac{\alpha}{\alpha-d})}$,

$$\frac{\alpha}{d} > \frac{m}{m-1}.$$

Let

$$a_n = \log n \tag{108}$$

and

$$K_n = \frac{\log \log n + \log(\frac{1}{d} - \delta) - \log \log a_n}{\log m} = \frac{\log \log n + \log(\frac{1}{d} - \delta) - \log \log \log n}{\log m}, \tag{109}$$

where $\delta > 0$ is such that $\frac{1}{d} - \delta > 0$. Note that by the choice of K_n , we have

$$a_n^{m^{K_n}} = n^{\frac{1}{d} - \delta}. \tag{110}$$

We also let $r_n = r(a_n, m, K_n)$ be as in (36).

Note that, since $C < \frac{1}{\log m}$ by the choice of m , for all large n ,

$$C \log \log n \leq K_n.$$

Then for $U_{n,1}$ and $U_{n,2}$ two uniformly chosen vertices of \mathbb{G}_n , for all large n ,

$$\begin{aligned} & \mathbb{P} \left(d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) \leq C \log \log n \right) \\ & \leq \mathbb{P} \left(d_{\mathbb{G}_n}(U_{n,1}, U_{n,2}) \leq K_n \right) \\ & = \mathbb{P} \left(U_{n,2} \in \mathcal{B}_{U_{n,1}}^{\mathbb{G}_n}(K_n) \right) \\ & \leq \mathbb{P} \left(U_{n,2} \in \mathcal{B}_{U_{n,1}}^{F_{U_{n,1}}^{\mathbb{G}_n}(r_n)}(K_n) \right) + \mathbb{P} \left(\mathcal{B}_{U_{n,1}}^{F_{U_{n,1}}^{\mathbb{G}_n}(r_n)}(K_n) \neq \mathcal{B}_{U_{n,1}}^{\mathbb{G}_n}(K_n) \right) \\ & \leq \mathbb{P} \left(U_{n,2} \in F_{U_{n,1}}^{\mathbb{G}_n}(r_n) \right) + \mathbb{P} \left(\mathcal{B}_{U_{n,1}}^{F_{U_{n,1}}^{\mathbb{G}_n}(r_n)}(K_n) \neq \mathcal{B}_{U_{n,1}}^{\mathbb{G}_n}(K_n) \right) \\ & = \mathbb{P} \left(Y_{U_{n,2}}^{(n)} \in \mathcal{B}_{Y_{U_{n,1}}^{(n)}}^{r_n} \right) + \mathbb{P} \left(\mathcal{B}_{U_{n,1}}^{F_{U_{n,1}}^{\mathbb{G}_n}(r_n)}(K_n) \neq \mathcal{B}_{U_{n,1}}^{\mathbb{G}_n}(K_n) \right), \end{aligned} \tag{111}$$

where we recall the Euclidean graph neighborhoods $F_i^{\mathbb{G}_n}(r)$ from Definition 6.

Note that to conclude Theorem 3, it is sufficient to establish that the right-hand side of (111) tends to 0 as $n \rightarrow \infty$.

Via a simple conditioning on $Y_{U_{n,1}}^{(n)}$, and using that $Y_{U_{n,2}}^{(n)}$ is uniformly distributed on I_n and is independent of $Y_{U_{n,1}}^{(n)}$, we have

$$\mathbb{P} \left(Y_{U_{n,2}}^{(n)} \in \mathcal{B}_{Y_{U_{n,1}}^{(n)}}^{r_n} \right) \leq \frac{\lambda_d(\mathcal{B}_{\mathbf{0}}^{r_n})}{n}.$$

Furthermore (recalling $r(a, m, K)$ from (36)), note that using the upper bound

$$r(a_n, m, K_n) \leq K_n a_n^{m^{K_n}},$$

we have

$$\frac{\lambda_d(\mathcal{B}_{\mathbf{0}}^{r_n})}{n} \leq \frac{w r_n^d}{n} \leq \frac{w K_n^d n^{d\delta-1}}{n} \rightarrow 0,$$

as $n \rightarrow \infty$, by the choice of K_n as in (109), where $w > 1$ is some constant upper bound on $\lambda_d(\mathcal{B}_{\mathbf{0}}^1)$, and in the last inequality we have used (110). So the first term on the right-hand side of (111) tends to 0 as $n \rightarrow \infty$, and it remains for us to show that

$$\mathbb{P} \left(\mathcal{B}_{U_n}^{F_{U_n}^{\mathbb{G}_n}(r_n)}(K_n) \neq \mathcal{B}_{U_n}^{\mathbb{G}_n}(K_n) \right) \rightarrow 0, \tag{112}$$

as $n \rightarrow \infty$, where U_n is uniformly distributed on $V(\mathbb{G}_n) = [n]$.

We now recall the general estimate from Remark 9:

$$\begin{aligned} & \mathbb{P} \left(\mathcal{B}_{U_n}^{F_{U_n}^{\mathbb{G}_n}(r_n)}(K_n) \neq \mathcal{B}_{U_n}^{\mathbb{G}_n}(K_n) \right) \\ & \leq \sum_{j=1}^{K_n} \int_{\mathcal{B}_{\mathbf{0}}^{a_n^j}} \cdots \int_{\mathcal{B}_{\mathbf{0}}^{a_n^{j-1}}} \int_{\mathbb{R}^d \setminus \mathcal{B}_{\mathbf{0}}^{a_n^j}} \mathbb{E} \left[\kappa_n(\|z_j\|, W_{U_{n,1}}^{(n)}, W_{U_{n,2}}^{(n)}) \right] dz_j \cdots dz_1, \end{aligned} \tag{113}$$

where $a = a_n$ is as in (108), m is as in (107), $K = K_n$ is as in (109), $r_n = r(a_n, m, K_n)$ is as in (36), and $U'_{n,1}, U'_{n,2}$ are two independent uniformly distributed random variables on $[n]$.

Using (113) and Assumption 3(3), taking $h_n: \mathbb{R}^2 \rightarrow \mathbb{R}$ in (8) as being equal to $h_n(s, t) = \kappa_n(\|z_j\|, s, t, \cdot)$, we note that for n sufficiently large so that $a_n^m > t_0$ and

$$\mathbb{E} \left[\kappa_n(\|z_j\|, W_{U'_{n,1}}^{(n)}, W_{U'_{n,2}}^{(n)}) \right] \leq \|z_j\|^{-\alpha},$$

we have

$$\begin{aligned} \mathbb{P} \left(B_{U_n}^{F_{U_n}^{G_n}(r_n)}(K_n) \neq B_{U_n}^{G_n}(K_n) \right) &\leq \sum_{j=1}^{K_n} \int_{\mathcal{B}_0^{a_n^m}} \cdots \int_{\mathcal{B}_0^{a_n^{m^{j-1}}}} \int_{\mathbb{R}^d \setminus \mathcal{B}_0^{a_n^m}} \frac{1}{\|z_j\|^\alpha} dz_j \cdots dz_1. \\ &= \sum_{j=1}^{K_n} \frac{w^j}{a_n^{d\left(\frac{\alpha}{d}-1-\frac{1}{m}-\cdots-\frac{1}{m^{j-1}}\right)}}, \end{aligned} \tag{114}$$

where $w > 1$ is some constant upper bound on $\lambda_d(\mathcal{B}_0^1)$.

Since $\frac{\alpha}{d} > \frac{m}{m-1}$, and if we let $C_0 = d \left(\frac{\alpha}{d} - \frac{m}{m-1} \right) > 0$, it follows from (114) that for all n large enough so that $\frac{w}{a_n^{C_0}} < 1$, and for some $J > 1$ sufficiently large so that for all $j > J$ we have $j^{1/j} < m$ (note that such a J exists since $m > 1$), we can write (assuming n is large so that $K_n > J + 1$)

$$\mathbb{P} \left(B_{U_n}^{F_{U_n}^{G_n}(r_n)}(K_n) \neq B_{U_n}^{G_n}(K_n) \right) \leq \sum_{j=1}^{K_n} \frac{w^j}{a_n^{C_0 m^j}} = \sum_{j=1}^J \frac{w^j}{a_n^{C_0 m^j}} + \sum_{j=J+1}^{K_n} \frac{w^j}{a_n^{C_0 m^j}}. \tag{115}$$

Note that the first term on the right-hand side of (115) clearly converges to 0 as $n \rightarrow \infty$ since $a_n \rightarrow \infty$. For the second term on the right-hand side of (115), we note that since for all $j \geq J + 1, m^j > j$, and since $\frac{w}{a_n^{C_0}} < 1$, we have

$$\sum_{j=J+1}^{K_n} \frac{w^j}{a_n^{C_0 m^j}} \leq \sum_{j=J+1}^{K_n} \frac{w^{m^j}}{a_n^{C_0 m^j}} \leq \sum_{j=J+1}^{K_n} \left(\frac{w}{a_n^{C_0}} \right)^j \leq \sum_{j=1}^{\infty} \left(\frac{w}{a_n^{C_0}} \right)^j = \frac{w}{a_n^{C_0}} \frac{1}{1 - \frac{w}{a_n^{C_0}}} \rightarrow 0,$$

as $n \rightarrow \infty$. This implies (112), completing the proof of Theorem 3. □

3.7. Proofs of results on examples

Proof of Lemma 1. We write

$$\begin{aligned} &\mathbb{E} \left[\kappa(t, W^{(1)}, W^{(2)}) \right] \\ &= \mathbb{E} \left[1 \wedge f(t)g(W^{(1)}, W^{(2)}) \right] \\ &= \mathbb{P} \left(g(W^{(1)}, W^{(2)}) > 1/f(t) \right) + f(t)\mathbb{E} \left[g(W^{(1)}W^{(2)}) \mathbb{1}_{\{g(W^{(1)}W^{(2)}) < 1/f(t)\}} \right]. \end{aligned} \tag{116}$$

Let us define

$$Y = g(W^{(1)}, W^{(2)}) \mathbb{1}_{\{g(W^{(1)}W^{(2)}) < 1/f(t)\}}.$$

Note that since Y is a non-negative random variable, $\mathbb{E}[Y] = \int_0^\infty \mathbb{P}(Y \geq l) dl$. We note that

$$\mathbb{P}(Y \geq l) \leq \begin{cases} 0 & \text{if } l > 1/f(t), \\ \mathbb{P}(g(W^{(1)}, W^{(2)}) > l) & \text{if } l \leq 1/f(t). \end{cases} \tag{117}$$

Hence,

$$\begin{aligned} \mathbb{E}\left[g(W^{(1)}W^{(2)})\mathbb{1}_{\{g(W^{(1)}, W^{(2)}) < 1/f(t)\}}\right] &= \mathbb{E}[Y] = \int_{\mathbb{R}_+} \mathbb{P}(Y \geq l) dl \\ &\leq \int_0^{1/f(t)} \mathbb{P}(g(W^{(1)}W^{(2)}) > l) dl. \end{aligned} \tag{118}$$

Recall t_1 and t_2 from Assumption 4. Let

$$\bar{t}_1 := \inf\{t' > 0 : t > t' \implies f(t)^{-1} > t_2\}.$$

Note from Assumption 4(2) that, since $f(t)^{-1}$ increases to ∞ as $t \rightarrow \infty$, \bar{t}_1 is well defined.

Let

$$t_0 := \max\{\bar{t}_1, t_1\}.$$

Then for any $t > t_0$, we bound

$$\begin{aligned} \int_0^{1/f(t)} \mathbb{P}(g(W^{(1)}W^{(2)}) > l) dl &\leq t_2 + \int_{t_2}^{f(t)^{-1}} l^{-\beta_p} dl \\ &= t_2 + \frac{1}{1-\beta_p} \left(f(t)^{\beta_p-1} - t_2^{1-\beta_p} \right). \end{aligned}$$

Hence, from (116), for $t > t_0$ we have

$$\begin{aligned} \mathbb{E}\left[\kappa(t, W^{(1)}, W^{(2)})\right] &\leq f(t)^{\beta_p} + t_2 f(t) + \frac{1}{1-\beta_p} \left(f(t)^{\beta_p} - t_2^{1-\beta_p} f(t) \right) \\ &\leq t^{-\alpha_p \beta_p} + t_2 t^{-\alpha_p} + \frac{1}{1-\beta_p} \left(t^{-\alpha_p \beta_p} - t_2^{1-\beta_p} t^{-\alpha_p} \right). \end{aligned} \tag{119}$$

Since, for any $\epsilon > 0$, the right-hand side of (119) is dominated by $t^{-\min\{\alpha_p, \alpha_p \beta_p\} + \epsilon}$ outside a compact set (depending on ϵ), we are done. \square

Proof of Corollary 2. We will rely upon Corollary 1 and Remark 4 to conclude the proof.

Note that by definition, $\text{GIRG}_{n, \alpha_G, \beta_G, d}$ is the SIRG $G(\mathbf{X}^{(n)}, \mathbf{W}^{(n)}, \kappa_n^{\alpha_G})$, where the locations $(\mathbf{X}^{(n)})_{i \in [n]}$ satisfy Assumption 1, the weights $(\mathbf{W}_i^{(n)})_{i \in [n]}$ satisfy Assumption 2, and $\kappa_n^{\alpha_G} : \mathbb{R}_+ \times \mathbb{R} \times \mathbb{R} \rightarrow [0, 1]$ is defined as

$$\kappa_n^{\alpha_G}(t, x, y) := \begin{cases} 1 \wedge \left(\frac{xy}{\sum_{i \in [n]} W_i^{(n)}} \right)^{\alpha_G} \frac{1}{t^{\alpha_G}} & \text{if } 1 < \alpha_G < \infty, \\ \mathbb{1} \left\{ \left(\frac{xy}{\sum_{i \in [n]} W_i^{(n)}} \right)^{1/d} > t \right\} & \text{if } \alpha_G = \infty. \end{cases} \tag{120}$$

It is not very difficult to check that $\kappa_n^{\alpha_G}$ satisfies Assumption 3(1) with limiting connection function κ^{α_G} as defined in (14); hence we only need to check Assumption 4 for $\kappa^{(\alpha_G)}$ to directly apply Corollary 1.

Case 1: $\alpha_G < \infty$. Note that for the $\alpha < \infty$ case, κ^{α_G} is a PSIRG connection function with $g(x, y) = \left(\frac{xy}{\mathbb{E}[W]}\right)^{\alpha_G}$, and $f(t) = t^{-d\alpha_G}$.

Since W has a power-law tail with exponent $\beta_G - 1$, using Breiman’s lemma [26, Lemma 1.4.3], for any $\epsilon > 0$, the tail $\mathbb{P}(W_1 W_2 > t)$ of the product of two i.i.d. copies W_1 and W_2 of W is dominated from above by a regularly varying function with exponent $\beta_G - 1 - \epsilon$ for all sufficiently large t . Hence if we choose $\epsilon > 0$ sufficiently small so that $\beta_G - 1 - \epsilon > 1$, then $g(x, y)$ satisfies Assumption 4(3) with $\beta_p = (\beta_G - 1 - \epsilon)/\alpha_G$. Also, clearly $f(t)$ satisfies Assumption 4(2) with $\alpha_p = d\alpha_G$. Hence in this case $\gamma_p = \min\{\alpha_p, \alpha_p \beta_p\} = \min\{d\alpha_G, d(\beta_G - 1 - \epsilon)\} > d$, since both $\alpha_G, (\beta_G - 1 - \epsilon) > 1$. So we can conclude the result in this case using Corollary 1.

Case 2: $\alpha_G = \infty$. Fix $\gamma > d$. When $\alpha_G = \infty$, we note from (14) that the function $\kappa^{(\infty)}(t, x, y)$ can be bounded from above as

$$\kappa^{(\infty)}(t, x, y) = \mathbb{1}\left\{\left(\frac{xy}{\mathbb{E}[W]}\right)^{\gamma/d} > t^\gamma\right\} \leq 1 \wedge \frac{\left(\frac{xy}{\mathbb{E}[W]}\right)^{\gamma/d}}{t^\gamma} =: h(t, x, y).$$

Clearly $h(t, x, y)$ is a PSIRG connection function with $f(t) = \frac{1}{t^\gamma}$ satisfying Assumption 4(2) with $\alpha_p = \gamma$, and $g(x, y) = \left(\frac{xy}{\mathbb{E}[W]}\right)^{\gamma/d}$ satisfies Assumption 4(3) with $\beta_p = d(\beta_G - 1 - \epsilon)/\gamma$, for $\epsilon > 0$ sufficiently small so that $\beta_G - 1 - \epsilon > 1$, again by Breiman’s lemma [26, Lemma 1.4.3]. Since in this case also we have $\gamma_p = \min\{\alpha_p, \alpha_p \beta_p\} = \min\{\gamma, d(\beta_G - 1 - \epsilon)\} > d$, we can conclude the proof using Remark 4. □

Proof of Corollary 3. We first transform the hyperbolic random graph models into 1-dimensional SIRGs with appropriate parameters. To do this, we follow the proof of [24, Theorem 9.6]. Recall respectively, from Section 2.1.3, the radial component vector $(r_i^{(n)})_{i=1}^n$ and the angular component vector $(\theta_i^{(n)})_{i=1}^n$ of the vertices $(u_i^{(n)})_{i=1}^n$ of the THRG and PHRG models. Consider the transformations

$$X_i^{(n)} = \mathcal{X}(\theta_i^{(n)}) := \frac{\theta_i^{(n)}}{2\pi}, \quad W_i^{(n)} = \mathcal{W}(r_i^{(n)}) := \exp \frac{R_n - r_i^{(n)}}{2}. \tag{121}$$

Clearly, $(X_i^{(n)})_{i=1}^n$ is then a vector with i.i.d. coordinates on $[-1/2, 1/2]$, and using (16), it can be shown the i.i.d. components of the vector $(W_i^{(n)})_{i=1}^n$ have a power-law distribution with parameter $2\alpha_H + 1$ when $\alpha_H > 1/2$ (see [24, (9.8)] and the text following it).

Recall the connection functions $p_{\text{THRG}}^{(n)}$ and $p_{\text{PHRG}}^{(n)}$ from (17) and (18) respectively. The hyperbolic distance $d_{\mathbb{H}}(u_i^{(n)}, u_j^{(n)})$ between $u_i^{(n)} = (r_i^{(n)}, \theta_i^{(n)})$ and $u_j^{(n)} = (r_j^{(n)}, \theta_j^{(n)})$ depends on the angular coordinates $\theta_i^{(n)}$ and $\theta_j^{(n)}$ through $\cos(\theta_i^{(n)} - \theta_j^{(n)})$ (see [24, (9.1)]). Hence, it can be seen as a function of $|\theta_i^{(n)} - \theta_j^{(n)}|$, since $\cos(\cdot)$ is symmetric. Consequently, there exist functions \bar{p}_{THRG} and \bar{p}_{PHRG} such that

$$\begin{aligned} p_{\text{THRG}}^{(n)}(u_i^{(n)}, u_j^{(n)}) &= \bar{p}_{\text{THRG}}^{(n)}(|\theta_i^{(n)} - \theta_j^{(n)}|, r_i^{(n)}, r_j^{(n)}), \\ p_{\text{PHRG}}^{(n)}(u_i^{(n)}, u_j^{(n)}) &= \bar{p}_{\text{PHRG}}^{(n)}(|\theta_i^{(n)} - \theta_j^{(n)}|, r_i^{(n)}, r_j^{(n)}). \end{aligned} \tag{122}$$

Write

$$\begin{aligned} \kappa_{\text{THRG},n}(t, x, y) &= \bar{p}_{\text{THRG}}^{(n)}(2\pi t, g_n(x), g_n(y)), \\ \kappa_{\text{PHRG},n}(t, x, y) &= \bar{p}_{\text{PHRG}}^{(n)}(2\pi t, g_n(x), g_n(y)), \end{aligned} \tag{123}$$

where the function g_n satisfies

$$g_n(x) = R_n - 2 \log(x).$$

It was shown in [24, (9.17)] and [24, (9.16)] respectively that for fixed (t, x, y) as $n \rightarrow \infty$,

$$\begin{aligned} \kappa_{\text{THRG},n}(t, x, y) &= \bar{p}_{\text{THRG}}^{(n)}(2\pi t, g_n(x), g_n(y)) \rightarrow \kappa_{\text{THRG},\infty}(t, x, y), \\ \kappa_{\text{PHRG},n}(t, x, y) &= \bar{p}_{\text{PHRG}}^{(n)}(2\pi t, g_n(x), g_n(y)) \rightarrow \kappa_{\text{PHRG},\infty}(t, x, y), \end{aligned}$$

where

$$\kappa_{\text{THRG},\infty}(t, x, y) := \mathbb{1}_{\{t \leq \frac{\nu xy}{\pi}\}}, \quad \kappa_{\text{PHRG},\infty}(t, x, y) := \left(1 + \left(\frac{\pi t}{\nu xy}\right)^{1/T_H}\right)^{-1}. \tag{124}$$

In particular, the THRG and PHRG models can be seen as finite 1-dimensional SIRGs, where the vertex locations $(X_i^{(n)})_{i=1}^n$ satisfy Assumption 1, the vertex weights $(W_i^{(n)})_{i=1}^n$ satisfy Assumption 2 with the function $F_W(x)$ being a power-law distribution function with exponent $2\alpha_H + 1$, and where the connection functions are as in (123), converging pointwise to limiting connection functions as in (124). The pointwise convergence can in fact be improved to the case where one has sequences $x_n \rightarrow x, y_n \rightarrow y$ as in Assumption 3(1). This is because the error terms are uniformly bounded (see [24, (9.15)]), which implies $\kappa_{\text{THRG},n}(t, x_n, y_n) \rightarrow \kappa_{\text{THRG},\infty}(t, x, y)$ and $\kappa_{\text{PHRG},n}(t, x_n, y_n) \rightarrow \kappa_{\text{PHRG},\infty}(t, x, y)$, with t avoiding a set of measure zero for the THRG case, namely the set $\{\frac{\nu xy}{\pi}\}$. Thus, the sequences of connection functions $\kappa_{\text{THRG},n}$ and $\kappa_{\text{PHRG},n}$ satisfy Assumption 3(1) with limiting connection functions (124).

Finally, we need to check that the limiting connection functions $\kappa_{\text{THRG},\infty}$ and $\kappa_{\text{PHRG},\infty}$ satisfy Assumption 3(2) with some $\alpha > d$. For this, we use Corollary 1 and Remark 4.

Case 1: THRG. Let $\gamma > 1$ be any constant. Note that the function $\kappa_{\text{THRG},\infty}$ can be bounded from above as

$$\kappa_{\text{THRG},\infty}(t, x, y) \leq 1 \wedge \frac{\left(\frac{\nu xy}{\pi}\right)^\gamma}{t^\gamma}.$$

Note that this is a PSIRG connection function with $f(t) = \frac{1}{t^\gamma}$ satisfying Assumption 4(1) with $\alpha_p = \gamma$, and $g(x, y) = \left(\frac{\nu xy}{\pi}\right)^\gamma$. In addition, from (121) it follows that the limiting weights are i.i.d. and have a power-law distribution with exponent $2\alpha_H + 1$. Hence, by Breiman’s lemma [26, Lemma 1.4.3], if $W^{(1)}$ and $W^{(2)}$ are i.i.d. copies of the limiting weight distribution, then $g(W^{(1)}, W^{(2)})$ is regularly varying with exponent $2\alpha_H/\gamma$. Applying Potter’s bounds, we conclude that $g(W_1, W_2)$ satisfies Assumption 4(2) with $\beta_p = (2\alpha_H - \epsilon)/\gamma$, for $\epsilon > 0$ sufficiently small so that $2\alpha_H - \epsilon > 1$.

Since in this case we have $\gamma_p = \min\{\alpha_p, \alpha_p \beta_p\} = \min\{\gamma, (2\alpha_H - \epsilon)\} > 1$, we can conclude the proof using Corollary 1 and Remark 4.

Case 2: **PHRG**. The function $\kappa_{\text{PHRG},\infty}$ can be bounded from above as

$$\kappa_{\text{PHRG},\infty}(t, x, y) \leq C_1 \left(1 \wedge a_1 \left(\frac{xy}{t} \right)^{1/T_H} \right), \tag{125}$$

for some constants $C_1, a_1 > 0$. To see this, combine [24, (9.14)], [24, (9.16)], and Assumption 3(1). Using the fact that $\kappa_{\text{PHRG},\infty}(t, x, y)$ is a probability, and hence ≤ 1 , we can further get an upper bound from (125) as

$$\kappa_{\text{PHRG},\infty}(t, x, y) \leq 1 \wedge C_1 a_1 \left(\frac{xy}{t} \right)^{1/T_H}.$$

Note that this is a PSIRG connection function, with $f(t) = \frac{C_1 a_1}{t^{1/T_H}}$ and $g(x, y) = (xy)^{1/T_H}$. Recall from the statement of Corollary 3 that $0 < T_H < 1$. Note that $f(t)$ then satisfies Assumption 4(1) with $\alpha_p = 1/(T_H - \epsilon_1)$, for some $\epsilon_1 > 0$ sufficiently small so that $1/T_H - \epsilon_1 > 1$. Also note that from (121), the limiting weights are i.i.d. and have a power-law distribution with exponent $2\alpha_H + 1$. So if we let $W^{(1)}$ and $W^{(2)}$ be i.i.d. copies of the limiting weight distribution, then by Breiman’s lemma [26, Lemma 1.4.3], $g(W^{(1)}, W^{(2)})$ is regularly varying with exponent $2\alpha_H T_H$. Hence, applying Potter’s bounds, we note that $g(W^{(1)}, W^{(2)})$ satisfies Assumption 4(2) with $\beta_p = (2\alpha_H - \epsilon_2)T_H$, for some $\epsilon_2 > 0$ sufficiently small so that $2\alpha_H - \epsilon_2 > 1$. Since in this case also we have $\gamma_p = \min\{\alpha_p, \alpha_p \beta_p\} = \min\{1/(T_H - \epsilon_1), (2\alpha_H - \epsilon_2)T_H/(T_H - \epsilon_1)\} > 1$, we can conclude the proof using Corollary 1 and Remark 4. \square

Proof of Corollary 4. We apply Corollary 1, using Remark 4. Note that Assumptions 1 and 2 are immediate. Since Assumption 3(1) is immediate for κ_n with limit κ , we only need to check that κ is dominated by a PSIRG connection function which satisfies Assumption 4.

We use the easy bound

$$1 - \exp\left(-\frac{\lambda xy}{t^\alpha}\right) \leq 1 \wedge \frac{\lambda xy}{t^\alpha}$$

to observe that the limiting connection function κ is dominated by the PSIRG connection function $1 \wedge f(t)g(x, y)$, where $f(t) = 1/t^\alpha$ and $g(x, y) = \lambda xy$.

Note that for i.i.d. copies W_1 and W_2 of the weight distribution W as in (19), for any $\epsilon > 0$, the tail $\mathbb{P}(g(W_1, W_2) > t)$ of the random variable $g(W_1, W_2)$ is dominated by a regularly varying function with exponent $\beta - \epsilon > 0$ by Breiman’s lemma [26, Lemma 1.4.3], which implies that g satisfies Assumption 4(2) with $\beta_p = \beta - \epsilon$. Also, clearly f satisfies Assumption 4(1) with $\alpha_p = \alpha$. For $\epsilon > 0$ sufficiently small so that $\beta - \epsilon > 1$, since we have $\gamma_p = \min\{\alpha_p \beta_p, \alpha_p\} = \min\{\alpha(\beta - \epsilon), \alpha\} > d$, the proof of Corollary 4 is complete using Remark 4 and Corollary 1. \square

3.8. Proofs of degree results

Proof of Proposition 1. We argue by showing that the moment generating function converges to the moment generating function of the claimed limit. Also, we write interchangeably the vertex set $V(\mathbb{G}_\infty)$ and $\mathbb{N} \cup \{0\}$. In particular, the set of all vertices of \mathbb{G}_∞ other than 0 is \mathbb{N} .

Note that we have to show that for all $t \in \mathbb{R}$,

$$\mathbb{E} \left[e^{tD} \mid W_0 \right] \stackrel{\text{a.s.}}{=} \exp \left((e^t - 1) \int_{\mathbb{R}^d} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz \right). \tag{126}$$

Recall that $E(\mathbb{G}_\infty)$ is the edge set of \mathbb{G}_∞ . For any $r > 0$, we define $D_{\leq r}$ as

$$D_{\leq r} := \sum_{i \in \mathbb{N}} \mathbb{1}_{\{(0,i) \in E(\mathbb{G}_\infty)\}} \mathbb{1}_{\{\|Y_i\| \leq r\}}. \tag{127}$$

Clearly, $D_{\leq r}$ increases to D as $r \rightarrow \infty$. So, applying conditional monotone convergence when $t \geq 0$ and conditional dominated convergence when $t < 0$, for any $t \in \mathbb{R}$ we have

$$\lim_{r \rightarrow \infty} \mathbb{E} [e^{tD_{\leq r}} \mid W_0] \stackrel{\text{a.s.}}{=} \mathbb{E} [e^{tD} \mid W_0]. \tag{128}$$

Let $\mathcal{B}_0^r = \{y \in \mathbb{R}^d : \|y\| < r\}$ denote the open Euclidean ball of radius r in \mathbb{R}^d , centered at $\mathbf{0}$. Let Q_r be a Poi $(\lambda_d(\mathcal{B}_0^r))$ random variable, and conditionally on Q_r , make the following definitions:

- a. Let $\{\mathcal{R}_i\}_{i=1}^{Q_r}$ be a collection of Q_r i.i.d. uniform random variables on \mathcal{B}_0^r .
- b. Let $\{\mathcal{U}_i\}_{i=1}^{Q_r}$ be a collection of Q_r i.i.d. uniform random variables on $[0, 1]$.
- c. Let $\{W^{(i)}\}_{i=1}^{Q_r}$ be Q_r i.i.d. copies of W_0 , independent of $\{\mathcal{R}_i\}_{i=1}^{Q_r}$, $\{\mathcal{U}_i\}_{i=1}^{Q_r}$, and W_0 .

Note then that

$$e^{tD_{\leq r}} \mid W_0 \stackrel{d}{=} \prod_{i=1}^{Q_r} \exp \left(t \mathbb{1}_{\{\mathcal{U}_i \leq \kappa(\|\mathcal{R}_i\|, W_0, W^{(i)})\}} \right) \mid W_0, \tag{129}$$

and observe that the product on the right-hand side of (129) is, conditionally on W_0 , a product of (conditionally) independent random variables.

We compute that

$$\begin{aligned} & \mathbb{E} \left[\exp \left(t \mathbb{1}_{\{\mathcal{U}_i \leq \kappa(\|\mathcal{R}_i\|, W_0, W^{(i)})\}} \right) \mid W_0, W^{(i)}, \mathcal{R}_i \right] \\ & \stackrel{\text{a.s.}}{=} 1 - \kappa(\|\mathcal{R}_i\|, W_0, W^{(i)}) + e^t \kappa(\|\mathcal{R}_i\|, W_0, W^{(i)}), \end{aligned} \tag{130}$$

so that

$$\begin{aligned} & \mathbb{E} \left[\exp \left(t \mathbb{1}_{\{\mathcal{U}_i \leq \kappa(\|\mathcal{R}_i\|, W_0, W^{(i)})\}} \right) \mid W_0 \right] \\ & \stackrel{\text{a.s.}}{=} 1 - \frac{1}{\lambda_d(\mathcal{B}_0^r)} \int_{\mathcal{B}_0^r} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(i)}) \mid W_0 \right] dz \\ & \quad + e^t \frac{1}{\lambda_d(\mathcal{B}_0^r)} \int_{\mathcal{B}_0^r} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(i)}) \mid W_0 \right] dz \\ & \stackrel{\text{a.s.}}{=} (e^t - 1) \frac{1}{\lambda_d(\mathcal{B}_0^r)} \int_{\mathcal{B}_0^r} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz + 1. \end{aligned} \tag{131}$$

Hence, by (129),

$$\begin{aligned} & \mathbb{E} [e^{tD_{\leq r}} \mid W_0] \\ & \stackrel{\text{a.s.}}{=} \mathbb{E} \left[\left((e^t - 1) \frac{1}{\lambda_d(\mathcal{B}_0^r)} \int_{\mathcal{B}_0^r} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz + 1 \right)^{Q_r} \mid W_0 \right] \\ & \stackrel{\text{a.s.}}{=} \exp \left((e^t - 1) \int_{\mathcal{B}_0^r} \mathbb{E} \left[\kappa(\|z\|, W_0, W^{(1)}) \mid W_0 \right] dz \right), \end{aligned} \tag{132}$$

since Q_r has a Poisson distribution with parameter $\lambda_d(\mathcal{B}_0^r)$. Now, we let $r \rightarrow \infty$ on both sides of (132) and use (128) to establish (126), which concludes the proof of Proposition 1. \square

Proof of Proposition 2. Recall that D_n is the degree of the uniformly chosen vertex U_n of \mathbb{G}_n . Fix $\varepsilon > 0$, and note that the target is to show that there exist $M_0, N \in \mathbb{N}$ such that for all $M > M_0$ and $n > N = N(M_0)$,

$$\mathbb{E} [D_n \mathbb{1}_{\{D_n > M\}}] < \varepsilon. \tag{133}$$

For any $r > 0$, we can write

$$D_n = D_{n, < r} + D_{n, \geq r}, \tag{134}$$

where (recall that $E(\mathbb{G}_n)$ is the edge set of \mathbb{G}_n)

$$D_{n, < r} := \sum_{j \in [n]} \mathbb{1}_{\{j, U_n \in E(\mathbb{G}_n), \|Y_{U_n}^{(n)} - Y_j^{(n)}\| < r\}}, \tag{135}$$

$$D_{n, \geq r} := \sum_{j \in [n]} \mathbb{1}_{\{j, U_n \in E(\mathbb{G}_n), \|Y_{U_n}^{(n)} - Y_j^{(n)}\| \geq r\}}. \tag{136}$$

By applying the case $j = 1$ of (34), it is not hard to see that we can choose and fix $r_0 = r_0(\varepsilon) > 0$ and $n_0 \in \mathbb{N}$ such that, whenever $r \geq r_0$ and $n > n_0$,

$$\mathbb{E} [D_{n, \geq r}] \leq \varepsilon/4. \tag{137}$$

Splitting depending on whether $D_{n, < r_0}$ or $D_{n, \geq r_0}$ is larger, we obtain

$$\begin{aligned} \mathbb{E} [D_n \mathbb{1}_{\{D_n > M\}}] &\leq \mathbb{E} \left[D_n \mathbb{1}_{\{D_n > M\}} (\mathbb{1}_{\{D_{n, < r_0} \leq D_{n, \geq r_0}\}} + \mathbb{1}_{\{D_{n, < r_0} > D_{n, \geq r_0}\}}) \right] \\ &\leq 2\mathbb{E} \left[D_{n, \geq r_0} \mathbb{1}_{\{D_{n, \geq r_0} > M/2\}} \right] + 2\mathbb{E} \left[D_{n, < r_0} \mathbb{1}_{\{D_{n, < r_0} > M/2\}} \right] \\ &\leq \varepsilon/2 + 2\mathbb{E} \left[D_{n, < r_0} \mathbb{1}_{\{D_{n, < r_0} > M/2\}} \right], \end{aligned} \tag{138}$$

where in the last step we have used (137).

Now observe that $D_{n, < r_0}$ is stochastically dominated by Y_n , where Y_n is a $\text{Bin} \left(n - 1, \frac{\lambda_d(\mathcal{B}_0^{r_0})}{n} \right)$ random variable, so that $(Y_n)_{n \geq 1}$ is uniformly integrable. Hence, there exist $M_0 \in \mathbb{N}$ and $n_1 = n_1(M_0) \in \mathbb{N}$ such that, whenever $M > M_0$ and $n > n_1$, we have

$$2\mathbb{E} \left[D_{n, < r_0} \mathbb{1}_{\{D_{n, < r_0} > M/2\}} \right] < \varepsilon/2. \tag{139}$$

Hence, using (139) and (138), we note that (133) holds for $M > M_0$ and $n > N = \max\{n_1(M_0), n_0\}$. \square

3.9. Proofs of clustering results

Proof of Corollary 6. Parts 2 and 3 follow directly from using Theorem 2 with [22, Theorem 2.22] and [22, Exercise 2.31], respectively.

For Part 1, using [22, Theorem 2.21], we only have to verify the uniform integrability of $(D_n^2)_{n \geq 1}$ and the fact that $\mathbb{P}(D > 1) > 0$, where, as before, D_n is the degree of the uniformly chosen vertex U_n of \mathbb{G}_n , and D is the degree of 0 in \mathbb{G}_∞ . By Proposition 1, $\mathbb{P}(D > 1) > 0$ is trivial (we do not focus on the pathological case where $\int_{\mathbb{R}^d} \mathbb{E} [\kappa(\|z\|, W_0, W^{(1)}) | W_0] dz = 0$,

in which case it is not hard to see that \mathbb{G}_n is an empty graph). So we need only verify that $\alpha > 2d$ (where α is as in Assumption 3(3)) implies the uniform integrability of the sequence $(D_n^2)_{n \geq 1}$.

Fix $\varepsilon > 0$. We want to show there exist $M_0 \in \mathbb{N}$ and $N = N(M_0) \in \mathbb{N}$ such that whenever $M > M_0$ and $n > N$,

$$\mathbb{E} \left[D_n^2 \mathbb{1}_{\{D_n^2 > M\}} \right] < \varepsilon. \tag{140}$$

Recall the decomposition (134). Note that

$$\begin{aligned} D_{n, \geq r}^2 &= 2 \sum_{i, j \in [n], i < j} \mathbb{1}_{\{\{U_n, i\} \in E(\mathbb{G}_\infty), \|Y_{U_n}^{(n)} - Y_i^{(n)}\| \geq r\}} \mathbb{1}_{\{\{U_n, j\} \in E(\mathbb{G}_\infty), \|Y_{U_n}^{(n)} - Y_j^{(n)}\| \geq r\}} \\ &\quad + \sum_{i=1}^n \mathbb{1}_{\{\{U_n, i\} \in E(\mathbb{G}_\infty), \|Y_{U_n}^{(n)} - Y_i^{(n)}\| \geq r\}}. \end{aligned} \tag{141}$$

Taking expectations on both sides of (141), and after applying a routine change of variables, we get the bound

$$\begin{aligned} &\mathbb{E} \left[D_{n, \geq r}^2 \right] \\ &\leq \int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \mathbb{E} \left[\kappa_n \left(\|x\|, W_{U_{n,1}}^{(n)}, W_{U_{n,2}}^{(n)} \right) \kappa_n \left(\|y\|, W_{U_{n,1}}^{(n)}, W_{U_{n,3}}^{(n)} \right) \right] dx dy \\ &\quad + \int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \mathbb{E} \left[\kappa_n \left(\|z\|, W_{U_{n,1}}^{(n)}, W_{U_{n,2}}^{(n)} \right) \right] dz, \end{aligned}$$

where $U_{n,1}, U_{n,2}, U_{n,3}$ are i.i.d. uniformly distributed random variables on $[n]$; recall that $(W_i^{(n)})_{i \in [n]}$ is the weight sequence corresponding to the random graph \mathbb{G}_n .

Applying the Cauchy–Schwarz inequality on the integrand of the first term, and noting that $\kappa_n \leq 1$, we have the bound

$$\begin{aligned} &\mathbb{E} \left[D_{n, \geq r}^2 \right] \\ &\leq \left(\int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \mathbb{E} \left[\kappa_n \left(\|x\|, W_{U_{n,1}}^{(n)}, W_{U_{n,2}}^{(n)} \right) \right]^{1/2} dx \right) \\ &\quad \times \left(\int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \mathbb{E} \left[\kappa_n \left(\|y\|, W_{U_{n,1}}^{(n)}, W_{U_{n,3}}^{(n)} \right) \right]^{1/2} dy \right) \\ &\quad + \int_{\mathbb{R}^d \setminus \mathcal{B}_0^r} \mathbb{E} \left[\kappa_n \left(\|z\|, W_{U_{n,1}}^{(n)}, W_{U_{n,2}}^{(n)} \right) \right] dz. \end{aligned} \tag{142}$$

Since $\alpha > 2d$, we can choose and fix $r_0 = r_0(\varepsilon) > 0$ such that there exists $n_0 = n_0(r_0) \in \mathbb{N}$ such that, whenever $n > n_0$, by (142),

$$\mathbb{E} \left[D_{n, \geq r_0}^2 \right] < \varepsilon/8. \tag{143}$$

Hence, by splitting according to which of $D_{n,<r_0}$ and $D_{n,\geq r_0}$ is larger, we have

$$\begin{aligned} & \mathbb{E} \left[D_n^2 \mathbb{1}_{\{D_n^2 > M\}} \right] \\ &= \mathbb{E} \left[D_n^2 \mathbb{1}_{\{D_n^2 > M\}} \left(\mathbb{1}_{\{D_{n,<r_0} > D_{n,\geq r_0}\}} + \mathbb{1}_{\{D_{n,<r_0} \leq D_{n,\geq r_0}\}} \right) \right] \\ &\leq \mathbb{E} \left[4D_{n,<r_0}^2 \mathbb{1}_{\{4D_{n,<r_0}^2 > M\}} \right] + 4\mathbb{E} \left[D_{n,\geq r_0}^2 \right] \\ &\leq \mathbb{E} \left[4D_{n,<r_0}^2 \mathbb{1}_{\{4D_{n,<r_0}^2 > M\}} \right] + \varepsilon/2. \end{aligned} \tag{144}$$

As argued previously in the proof of Proposition 2, $D_{n,<r_0}$ is stochastically dominated by a $\text{Bin} \left(n-1, \frac{\lambda_d(\mathcal{B}_{\mathbf{0}}^{r_0})}{n} \right)$ -distributed random variable. Hence, by standard arguments, the sequence $(4D_{n,<r_0}^2)_{n \geq 1}$ is uniformly integrable. Hence there exist $M_0 \in \mathbb{N}$ and $n_1 = n_1(M_0) \in \mathbb{N}$ such that, whenever $M > M_0$ and $n > n_1$, the first term on the right-hand side of (144) is smaller than $\varepsilon/2$. We conclude that (140) holds whenever $M > M_0$ and $n > N(M_0) = \max\{n_0, n_1\}$. This finishes the proof of Part 1. \square
