# Sugar and Slavery in Puerto Rico

THE PLANTATION ECONOMY OF PONCE, 1800-1850

*Francisco A. Scarano*

This important new study of Ponce, a major sugar-producing district in Puerto Rico, examines in detail the processes by which a predominantly peasant economy and society was transformed into a plantation system. Francisco A. Scarano's work, one of the first full investigations into Puerto Rico's nineteenth-century economic history, dispels the long-held belief that slavery was an inconsequential factor in this society; indeed, he finds that the new plantation system was fully dependent on African slave labor and that the initial stimuli for economic change came from immigrants. *Sugar and Slavery in Puerto Rico* will be of particular interest and value to scholars studying slavery, plantation societies, the social and economic history of the Caribbean region, and Puerto Rican history, society, and culture.

Among Mexico's indigenous population, the Yaqui Indians of Sonora have most successfully repelled threats to their identity, land, and community. Interested in explaining how the relatively small "nation" withstood four centuries of contact with white culture, Evelyn Hu-DeHart focuses here on the Indians' response to shifting environmental pressures in the period 1820 to 1910, an increasingly violent, and ultimately decisive, chapter of their history. The resulting study, a companion to Hu-DeHart's earlier account of Yaqui history in the colonial era, constitutes the first comprehensive treatment of the nineteenth-century Yaqui and a major contribution to Mexican history.

## NOTES ON THE CONTRIBUTORS

**DON S. RICE** is Associate Professor of Anthropology at the University of Chicago. His research interests include Latin American prehistory and ethnohistory as well as human utilization of tropical environments. He has conducted archaeological and ecological analyses of aboriginal settlement areas in Yucatán, Mexico, in the central Petén of Guatemala, and in southern Peru.

**PRUDENCE M. RICE** is Associate Professor of Anthropology at the University of Florida. Her research interests, which include analyses of pottery and obsidian artifacts and the study of craft production, are being pursued through field and laboratory work on material from Guatemala, Belize, and Florida.

**ROBERT A. PASTOR** is on the faculty of the School of Public Affairs at the University of Maryland, College Park. He was the senior staff member in charge of Latin American and Caribbean Affairs at the National Security Council from 1977 to 1981 and has written widely on the Caribbean Basin and U.S. foreign policy.

**JAMES M. WALLACE** is Associate Professor of Anthropology at North Carolina State University and a fellow of the North Carolina Japan Center. He has studied at the University of Ayacucho and taught at the Catholic University in Lima on various occasions.

**MARIANNE SCHMINK** is Assistant Professor of Latin American Studies at the University of Florida, where she has directed the Amazon Research and Training Program since 1980. For the past two years, she has served as comanager of a Population Council/USAID project in Peru, Mexico, and Jamaica entitled "Women, Low-Income Households, and Urban Services in Latin America and the Caribbean."

**FORREST D. COLBURN** is Assistant Professor of Political Science at Florida International University and Book Review Editor for the *Caribbean Review*. He is completing a book on postrevolutionary Nicaragua.

GEORGE R. MCMURRAY is Professor of Spanish at Colorado State University. He has published articles on contemporary Spanish American fiction in addition to monographs on Gabriel García Márquez, José Donoso, and Jorge Luis Borges.

CHERYL E. MARTIN is Assistant Professor of History at the University of Texas at El Paso. Her forthcoming book, *Rural Society in Colonial Morelos*, will be published by the University of New Mexico Press.
