Bradley Richard is a lecturer in philosophy in the Department of Philosophy, Logic and Scientific Method at the London School of Economics. He works mainly in decision theory and on conditionals and hypothetical reasoning, but is interested in all branches of the philosophy of economics and, more generally, in the normative and conceptual foundations of social theory.

Bradie Michael is a Professor of Philosophy at Bowling Green State University.
