Communism in Korea

Robert A. Scalapino and Chong-Sik Lee

Communism in Korea is the first in-depth study of the origins and evolution of Korean Communism. It is also the first book to combine two basic approaches in its treatment of a Communist movement: an historical, developmental treatment and a topical, social science-oriented analysis.

A basic thesis of the authors holds that in analysing the Communist movement whether in Korea or in comparable societies—either independently or in a comparative manner—it is necessary to consider three critical variables: Communism, emergence, and tradition. Their use of both historical and social science methods enables them to treat each of these forces definitively. They devote much attention also to comparisons of Korean developments with those in the major Communist states with which North Korea has been in most intimate contact, as well as with those in emerging states operating under non-Communist systems.

The Classical Law of India

Robert Lingat

Translated from the French by J. Duncan M. Derrett

Before the publication in 1967 of the original French edition of M. Lingat's book (*Les sources du droit dans le système traditionnel de l'Inde*), there existed no reliable appraisal of the significance of the *Dharmāstra*, or 'science of righteousness', the indigenous jurisprudence of India. Until then, doubts concerning its objectivity, as well as over-estimates of its practical applicability, had vitiated the many historical and sociological studies that took account of it. M. Lingat's lucid and penetrating analysis represents a fresh start. By bringing a series of commanding perspectives into new and sharp focus, he clarifies for the first time the mutual relationships existing among the 'sacred law', custom, and royal decree. M. Lingat, recently associated with the Centre for Indian Studies at the University of Paris and an eminent student of South and Southeast Asian law, has written authoritative commentaries on contrasts and conflicts between Asian and Western legal ideas. J. Duncan M. Derrett is Professor of Oriental Law at the School of Oriental and African Studies in the University of London.
