

Divisions and Discussion Groups

Division Executive Committees

MLA divisions encompass the primary scholarly and professional concerns of the association, with each of the eighty-six divisions representing a major area of membership interest. Since membership in divisions is maintained as part of all members' records for the purpose of sending them special-interest materials, joining a division indicates an active involvement in the field and a desire to promote its scholarly and professional concerns. Membership in one division does not, of course, exclude a member from attending any or all meetings arranged by other divisions at the MLA Annual Convention.

Members who wish to join a division or change membership from one division to another may do so by writing to the member and customer services office at the MLA office. It is, however, most convenient to make changes and additions when paying one's annual dues (the dues notice accommodates such changes).
