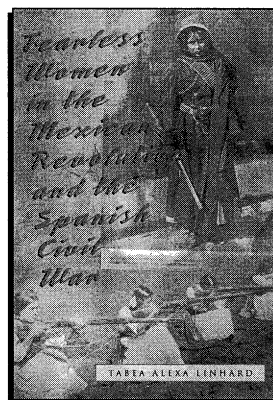


Fearless Women in the Mexican Revolution and the Spanish Civil War

Linhard maintains a focus on these women's stories, and she addresses several existing gaps in studies of the intersections of gender, revolution, and culture in both the Mexican and the Spanish contexts.

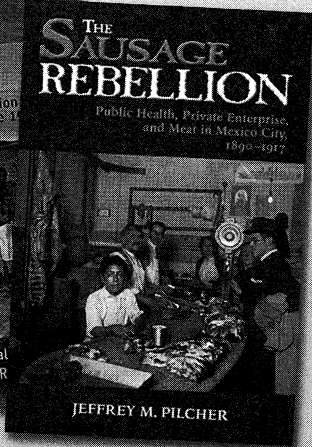
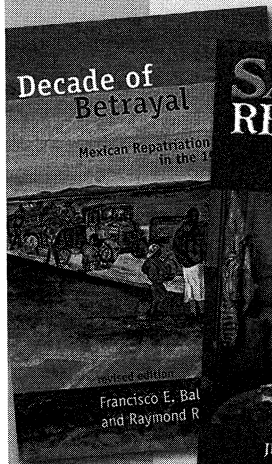
