**James A. Anderson** is associate professor of history at the University of North Carolina at Greensboro. A historian of premodern China and Vietnam, Anderson is author of *The Rebel Den of Nùng Trí Cao: Loyalty and Identity Along the Sino-Vietnamese Frontier* (2007). He is coeditor with Nola Cooke and Li Tana of *The Tongking Gulf Through History* (2011).

**David C. Kang** is professor of international relations and business at the University of Southern California, where he also directs the Korean Studies Institute and the East Asian Studies Center. His latest book is *East Asia Before the West: Five Centuries of Trade and Tribute* (2010).

**Kirk W. Larsen** is associate professor of history at Brigham Young University. He received his PhD in history from Harvard University. He has previously taught at the University of Texas–Austin and George Washington University. At GWU he served as director of the International Affairs Program and the Sigur Center for Asian Studies. His publications include *Tradition, Treaties, and Trade: Qing Imperialism and Chosŏn Korea, 1850–1910* (2008). He has published, presented, and commented on a variety of contemporary issues including North Korea, nationalism and elections in South Korea, and Sino-Korean relations.

**Ji-Young Lee** is assistant professor at the School of International Service, American University. Her research focuses on East Asian security and diplomatic history, and international relations theory.

**Seo-Hyun Park** is assistant professor in the Department of Government and Law at Lafayette College. Her research interests include national identity politics, military alliances, and globalization and security. She is currently working on a book project on conceptualizations of state sovereignty in the context of enduring patterns of hierarchical security relationships in East Asia. Park received her PhD from Cornell University and was a research fellow at the Center for

International Security and Cooperation (CISAC) and the Shorenstein Asia-Pacific Research Center (APARC) at Stanford University.

**Kenneth R. Robinson** is Special Visiting Scholar at Northeast Asian History Foundation in Seoul and Research Fellow at the Institute of Asian Cultural Studies, International Christian University in Tokyo. His research focuses on Korean foreign relations in the early Chosŏn period (1392–1600). He has published in the *Journal of Asian Studies*, *Korean Studies*, the *Journal of Korean Studies*, and other journals in English, Korean, and Japanese, and in edited volumes published in the United States, South Korea, and Japan.

**Yuan-kang Wang** is associate professor in the Department of Sociology at Western Michigan University. He holds a PhD in political science from the University of Chicago, was an international security fellow at Harvard University's Belfer Center for Science and International Affairs, and was a visiting fellow at the Brookings Institution's Center for Northeast Asian Policy Studies. Wang specializes in international relations, East Asian security, Taiwan, and Chinese foreign policy, and he has published a variety of articles related to these topics. He is author of *Harmony and War: Confucian Culture and Chinese Power Politics* (2011).
