THE SEVENTY-FOURTH GENERAL MEETING

30 July - 2 August 2019

The seventy-fourth General Meeting of the Society took place at the Philipps Universität Marburg, Germany, during 30 July-2 August, under the presidency of Prof. John Kloppenborg (Canada). There were about 260 participants, of which 221 were members. The chairs of the Local Organising Committee were Profs. Lukas Bormann and Angela Standhartinger. On the first evening, the Society was welcomed at a reception in the Alte Aula of the University.

The Academic Programme

The President delivered his Presidential Address entitled 'Social Networks in Early Christianity' at the opening plenary session of the Society. Main Papers were presented by Profs. The Business Meetings

At the two Business Meetings of the Society, members formally elected Prof. Margaret Mitchell (USA) to the post of President for the 75th General Meeting in Rome, Italy in 2020 (until which time she assumes the office of President-Elect). The Committee intimated the nomination of Prof. John Barclay (UK) to the post of President at the 76th General Meeting in Melbourne, Australia in 2021. He becomes Presidential Nominee until the 2020 General Meeting in Rome, when his nomination will be put to the vote by the Society.

Profs. Uta Poplutz (Germany) and Risto Uro (Finland) retired from the Committee at the conclusion of the General Meeting in Marburg. Profs. Sandra Huebenthal (Germany) and Heike Omerzu (Denmark) were elected as replacements and will serve on the Committee for a period of three years. In addition, Prof. Gosnell Yorke (Zambia) was elected to serve on the Committee until the end of the General Meeting in 2021.

The Society received the Treasurer's Report and formally accepted the statement of accounts as presented by the Treasurer, Prof. Paul Foster (UK). Members were reminded that the collection of membership fees was being processed electronically by CUP. Members were encouraged to register and make payments online.

The Assistant Secretary for International Initiatives, Prof. William R. G. Loader (Australia), reported on the work of the various liaison committees (the Eastern European Liaison Committee, the African Liaison Committee, the Asia Pacific Liaison Committee and the Latin America Caribbean Liaison Committee). One innovation at this General Meeting was for nine members and guests from Nigeria, Ghana, Lesoto, India, the Czech Republic, Bulgaria, Serbia and Romania to display research posters. The main goals of the international initiatives of the Society remain to promote the scholarly study of the New Testament in all parts of the world, to expand the Society's footprint internationally, and to increase its membership in regions where it is underrepresented. Important elements of this international work include authorising funding to provide sponsorships to assist members and approved guests from the Liaison Committees' regions to participate in the General Meeting, and to assist with the running of an annual pre-conference.

The Editor of New Testament Studies, Dr Simon Gathercole (UK), reported that 111 articles had been submitted to the Journal over the past year. Twenty of these had been accepted for publication. Peter Arzt-Grabner (Austria), Helen Bond (UK), Hugh Houghton (UK), Konrad Huber (Germany), James Kelhoffer (Sweden), Candida Moss (UK) and Joseph Verheyden (Belgium) were due to retire from the Board at the end of 2019. To replace these members, the Editorial Board nominated, and the Society elected, pending appointment by the Press, the following members to serve in their place, for the period January 2020 - December 2022: Nathan Eubank (USA), Mark Goodacre (USA), Holger Strutwolf (Germany), Matthew Thiessen (Canada), Gregor Wurst (Germany) and Christiane Zimmermann (Germany).

The Editor of the Monograph Series, Prof. Edward Adams (UK), reported that three monographs had been published since the previous General Meeting, four volumes were in production, and one further project had been placed under contract.

The Society received with regret news of the deaths of the following: Profs. Following extensive review, feedback and discussion over the last three years, Prof. John Kloppenborg (Past President) reported that the Committee is implementing a number of changes to its practices. From the Rome 2020 General Meeting, the frequency of an individual attending as a personal guest is being increased to three times within a five-year period, which can be repeated. This will be reviewed by the Committee at regular intervals to ensure that it continues both to widen access, but still incentivise nominations for membership. Additionally, members will be allowed to invite up to two guests and are strongly encouraged to keep the Society's commitment to diversity in mind when doing so.

From the Melbourne 2021 General Meeting, there will be six Main Papers, instead of four. It is intended that this will broaden the range of contributors to the Academic Programme.

The Committee will also prepare a resolution regarding Associate Membership for the membership to consider at its meeting in Rome in 2020.

Social Events

On the Wednesday evening, there was an Organ Concert in the Elisabethkirche, with music from England, France and Germany; and on the Thursday evening, there was a Dinner at the Restaurant Dammühle. There were optional excursions on the Saturday to various places of cultural, historic and local interest.

Future General Meetings

The Society will hold its annual General Meeting in Rome, Italy in 2020, and in Melbourne, Australia in 2021.
