centrate on biochemical changes in the brain in seeking an underlying pathology for this, so far empirical, treatment.

Dr. Sullivan introduced Dr. Gilmartin, who gave a clinical demonstration of his technique. He used larger doses of curare than those suggested by Dr. Drury, and gave physostigmine as a routine procedure. The demonstration was smoothly and skilfully carried out, and showed clearly the extent to which a convulsion may be modified.

A general discussion followed, in which the following members took part: Drs. Dunne, Coyne, Thompson, H. J. Eustace, Glass, Conlon, McLaughlin, O'Brien, Fitzgerald, Moore, Sheridan, Hill and Andrews.

Dr. Drury, Dr. GILMARTIN and Dr. Sullivan replied to questions, and the discussion was closed.

Dr. McCarthy kindly invited the division to hold the summer meeting at Ballinasloe. The invitation was unanimously accepted, and it was decided to hold the meeting on Wednesday, 13 July, 1949. After some discussion it was decided to hold a golf competition on the morning of the meeting at Ballinasloe.

It was proposed by Dr. Dunne, seconded by Drs. McCarthy, Fitzgerald, Moran, Coyne and Moore, that Dr. Kearney be elected junior representative of the Council.

The meeting then adjourned.

Dr. D. Prentice then opened a discussion on the work of the Psychiatric Advisory Panel of the South-Western Region. He gave an account of the composition of the Panel and its functions.
