Faculty Fellowships in Ethics Available

The University Center for Ethics and the Professions offers Faculty Fellowships supporting outstanding teachers and scholars who wish to develop their ability to address questions of moral choice in such areas as business, education, government, law, medicine, and public policy. Fellows participate in a weekly seminar discussing problems of research and teaching in ethics. Fellows enjoy opportunites to participate in courses, colloquia, curricular development, collaborative research, study groups, casewriting workshops, and clinical programs. A significant part of their time is devoted to conducting their own research in ethics.

Jackson Papers Left to Morehouse College

Former Atlanta Mayor Maynard Jackson, who died June 23, left \$3,000 and his political writings to his alma mater, Morehouse College. The money is to be invested to help fund small scholarships for needy political science students with high academic standing who intend to pursue a career in politics. Jackson's political papers include letters, papers, and unpublished manuscripts. Jackson was Atlanta's first African-American mayor. He was mayor from 1974 to 1982 and from 1990 to 1994.

John Carter Brown Library Fellowships

The John Carter Brown Library will award approximately 25 short- and long-term Research Fellowships for the year June 1, 2004–July 31, 2005. Short-term fellowships are available for periods of two to four months and carry a stipend of \$1,400 a month. These fellowships are open to foreign nationals as well as to U.S. citizens who are engaged in pre- post-doctoral, or independent, research. Graduate students must have passed their preliminary or general examinations at the time of application and be at the dissertation-writing stage. Long-term fellowships, primarily funded by the National Endowment for the Humanities (NEH) and the Anderw W. Mellon Foundation, are typically for five to nine months and carry a stipend of \$3,500 per month. Recipients may not be engaged in graduate work and ordinarily must be U.S. citizens or have resided in the U.S. for the three years immediately preceding the application deadline.
