CONTRIBUTORS

IRIS BERGER is Professor of History, Africana Studies and Women's Studies at the University of Albany, State University of New York. She is also past Director of the Institute for Research on Women. Her research centers on the history of East and Southern Africa, with an emphasis on women and gender, labor, religion and popular culture. She is the author of *Threads of Solidarity: Women in South African Industry, 1900-1980* and *Religion and Resistance: East African Kingdoms in the Precolonial Period* and co-editor of *Women and Class in Africa*.

MR. THANDIKA MKANDAWIRE was, until last year, the Executive Secretary of CODESRIA (Council for the Development of Social Research in Africa). He did his undergraduate studies at Ohio State University and his graduate studies at the University of Stockholm where he taught for eight years. He has also taught at the University of Zimbabwe. His recent publications have been on the social sciences in Africa and on problems of structural adjustment and democratic transitions in Africa. He was awarded the Distinguished Fulbright Fellowship in 1996. He is currently a Senior Research Fellow at the Centre for Development Research in Copenhagen, Denmark.

JOSEPH R.A. AYEE (Ph.D.) is Head of the Department of Political Science, University of Ghana, Legon. He is the author of *An Anatomy of Public Policy Implementation: The Case of Decentralization Policies in Ghana*. Aldershot, Avebury, 1994. His latest article is on "The Measurement of Decentralization: The Ghanaian Experience, 1988-92," *African Affairs* 95/378: (1996), 31-50. His research interests are in development management and public policy issues.

TONY WATERS is Lecturer in the Department of Sociology and Social Work, California State University, Chico. He worked in refugee assistance programs in Tanzania from 1984-7 and 1994-6. He has published essays about development and ethnicity in *African Studies Review*, *Journal of Modern African Studies*, *Issue*, *International Migration Review*, and *Ethnic Groups*.
