

the South must “emphasize that a sustainable economic order is not possible unless the benefits of the global economic order are equitably distributed, the standard of living of the poorest is enhanced, and the processes by which the rules are made is fair and equitable” (p. 623).

What is quite exemplary about the book is that it combines several seemingly contradictory strands of IEL and exhibits a keenness for multidimensionality and inclusiveness. Yet it is disappointing that the volume was published in late 2015 and was not able to include analysis following the Paris climate agreement. Aside from this constraint of the publishing timeline, the book will be influential for years to come. The next installment, *International Natural Resources Law, Investment and Sustainability*, edited by Alam, Razzaque, and Jahid Hossain Bhuiyan, is forthcoming later this year. There, the editors will likely fill in the gaps and expand the discussion from Paris.
