PRESIDENT'S REPORT

This is my first report as President of the IALL as published during my second election term ending (2016–2019). It covers the period between the Oxford Conference of July/August 2016 and the days preceding the Atlanta conference of 2017.

THE BOARD

Since the 2016 International Association of Law Libraries Board Member-election, and from the 2016 Oxford Annual Course onwards till 2019, the Board of the International Association of Law Libraries consists of the following Officers:

BOARD MEETINGS

The Board met on Saturday July 30, 2016 in Oxford and on Friday August 5, 2016; annually returning items were discussed, as well as strategic issues, especially the New Constitution and the changes in the membership structure, the International Journal of Legal Information (IJLI), and the subscription-based model for IJLI for institutions.

Strategy Meeting: An additional Board Meeting fully dedicated to Strategy Issues took place in Montreal, Canada, on Wednesday and Thursday, February 22 and 23, 2017. Prior to the conference and afterwards, much Board communication and ordinary business happened through frequent email.

THE ANNUAL GENERAL MEETING IN 2016

The AGM was held on August 3, 2016. Scholarship and bursary recipients were announced. Regular reporting took place as well as recognition of our sponsors.

REPRESENTATION

I accepted an invitation to attend the Canadian Association of Law Libraries annual conference in May 2017, the Chinese & American Forum on Legal Information & Law Libraries in June 2017, and the American Association

of Law Libraries annual conference in Austin in July 2017. At all of these conferences I spoke about the International Association of Law Libraries, or canvassed for new IALL members and for attendance at IALL annual courses (and this year's course), such as at each group's business meeting, as well as at the "International Attendees Joint Reception" (at AALL).

IALL'S 35TH ANNUAL COURSE IN OXFORD, 2016

The 35th Annual Course took place from July 31 until August 3, 2016 in Keble College, Oxford. There were approximately 150 delegates and 25 vendors who took part in the 35th IALL Annual Course. At the post-conference Board Meeting, Ruth Bird, resigning from the Board, was elected as a Life Member of IALL by a unanimous vote of the Board.

THE PROPOSED 2017 ANNUAL COURSE IN MANILA, THE PHILIPPINES

The Board of the International Association of Law Libraries has decided to withdraw from Manila, the Philippines, as the venue for the 2017 Annual Course of the International Association of Law Libraries. The considerations for the proposal to withdraw can be summarized under the following headings: political circumstances in the Philippines, implications thereof for IALL, the image of IALL being endangered if preparations had continued, necessity of avoidance of signs of IALL-support for the regime and complicity of IALL, the freedom of speech at the conference possibly being jeopardized and democratic values not obviously guaranteed, and the safety of delegates.

THE 2017 ANNUAL COURSE IN ATLANTA, USA

The 2017 IALL Annual Course "Civil Rights, Human Rights, and Other Critical Issues in U.S. Law" will be held in Atlanta, Georgia, from October 22–25, 2017, with the Optional Day on Thursday, October 26, 2017, organized by the Hugh F. MacMillan Law Library at Emory University School of Law, which is also celebrating its centennial anniversary. The Local Planning Committee consists of:
