The *Consolidated Treaty Series* begins with the year 1648, the year of the Treaties of Muenster and Osnabrueck which established the European system of states. It terminates in 1918, when the *League of Nations Treaty Series* began.

It provides in every case the *original* text in the language in which the treaty was drawn up. Further, where this language was not either English or French, there is also provided either a contemporary translation into one of those languages or a summary in English of the main provisions of the treaty.

The *Consolidated Treaty Series* will also have a very real value to scholars and specialists concerned with contemporary problems. A treaty is not necessarily outmoded, or irrelevant to international relations because it was concluded long ago. It may still be operative in fact, whether as a root of title, or otherwise. In consequence it is important to know, not only what a treaty may have said, but between which parties it was concluded, when it came into force, whether it continues in force, how it may have been terminated and what are the facts of its continued relevance. Therefore, the essential original feature of this *Series* consists of annotations which provide the above information.

Both the collection and its annotations are the work of Dr. Clive Parry, the distinguished Cambridge University international legal scholar. Dr. Parry, the author of several books, is the compiler of the *Index of British Treaties 1101-1958*, the compiler and editor of *British International Law Cases* and the editor of the *British Digest of International Law*.

The *Consolidated Treaty Series* will extend to about one hundred volumes of approximately five hundred pages each. OCEANA PUBLICATIONS, Inc. intends to issue the first five volumes in mid-summer, 1969 and a second group of five volumes at the end of 1969. Together, these first ten volumes will cover the period 1648 to approximately 1693. The Publisher hopes to complete the entire *Series* in about seven years.

The order within the *Series* will be chronological. Omissions discovered as research proceeds, especially in unpublished national archives, will be introduced out of chronological order by way of addenda to the *Series*.

"The Committee of Ministers . . . recommends to the governments of member states to facilitate the preparation of this treaty series in particular by putting at the disposal of the Editor so far as possible the texts of treaties concluded by them and which are not otherwise available, and any translations in their possession of treaties drawn up in languages other than English and French."

Each volume will be printed on finely made acid-free paper and bound in high quality library buckram. All treaties are being reproduced from the best available sources to insure maximum legibility. In many instances, especially in the case of early documents, the larger page size of the *Series* will make the reproduction more readable than the original.

TERMS OF SALE

The *Consolidated Treaty Series* will be available only from the Publisher, Oceana Publications, Inc. The Publisher has established a pre-publication price of \$35.00 per volume for orders for the set placed prior to October 1, 1969. After October 1, 1969 the price will be \$37.50 per vol. and —after June 1, 1970—the price per vol. will be \$40.00.

PLEASE NOTE: The Publisher will absorb shipping charges for the entire set on orders received BEFORE AUGUST 1, 1969.
