deserving of their office's or committee's attention, and which issues will remain on the back burner.

In sum, the ability of interest groups to influence legislation in large part depends on relationships with staff. Because the

staffs buffer so much information flow to the member, and because staffs carry out the development of legislative language, much of legislative outcome can be credited to productive interactions between staff and interest groups. However, it is important to consider the staff in varying contexts of personal, committee, and leadership offices since their needs are different in each of these settings, creating varying opportunities for interest groups.
