The mathematics register is a section of the National Register of Scientific and Technical Personnel, which is an official responsibility of the National Science Foundation.

The main objective of the Register is to provide up-to-date information on the scientific manpower resources of the United States. It is also increasingly valuable to the scientific community as a source of statistical information.

At the request of the National Science Foundation, the American Mathematical Society mailed the 1970 reporting forms to its section in the National Register. It is hoped again to obtain the fine cooperation accorded the previous cycle of the Register by most of the mathematicians and mathematical scientists.

The need for a journal such as this has arisen because many important papers are now being written which are too long to be considered for prompt publication in the existing journals but which are too short to form an individual book. **Annals of Mathematical Logic** will be devoted primarily to these contributions. Papers not exceeding 100 printed pages on topics of current interest in **Mathematical Logic** and the **Foundations of Mathematics** may be submitted to any one of the editors. Papers devoted to topics in related fields—such as **Automata Theory, Mathematical Linguistics, etc.**—will also be considered provided that they contain material relevant to mathematical logic and the foundations of mathematics.

The Council of the Association for Symbolic Logic has decided to sponsor the publication of this journal. Two of the four Editors of the *Annals of Mathematical Logic* have been nominated by the President of the Association for Symbolic Logic, and the Council of this Association has passed a resolution in which it welcomes the publication of the *Annals* and agrees that they be published under the auspices of the Association.

The Editors will work in close contact with the Editors of the *Journal of Symbolic Logic* and of the series *Studies in Logic and the Foundations of Mathematics*.

A volume will consist of 500 pages.

## **A PROFILE OF MATHEMATICAL LOGIC**

The general aim of this book is to describe mathematical logic; its historical background, its nature and its philosophical implications. It is meant to appeal to anyone—students, mathematicians, linguists, computer specialists, philosophers, etc.—who would like a relatively brief and readable introduction.

The book presupposes no knowledge of logic and only high school mathematics. The emphasis throughout is on understanding, not technique. The last chapter advocates the author's position in explicating the philosophical implications of metatheory.

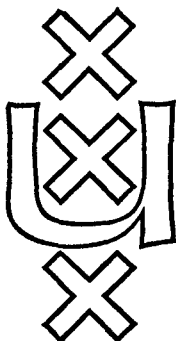

The Association assesses page charges at the rate of \$14.00 per page for all papers (excluding reviews) that appear in the JOURNAL. All bills for page charges will be submitted to the author's host institution or employing company, if any. Authors are not liable for the payment of page charges, nor for their acceptance and payment by employing organizations.

Attention is called to the fact that the JOURNAL invites submission of (1) original technical papers in the field of symbolic logic, (2) expository papers in this field, (3) philosophical papers which bear upon this field or make use of its methods, and (4) studies in the history of logic in which modern technical developments are taken into account.

## **LOGIC FOR UNDERGRADUATES, Third Edition**

Providing a penetrating and realistic treatment of the informal fallacies, this thoroughly revised edition of one of the best sellers in logic presents two complete chapters on fallacies near the *beginning* of the book rather than at the end. Too, this is the only book that integrates the study of judgment with critical thinking and the logic of making decisions. Featuring an extended and intensely practical study of the categorical syllogism, the text relates this topic to everyday argumentation and debate. The expanded chapter on induction more readily demonstrates—through models tested in class—the usefulness of induction for the problems of every-day life. The logic of implication is given a more simplified presentation, especially in the area of hypothetical syllogisms. A final chapter is provided on symbolic logic as a means of integrating the relationship between traditional and modern logic.
