NOOR O'NEILL BORBIEVA is assistant professor of anthropology at Indiana University—Purdue University Fort Wayne. In 2008, Borbieva was a visiting scholar at the Kellogg Institute, University of Notre Dame. She received her PhD in anthropology from Harvard University in 2007. Articles featuring her research in Central Asia have appeared in *Anthropological Quarterly*, *Culture and Religion*, and *Ethnology*. Borbieva is currently working on a new research project that explores interfaith activism in the United States.

MELISSA L. CALDWELL is professor of anthropology at the University of California, Santa Cruz, and the codirector of the University of California Multi-Campus Research Program on Studies of Food and the Body. Her research focuses on changing practices and experiences of intimacy and compassion in post-Soviet Russia, with special attention to poverty, social welfare, faith-based charities, and social justice. The author of *Not by Bread Alone: Social Support in the New Russia* (University of California Press, 2004) and *Dacha Idylls: Living Organically in Russia's Countryside* (University of California Press, 2011), Caldwell is also the editor of *Food and Everyday Life in the Postsocialist World* (Indiana University Press, 2009).

JULIE HEMMENT is associate professor in the department of anthropology at the University of Massachusetts, Amherst. Her research interests include gender and postsocialism, nongovernmental organizations (NGOs) and global civil society, social welfare, and citizenship. The author of *Empowering Women in Russia: Activism, Aid, and NGOs* (Indiana University Press, 2007), Hemment has also published in *Signs* and *Anthropological Quarterly*. Her current book project explores themes of youth, gender, and nationalism in postsocialist space by interrogating Russia's new state-run youth organizations.

RUTH MANDEL teaches at University College London; she was trained in anthropology at the University of Chicago. Her book, *Cosmopolitan Anxieties: Turkish Challenges to Citizenship and Belonging in Germany* (Duke, 2008), has been widely reviewed and won the 2009 Douglass Prize for the Best Book on the Anthropology of Europe. She is coeditor (with Caroline Humphrey) of *Markets and Moralities: Ethnographies of Postsocialism* (Berg, 2002). She is currently writing a book stemming from research in Kazakhstan on media and development. Mandel's awards and honors include Berlin Prize Fellow at the American Academy Berlin, Kennan Scholar at the Woodrow Wilson Center, as well as grants from Fulbright, the Social Science Research Council, the Deutscher Akademischer Austausch Dienst, the Economic and Social Research Council, and the Arts and Humanities Research Council.

CURTIS G. MURPHY is a doctoral candidate in Russian and east European history at Georgetown University. His dissertation, "Progress without *Slavic Review* 71, no. 2 (Summer 2012)

JEFF SAHADEO is associate professor at the Institute of European, Russian, and Eurasian Studies at Carleton University. The author of *Russian Colonial Society in Tashkent, 1865–1923*, Sahadeo is also coeditor (with Russell G. Zanca) of *Everyday Life in Central Asia, Past and Present* (both Indiana University Press, 2007). Sahadeo has published in *Slavic Review* and *Kritika: Explorations in Russian and Eurasian History*. Recent articles related to his current project have appeared in *Central Asian Survey*.
