
Notes on Contributors

Konstantinos Chatzis obtained his Ph.D. in social sciences from the École Nationale des Ponts et Chaussées. He is currently a senior researcher at Laboratoire Techniques, Territoires et Sociétés (Université Paris-Est and CNRS). His main research interests are the engineering profession, engineering education and engineering sciences in France and Greece in the nineteenth and twentieth centuries; the development of large urban socio-technical systems during that period; the rationalization process in French industry in the twentieth century; and comparative and transnational analysis in the field of engineering sciences and technology. He has contributed over eighty scientific publications. His recent publications include 'National Identities of Engineers', in a special issue of *History and Technology* (2007, guest editor with Y. Antoniou and M. Assimakopoulos); 'From Free Good to Commodity: Universalizing the Provision of Water in Paris (1830–1930)', *Geoforum* (2008, with D. Bocquet and A. Sander); *La Presse et les périodiques techniques en Europe, 1750–1950* (2008, co-editor, with P. Bret and L. Pérez); 'Coping with the Second Industrial Revolution: Fragmentation of the French Engineering Education System, 1870s to the present', *Engineering Studies* (2009). He is currently working on a biography of the French state engineer and economist Jules Dupuit (1804–66).

Aurélie Gfeller is a post-doctoral fellow of the Swiss National Science Foundation and holds a Ph.D. from Princeton University (2008). She is currently finishing a monograph on France's European policy at a critical juncture: the Yom Kippur War, the first oil crisis and the end of Gaullist rule. The book combines an examination of French policymaking within the context of EPC and the 1974 Paris summit with an analysis of political discourse. The author has also been awarded a post-doctoral fellowship for a research project on the European Parliament (EP) from the 1969 Hague summit to the 1986 Single European Act. The project explores the transformative powers of the EP, both its role in shaping the course of European integration and its impact on the norms and the values of its members. Her publications include 'Valéry Giscard d'Estaing et la relance européenne: nouvel éclairage sur la création du Conseil européen et les réformes institutionnelles du sommet de Paris (1974)', *Revue d'histoire diplomatique* (2009), and 'A Contested Identity: France and the Year of Europe, 1973–1974', in Ann-Christina Lauring Knudsen and Morten Rasmussen, eds., *The Road to a United Europe* (forthcoming).

Mark Gilbert is Associate Professor of Contemporary History at the University of Trento and Adjunct Professor of European Studies at the Johns Hopkins School of Advanced International Studies, Bologna. The author of *Surpassing Realism: The Politics of European Integration since 1945* (2003), he is working on a political history of Europe since the 1960s.

Georgia Mavrogonatou obtained her Ph.D. in social sciences from the National Technical University of Athens in 2009. Her main research interests are Greek engineers in the nineteenth and twentieth centuries and the development of large urban socio-technical systems in Greece. Her publications include 'Implanter les "Ponts et Chaussées" européens en Grèce: le rôle des ingénieurs du corps du Génie, 1830–1880', *Quaderns d'Història de l'Enginyeria* (forthcoming, 2010, with F. Assimacopoulou and K. Chatzis); 'Eaux de Paris, eaux d'Athènes, 1830–1930: histoires croisées d'un réseau urbain', *Almagest* (forthcoming, 2010, with K. Chatzis); 'Le génie civil français et les ponts en Grèce, 1880–1910', in M. Mille and G. Piernas, eds., *Ponts d'ici, ponts d'ailleurs: constructions, archives et memoires* (forthcoming, 2010, with K. Chatzis).

Mathieu Segers is Assistant Professor in European Integration at the Department of History and Art History, University of Utrecht. His research focuses on (the history of) European integration. His recently published work includes (with Femke van Esch) 'Behind the Veil of Budgetary Discipline', *Journal of Common Market Studies* (2007), and 'Zwischen Pax Americana und Pakt Atomica', *Vierteljahrshefte für Zeitgeschichte* (2006). As the editor of the European Diaries of Max Kohnstamm (personal adviser to Jean Monnet), he is currently working on a follow-up to the first part of the diaries (1953–7, 2008) which covers the years 1958–63 (forthcoming, 2010).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor John Connelly, jfconnel@berkeley.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
