“Under her leadership, *PS* has become a central organ of our profession, featuring spirited debates on the nature of our enterprise and substantively rich reports on scholarly findings,” Mann said.

Prior to coming to APSA in 1981, Rudder was chief of staff for then Rep. Wyche Fowler of Georgia. She is a former Congressional Fellow and was assistant professor at the University of Georgia from 1973 until 1977.

A Phi Beta Kappa graduate of Emory University, Rudder received her PhD from Ohio State University in 1973.

In addition to Huntington, the Search Committee was composed of Martha Derthick (University of Virginia), John Ferejohn (Stanford University), Helen Ingram (University of Arizona), Harold Jacobson (University of Michigan), and Michael Preston (University of Southern California). □

Ferejohn and Krasner To Head 1988 Program

Kenneth Waltz, president-elect of APSA, has appointed Stephen D. Krasner and John Ferejohn, both of Stanford University, to co-chair the Program Committee for the 1988 Annual Meeting. In addition, scholars have been named to head the 25 sections planned for next year's program. These nominations were approved by the Council at its April 24 meeting in Washington, D.C.

The Program Committee is composed of Ferejohn, Krasner and the section heads of the program. The 1988 meeting will be held in Washington, D.C. at the Washington Hilton from Thursday, September 1 to Sunday, September 4.

Joint Sessions with International Meeting

The XIVth World Congress of the International Political Science Association will be held in conjunction with the APSA meeting in Washington in 1988. The IPSA World Congress will convene on Sunday, August 28, and will conclude Thursday, September 1 at the Sheraton Washington in walking distance from the Washington Hilton.

APSA and the international association will hold a joint evening plenary session on Thursday, September 1, and will co-sponsor the book exhibit at the Washington Hilton from Tuesday, August 30 through Saturday, September 3.

How to Participate in the International Meeting

Proposals for participation in the XIVth World Congress of the International Political Science Association in Washington, DC are also cordially invited.

The theme of the congress will be "Toward a Global Political Science." Several sessions will be sponsored within the framework of Mini-Plenary Sections and Subfield Sections which will be organized by the Program Committee.

There will also be approximately 50 sessions that will be organized as Special Meetings.

Individuals who wish to organize Special Meetings or to participate as paper presenters, chairs, or discussants in sessions organized by the Program Committee should send proposals to the Chair of the Program Committee: Harold K. Jacobson, Center for Political Studies, Institute for Social Research, The University of Michigan, P.O. Box 1248, Ann Arbor, MI 48106, USA.

A copy of the proposal should also be sent to the IPSA secretariat: IPSA Secretariat, c/o University of Ottawa, Ottawa, Ontario K1N 6N5, Canada.

The initial deadline for the submission of proposals was March 1, 1987 and the final deadline is July 1, 1987. Proposals submitted before the initial deadline will receive priority consideration at the meeting of the Program Committee in April 1987. The proposals should be as specific as possible and should supply completed information including curriculum vitae for the individuals who will be involved.
