## Policy

*Phonology* is concerned with all aspects of phonology and related disciplines. Preference is given to papers which make a substantial theoretical contribution, irrespective of the particular theoretical framework employed, but the submission of papers presenting new empirical data of general theoretical interest is also encouraged. The editors also welcome squibs and shorter pieces that draw attention to a new dataset, explore a theoretical or methodological point or respond to a published article.

One of the issues of a volume is occasionally devoted to a particular theme. The editors welcome proposals for themes and offers to act as guest editors for thematic issues.

## Submission of papers

Submissions, in PDF format, should be sent to the editors at [submissions@phonology.uk](mailto:submissions@phonology.uk). An abstract (no longer than 150 words) should be included separately in the body of the e-mail. The author's name should not appear on the paper itself, and, as far as possible, should not be identifiable from references in the text.

A full set of notes for contributors can be found on the journal website. This should be consulted before submission of a paper.

The language of submission and publication is English.
