#### **Conclusions**

The British Library is more than just a store of historic manuscripts and books, but is a formidable resource which will support all aspects of research, whether they are business driven or academic. Collections are now even more accessible and relevant to users, regardless of their

subject, and if the library does not have them in their catalogues, there is a 99 percent possibility that they will be able to locate material.

## Government and European Union Legal News

Plans for CELEX to become a free of charge database are under way. The new service will be launched sometime later this year. The Office for Official Publications is planning to integrate PRELEX, the decision-making database and CELEX into one comprehensive free database. Integration may be difficult because of differences in data structure. The new service will be more current, publishing texts every day. Better access to legislation is also planned. The Office for Official Publications hopes to launch the service in three phases during 2004. Phase I, creation of the prototype ended in December 2003 with Phase 2 now in progress. The new service should enter production sometime after June 2004.

The Office for Official Publications will continue to provide value added services in order to compensate for revenue lost by CELEX.

The new EURLEX database is still in preparation but will be available on the Europa site. EURLEX once completed, is designed to give access to all national legislation resulting from the implementation of European Union Directives.
