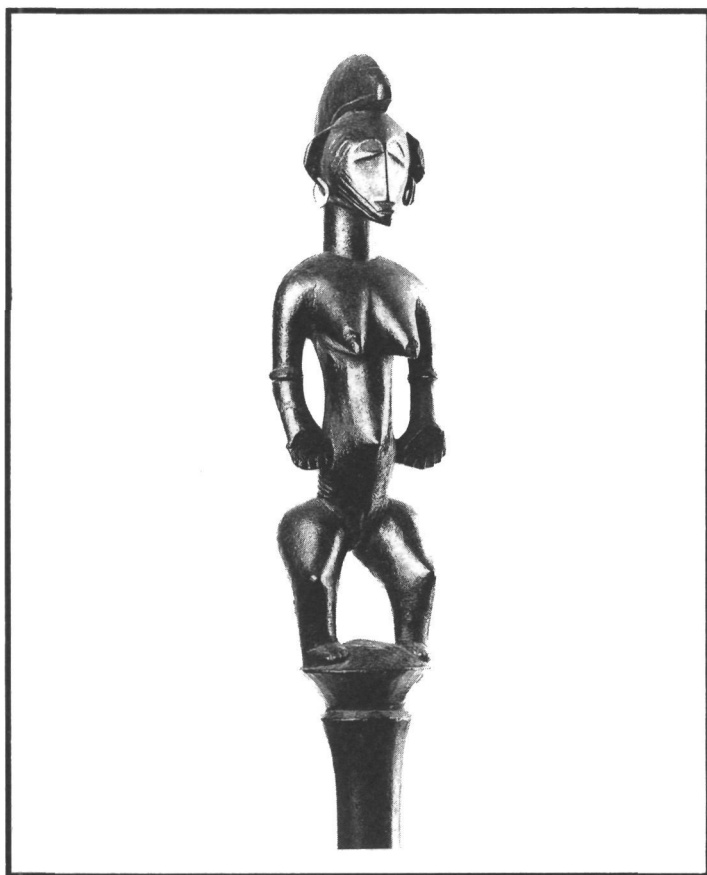

Manuscripts should conform to the latest edition of *A Manual of Style* (University of Chicago Press). List notes and references at the end of the article. Manuscripts will be submitted anonymously to readers; please include a removable cover page giving name and mailing address, fax number and e-mail address, if available; title should be on the first page of text. Avoid self-identification as author throughout article. Include a 250-word abstract, as well as a signed statement that the article has not been published and is not currently under consideration by other journals. ASR will only consider unpublished manuscripts.

CONTRIBUTORS

Edward A. Alpers specializes in the history of eastern Africa. He is Professor of History and Dean of Honors and Undergraduate Programs at the University of California, Los Angeles, and Past President of the African Studies Association.

Jeanne Maddox Toungara is Assistant Professor of History at Howard University. She lived in Côte d'Ivoire for fifteen years and taught at the Université Nationale de Côte d'Ivoire. She has published articles on Ivoirian political culture, women, and family law and is currently working on a study of Kabasarana, a nineteenth-century Malinké kingdom in Northwestern Côte d'Ivoire. He is also co-editor of the *International Journal of Comparative Sociology*.

Paul J. Kaiser is Assistant Professor in the Department of Political Science at Mississippi State University. His research focuses on the international and cultural dimensions of African politics and development and he is currently working on a project that explores Aga Khan social service initiatives in Tanzania in the theoretical context of state/civil society relations.

Stephen N. Ndegwa is Assistant Professor of Government at the College of William and Mary. He was previously Assistant Director of the African Studies Program at Indiana University, Bloomington, where he received his doctorate. His research interests include epistemological and pedagogical issues in African Studies, which have appeared in *Issue: A Journal of Opinion*. His research on NGOs and political change has appeared in the *International Journal of Comparative Sociology*. His current projects focus on civic education, development and state formation in Africa

Robert Fatton, Jr. is Professor and Associate Chair in the Woodrow Wilson Department of Government and Foreign Affairs at the University of Virginia. He has published numerous articles on African

politics and is the author of three books: *Black Consciousness in South Africa*; *The Making of a Liberal Democracy: Senegal's Passive Revolution*; and *Predatory Rule: State and Civil Society in Africa*.
