Robin Cubitt is Professor of Economics and Decision Research at the University of Nottingham. His research uses theoretical, experimental and conceptual methods to investigate the foundations of economics, decision theory and game theory. As well as journal articles in these fields, he is author (with five others) of *Experimental Economics: Re-thinking the Rules* (Princeton University Press, 2010).

Allan Gibbard is Richard B. Brandt Distinguished University Professor of Philosophy at the University of Michigan, Ann Arbor. His books include Wise Choices, Apt Feelings (1990) and Meaning and Normativity (2012), and he has written on theories of conditionals, identity, and social choice theory. He is Fellow of the American Academy of Arts and Sciences, Member of the American Philosophical Society, Fellow of the Econometric Society, and Member of the National Academy of Sciences.

Cyril Hédoin is Associate Professor of Economics at the University of Reims Champagne-Ardenne, France. He has recently published papers in the Erasmus Journal for Philosophy and Economics,, the Journal of Institutional Economics and in Philosophy of the Social Sciences. He is currently working on several topics relating microeconomics and ethics as well as on the development of a non-individualistic understanding of game theory.

Emily McTernan is a Lecturer in Political Philosophy at the Department of Political Science, University College London. Her research interests include responsibility-sensitive egalitarianism, the relevance of empirical research to political philosophy, and social norms.

Herlinde Pauer-Studer is Professor at the Department of Philosophy of the University of Vienna and PI of the ERC Advanced Research Grant 'Distortions of Normativity'. Her research interests are in metaethics, 536 Contributors

political philosophy and legal philosophy. Recent articles appeared in European Journal of Philosophy, Ethical Theory and Moral Practice and Jurisprudence. She is currently working on a monograph exploring the distortions in National Socialist jurisprudence.

Andrés Perea is an Associate Professor at Maastricht University. He has written two books: Rationality in Extensive Form Games (Kluwer Academic Publishers, 2001), and Epistemic Game Theory: Reasoning and Choice (Cambridge University Press, 2012). His research focuses mainly on epistemic game theory.

Nicholas Stern is IG Patel Professor of Economics and Government at London School of Economics, and Head of the India Observatory and Chairman of the Grantham Research Institute on Climate Change and the Environment. He is President of the British Academy (from July 2013). He has held previous posts at universities in the UK and abroad. He was Chief Economist at both the World Bank, 2000–2003, and the European Bank for Reconstruction and Development, 1994–1999. Lord Stern was Head of the UK Government Economic Service 2003–7, and produced the landmark Stern Review on the economics of climate change. He was knighted for services to economics in 2004 and made a cross-bench life peer as Baron Stern of Brentford in 2007. His most recent book is "A Blueprint for a Safer Planet".

Robert Sugden is Professor of Economics at the University of East Anglia, Norwich. His research uses a combination of theoretical, experimental and philosophical methods to investigate issues in welfare economics, social choice, choice under uncertainty, the foundations of decision and game theory, the methodology of economics, and the evolution of social conventions. His recent books include *The Economics of Rights, Cooperation and Welfare* (Palgrave Macmillan, second edition 2004) and, with five co-authors, *Experimental Economics: Re-thinking the Rules* (Princeton University Press, 2010).

John A. Weymark is the Gertrude Conaway Vanderbilt Professor of Economics and Professor of Philosophy at Vanderbilt University. His research interests include inequality measurement, optimal taxation, social choice, and welfare economics. He is a co-editor with Marc Fleurbaey and Maurice Salles of Justice, Political Liberalism, and Utilitarianism: Themes from Harsanyi and Rawls (Cambridge University Press, 2008) and Social Ethics and Normative Economics: Essays in Honour of Serge-Christophe Kolm (Springer, 2011). He is an Editor of Economics and Philosophy and a former Managing Editor of Social Choice and Welfare.
