This bibliography covers publications that appeared during the year 2000. It follows previous criteria, being divided into two broad areas: general literature in financial history in section 1, and specialised material in section 2. Section 2 is subdivided chronologically, and further by geographical area (the complete classification scheme was published in Volume 1, Part 2, October 1994, pp. 157–60, but in this 2000 edition the subdivision for Asia is extended). Where there are no entries for a particular section, the heading has been omitted. Abbreviations have been kept to a minimum, but standard abbreviations such as *J.* for *Journal*, *Q.* for *Quarterly*, *Rev.* for *Review/Revue*, have been used throughout. Short titles and cited titles (*cit.*), are used for references to edited volumes within the section in which they are listed, elsewhere they are cited in full. Doctoral theses and Working Papers are not included. Articles published in books ‘edited by’ are mentioned only if the bibliographer accessed the index of the book before the deadline of the publication. Where it was possible, a translation into English was maintained.
