Disability Income Now Available to APSA Members

A Disability Income plan with monthly benefits of \$1000, \$2000, or \$3000 is now available to members of the APSA.

All APSA members and their spouses/domestic partners are eligible (upon meeting certain requirements) for up to five full years of guaranteed income if disabled by a covered accident, and up to one full year if disabled by a covered illness. Benefits are payable in addition to income from other sources, up to 70% of the recipient's monthly salary.

Federalism and Intergovernmental Relations

The Distinguished Scholar Award recognizing distinguished scholarly contributions to the study of federalism and intergovernmental relations was presented to Paul E. Peterson of Harvard University. The Best Paper Award was conferred on Richard C. Elling and Lyke Thompson, Wayne State University, for "Let Them Eat Marblecake: Michigan Citizens' Preferences on Intergovernmental Structure." Conlan** of George Mason University for *New Federalism: Intergovernmental Reform and Political Change from Nixon to Reagan* (Brookings Institution, 1988).

Law and Courts

Gregory A. Caldeira, Ohio State University, **John R. Wright**, Ohio State University, and **Christopher Zorn**, Emory University, received the American Judicature Society Award conferred for the best paper on law and courts written by a faculty member and presented at the 1997 APSA Annual Meeting for "Sophisticated Judicial Behavior: Agenda Setting Via the Discuss List." The Congressional Quarterly Press Award for the best graduate student paper during 1997–8 was given to **Laura Langer**, Florida State University, for "State Supreme Courts and Countermajoritarian Behavior."

The C. Herman Pritchett Award for the best book on law and courts

written by a political scientist and published in 1997–8 was presented to **Lee Epstein** and **Jack Knight**, of Washington University, St. Louis, for *The Choices Justices Make* (Congressional Quarterly Press, 1998). Rounding out the Law and Courts awards, **Samuel Krislov** of the University of Minnesota was presented the Lifetime Achievement Award honoring his distinguished career of achievement and service in the field of law and courts.

Legislative Studies

The CQ Press Award for the best paper on legislative studies at the 1997 APSA Annual Meeting. The award was given to **Eric Lawrence** of Tulane University for "The Publication of Hinds' Precedents in 1899 and the Institutionalization of the House of Representatives."

Public Policy

The Aaron Wildavsky Enduring Contribution Award was presented to **Roger W. Cobb** of Brown University and **Charles D. Elder** of Wayne State University for *Participation in American Politics: The Dynamics of*

Agenda Building (Johns Hopkins University Press, 1983). The award is given annually for a book or article published in the last ten to twenty years that continues to influence the study of public policy.

Political Organizations and Parties

The Samuel J. Eldersveld Career Achievement Award, honoring a scholar whose lifetime professional work has made an outstanding contribution to the field, was presented to Nelson Polsby of the University of California, Berkeley. *Parties and Party Systems: A Framework for Analysis* (Cambridge University Press, 1976), a work by **Giovanni Sartori** of Columbia University won the Leon D. Epstein Outstanding Book Award honoring a book of outstanding and lasting significance in the field. The Jack Walker Outstanding Article Award honoring an article or published paper of unusual significance and importance to the field was presented to **Robert Salisbury**, Washington University, for "Interest Representation: The Dominance of Institutions." The Emerging Scholars Award for significant research by a scholar receiving his or her doctorate within the past five years was awarded to **Kenneth Kollman** of the University of Michigan and **Lonna Atkeson** of the University of New Mexico. An honorable mention was conferred on **David Farrell** of the University of Manchester and **John Gerring** of Boston University.

Public Administration

The Herbert Kaufman Award for the best paper on public administration presented at the 1997 APSA Annual Meeting was given to **Lael R. Keiser**, University of Missouri, Columbia, for her work, "State Bureaucratic Discretion and the Administration of Social Welfare Programs: The Incentive to Shift Costs to the Federal Government in the Granting of Disability Claims," and **Jeffrey L. Brudney**, University of Georgia, **F. Ted Hebert**, University of Utah, and **Deil S. Wright**, University of North Carolina, for "Rein-

venting Government in the American States: Measuring and Explaining Administrative Reform.”

Conflict Processes

The 1998 Best Book Award for the best book in the field of conflict processes was awarded to **Mark Irving Lichbach** of the University of California, Riverside for *The Rebel's Dilemma* (University of Michigan Press, 1995).

Representation and Electoral Systems

Richard S. Katz of Johns Hopkins University was presented the George H. Hallett Award for *A Theory of Parties and Electoral Systems* (Johns Hopkins University Press, 1980). The award is presented annually to the author of a book published at least ten years ago that has made a lasting contribution to the literature on representation and electoral systems. The Leon Weaver Award, given for the best paper presented at a panel sponsored by the Representation and Electoral Systems Division, was presented to **Micah Altman** of Harvard University for “Do Traditional Districting Principles Matter?”

Presidency Research

The Richard E. Neustadt Award, given for the best book published in 1997 that contributed to research and scholarship in the field of the American presidency, was presented to **Jeffrey E. Cohen** of the University of Kansas for *Presidential Responsiveness and Public Policy-Making: The Public and the Policies That Presidents Choose* (University of Michigan Press, 1997). **Bruce Buchanan** of the University of Texas, Austin was winner of the Founder's Award for the best paper presented at the 1997 APSA Annual Meeting for “Presidential Campaign Quality: What the Variance Implies.”

Political Methodology

The Harold Gosnell Award was awarded for the best work of politi-

cal methodology presented at a political science conference in 1997 to **Dean Lacy** from Ohio State University for “A Theory of Nonseparable Preferences in Survey Responses.” The Society for Political Methodology Poster Award for the best political methodology poster given at any political science conference during 1997 was given to **Adam Berinsky** of the University of Michigan for “The Two Faces of Public Opinion.”

Religion and Politics

The Aaron Wildavsky Award for the best dissertation on religion and politics was awarded to **Andrew R. Murphy** of the University of Wisconsin for “Conscience and Community: Revisiting Toleration and Dissent in Early Modern England and America.” The Best Paper Award for the best paper on religion and politics went to **Timothy B. Shah**, Harvard University, for “Making the World Safe for Liberalism: The Moralization of Christianity and the Roots of Liberal Public Reason in Hugo Gratius (1583–1645).”

Urban Politics

The Organized Section on Urban Politics presented two books awards in 1998, one for the best book published in 1996 and one for the best book in 1997. The 1996 Book Award went to **Roger Waldinger** of the University of California, Los Angeles for *Still the Promised City? African-Americans and New Immigrants in Postindustrial New York* (Harvard University Press, 1996). The winner of the 1997 Best Book Award on urban politics was *Morning Glories: Municipal Reform in the Southwest* (Princeton University Press, 1997), by **Amy Bridges**, University of California, San Diego. The Best Dissertation Award for the best dissertation on urban politics was presented to **Timothy Krebs**, University of North Carolina, Greensboro, for “The Politics of Chicago City Council Elections, 1979–1995.” The Norton Long Career Achievement Award was presented to **Dennis Judd**, University of Missouri, St. Louis in recognition of his profound

and lasting impact on the field of urban politics.

Science, Technology, and Environmental Politics

The Don K. Price Award for the best book on science, technology, and environmental politics published in the last three years was given to **Sheila Jasanoff** of Harvard University for *Science at the Bar: Law, Science, and Technology in America* (Harvard University Press, 1995).

Women and Politics

The Best Paper Award for the best paper in the field of women and politics research at the 1997 APSA Annual Meeting was awarded to **Gretchen Rittea**, University of Texas, Austin for “Regendering Citizenship after the Second World War.”

Foundations of Political Theory

The David Easton Award, recognizing a book that broadens the horizons of contemporary political science by engaging issues of philosophical significance in political life through any of a variety of approaches in the social sciences and humanities, was awarded to **Robert D. Putnam** of Harvard University for *Making Democracy Work* (Princeton University Press, 1993). **James Wood Bailey** of Princeton University was named winner of the First Book Award for *Utilitarianism, Institutions, and Justice* (Oxford University Press, 1997). The First Book Award recognizes the best first book published in 1997 by a scholar in the early stages of his or her career in the area of political theory/philosophy. The Best Paper Award for the best paper on foundations of political theory went to **Kennan Ferguson**, University of Hawaii, for “Communities of Meaning: Toward a Kantian Non-Universal Judgment.”

Computers and Multimedia

The Best Instructional Software Award, recognizing a work that enhances the teaching of political sci-

ence through the use of technology, was presented to **David Smetters** of MicroCase Corporation for *Explort*, a software package for elementary data analysis in American government. **D. Scott Bennett**, Pennsylvania State University and **Allan C. Stam**, Yale University were awarded the Best Research Software Award, for EUGene (Expected Utility Generation and data management program) a program for scholars engaged in quantitative international relations research. The award recognizes a work that contributes to the furtherance of research in the field as well as improvement of research.

Comparative Politics

The Gregory Luebbert Award for the best professional article in comparative politics was presented to **Adam Przeworski** of New York University and **Fernando Limongi** of the University of Sao Paulo, Brazil, for "Modernization: Theories and Facts" (*World Politics*, January 1997). The Sage Prize for the best comparative politics paper presented at the 1997 APSA Annual Meeting went to Joel S. Hellman of the European Bank for Reconstruction and Development for "Winners Take All: The Politics, of Partial Reform." **Gary W. Cox** of the University of California, San Diego was winner of the 1998 Gregory Luebbert Prize, awarded for the best book in comparative politics, for *Making Votes Count: Strategic Coordination in the World's Electoral Systems* (Cambridge University Press, 1997).

State Politics and Policy

The Best Paper Award was given to **William Berry**, Florida State University, **Richard Fording**, University of Kentucky, and **Russell Hanson**, Indiana University, for "Reassessing the 'Race to the Bottom' Thesis: A

Spatial Dependence Model of State Welfare Policy." The award recognizes the best paper on state politics given at the 1997 APSA Annual Meeting.

Political Communication

The Doris Graber Award, given for the best paper on political communication presented at the 1997 APSA Annual Meeting, was presented to **Marion R. Just**, Wellesley College, and **Ann N. Crigler**, University of Southern California, for "Emotional Interactions With the Campaign: A Constructionalist Approach to Campaign Effects." The Murray Edelman Distinguished Career Award for lifetime contribution to the study of political communication was given to **Shanto Iyengar** of the University of California, Los Angeles.

Politics and History

The **J. David Greenstone Book Prize** for the best book in history and politics in the past two calendar years was given to two outstanding books, *Civic Ideals: Conflicting Visions of Citizenship in U.S. History* (Yale University Press, 1997) by **Rogers M. Smith** of Yale University and *Making the Fascist Self: The Political Culture of Interwar History* (Cornell University Press, 1997) by **Mabel Berezin** of the University of California, Los Angeles.

Political Economy

Gary W. Cox, University of California, San Diego, was presented the Best Book Award for *Making Votes Count: Strategic Coordination in the World's Electoral Systems* (Cambridge University Press, 1997). The award is given annually for the best book on political economy. The Best

Dissertation Award was given to **Alberto Diaz-Cayeros** of Duke University for "Political Responses to Regional Inequality: Taxation and Distribution in Mexico."

Domestic Sources of Foreign Policy

The Best Paper Award was presented to **Mariam F. Elman**, Arizona State University, for "Unpacking Democracy: Presidentialism, Parliamentarianism, and the Democratic Peace Theory"; and **Richard K. Herrmann**, **Philip E. Tetlock**, and **Penny S. Visser**, Ohio State University, for "Mass Public Decisions on Going to War: A Cognitive-Interactionist Framework." The award is given annually for the best paper on domestic sources of foreign policy at the previous APSA Annual Meeting.

Race Ethnicity and Politics

The Organized Section on Race, Ethnicity and Politics awarded three prizes in 1998. The Best Paper Award was presented to **Clare Sheridan**, University of Texas, Austin, for "A Genealogy of Citizenship: Mexican Americans, Race, and National Identity." The award recognizes the best paper on race, ethnicity, and politics presented at the APSA Annual Meeting. The Best Dissertation Award for the best American dissertation on race, ethnicity, and politics was given to **Claire Jean Kim**, University of California, Irvine, for "Cracks in the 'Gorgeous Mosaic': Black-Korean Conflict and Racial Mobilization in New York City." The Best Dissertation Award, for the best comparative dissertation on race, ethnicity, and politics went to **Allaine D. Cerwonka** of the University of California, Irvine, for "Space and Nation in a Global Era: In Search of Australia."
