Paul Anand is Reader in Decision Science and Public Policy at the Open University and Research Associate in the Health Economics Research Centre at Oxford University. He holds a D.Phil. from Oxford University and has previously held a number of posts including research fellowships in Cambridge and Oxford Universities. His current research interests include the logical foundations of social choice and decision theory, applications of social choice to health, and the econometric analysis of capabilities and well-being.

Gilles Dostaler is professor at the Université du Québec à Montréal. Specialist in the history of economic thought, he is the author, amongst other works, of *Economic Thought since Keynes* (with Michel Beaud, Edward Elgar 1995; and Routledge 1997) and *Le libéralisme de Hayek* (La Découverte 2001). His forthcoming book is *Keynes and his Struggles* (Albin Michel and Edward Elgar).

Nir Eyal is a lecturer and postdoctoral fellow at Princeton's Center for Human Values. Currently he is writing a book that develops a consequentialist approach to respect for persons and examines the implications of that approach for political theory and bioethics. Eyal received doctoral training at Oxford and postdoctoral training at the National Institute of Health.

Daniel M. Hausman is the Herbert A. Simon Professor in the Department of Philosophy at the University of Wisconsin-Madison. His work lies mainly at the intersection between economics and philosophy, and he was one of the founding editors of this journal. He is the author of *The Inexact and Separate Science of Economics* (Cambridge University Press 1992) and the co-author of *Economic Analysis and Moral Philosophy* (Cambridge University Press 1996).

Stephen Kershnar is an associate professor of philosophy at SUNY-Fredonia and was formerly an attorney. His research interests are in desert, punishment, and rights. He is the author of *Desert, Retribution, and Torture* (University Press of America 2001) and *Justice for the Past* (SUNY Press, forthcoming).

Harro Maas lectures in history and methodology of economics at the University of Amsterdam. He is currently preparing a book on Stanley Jevons that will appear April 2005 with Cambridge University Press.

Serena Olsaretti is University Lecturer at the Faculty of Philosophy, and Teaching Fellow at St. John's College, Cambridge. She has edited *Desert and Justice* (Oxford

University Press 2003) and is the author of *Liberty, Desert and the Market* (Cambridge University Press 2004). Her research interests are in theories of distributive justice and theories of well-being.

Erik J. Olsson is a Senior Lecturer at Lund University, Sweden. He has published on epistemology, philosophical logic, and philosophy of science in journals like *Journal of Philosophy*, *Mind*, and *Analysis*.

Fabienne Peter is a Lecturer in Philosophy at the University of Warwick. Her research explores issues at the intersection of economics and philosophy, with particular emphasis on theories of justice and of democracy and on the philosophy of the social sciences. Her recent publications include "Choice, Consent, and the Legitimacy of Market Transactions" (this journal) and *Public Health, Ethics, and Equity*, a volume she co-edited with Sudhir Anand and Amartya Sen.

Philip Pettit teaches political theory and philosophy at Princeton University where he is William Nelson Cromwell Professor of Politics and Human Values. Prior to coming to Princeton in 2002, he had been located for many years at the Australian National University, Canberra. His interests include the philosophy of cognitive and social science as well as moral and political theory and he has published widely in these areas. His recent books include *Republicanism* (Oxford University Press 1997), *A Theory of Freedom* (Polity and Oxford University Press 2001) and a collection of his essays, *Rules, Reasons and Norms* (Oxford University Press 2002). Two further books appeared in 2004: Geoffrey Brennan and Philip Pettit, *The Economy of Esteem* (Oxford University Press 2004), and Frank Jackson, Philip Pettit, and Michael Smith, *Mind, Morality and Explanation: Selected Collaborations* (Oxford University Press 2004).

Mozaffar Qizilbash teaches economics at the University of East Anglia. His research focuses on a range of topics cutting across the areas of economics and philosophy. These include well-being, utilitarianism, development, poverty, vagueness, and corruption.

Margaret Schabas is Professor and Head of the Philosophy Department at the University of British Columbia. Her recent book (co-edited with Neil De Marchi), *Oeconomies in the Age of Newton* (Duke 2003) also adds to the literature on Adam Smith. Two forthcoming books are *Nature in Classical Economics* (Chicago) and (co-edited with Carl Wennerlind) *Essays on Hume's Political Economy* (Routledge).

Amartya Sen is Lamont University Professor at Harvard University and was until recently Master of Trinity College, Cambridge. He has served as President of the Econometric Society, the Indian Economic Association, the American Economic Association, and the International Economic Association. He was formerly Honorary President of OXFAM and is now its Honorary Advisor. Born in Santiniketan, India, Amartya Sen studied at Presidency College in Calcutta, India, and Trinity College, Cambridge. He is an Indian citizen. He was Lamont University Professor at Harvard also earlier, 1988–98, and previous to that he was the Drummond Professor of Political Economy at Oxford University and a Fellow of

All Souls College. Prior to that he was Professor of Economics at Delhi University and at the London School of Economics.

Amartya Sen's books have been translated into many languages, and include *Collective Choice and Social Welfare* (1970), *On Economic Inequality* (1973, 1997), *Poverty and Famines* (1981), *Choice, Welfare and Measurement* (1982), *Resources, Values and Development* (1984), *On Ethics and Economics* (1987), *The Standard of Living* (1987), *Inequality Reexamined* (1992), and *Development as Freedom* (1999), among others. His research has ranged over a number of fields in economics, philosophy, and decision theory, including social choice theory, welfare economics, theory of measurement, development economics, moral and political philosophy, and the economics of peace and war. His most recent book, *Rationality and Freedom*, published by Harvard University Press will be followed by a companion volume, *Freedom and Justice*. His next book, *The Argumentative Indian*, is in press.

Amartya Sen has received honorary doctorates from major universities in North America, Europe, Asia, and Africa, and is a Fellow of the British Academy and a Foreign Honorary Member of the American Academy of Arts and Sciences. Among the awards he has received are the "Bharat Ratna" (the highest honor awarded by the President of India); the Senator Giovanni Agnelli International Prize in Ethics; the Alan Shawn Feinstein World Hunger Award; the Edinburgh Medal; the Brazilian Ordem do Merito Cientifico (Grã-Cruz); the Presidency of the Italian Republic Medal; the Eisenhower Medal; Honorary Companion of Honour (UK); and the Nobel Prize in Economics.

Hans Bernhard Schmid lectures in Philosophy at the University of St. Gallen. He is the author of *Subjekt, System, Diskurs: Edmund Husserls Begriff transzendentaler Subjektivität in sozialtheoretischen Bezügen* (Phaenomenologica, vol. 158, Dordrecht 2000) and *Wir-Intentionalität: Kritik des ontologischen Individualismus und Rekonstruktion der Gemeinschaft* (forthcoming). His focus of research is on phenomenology, sociological theory, and social philosophy.

Alex Voorhoeve is a Lecturer in Philosophy and Public Policy in the Department of Philosophy, Logic, and Scientific Method at the London School of Economics. He has published on equal opportunity and on decision-theoretic puzzles in *Economics and Philosophy* and *Philosophy & Public Affairs*.
