Dr. Clark argues for a radical reappraisal of our attitudes to the non-human, urging that widely accepted liberal principles already require us to be vegetarian, and that our failure to be so results from greed and fantasy, not sound argument. The book is a paradigm of moral inquiry, relying at once on reason and on sentiment, but on no particular moral or meta-moral system. £5.95

Theories of relative identity have recently attracted a good deal of attention among philosophers. In this book, Dr. Griffin proposes a theory which incorporates P. T.
