## IRISH DIVISION

THE SUMMER QUARTERLY AND CLINICAL MEETING of the Irish Division was held on Tuesday, 29 June, 1954, at the Royal College of Physicians, Kildare Street, Dublin, by kind permission of the President and Fellows.

Twenty members were present.

The Minutes of the previous Meeting were read, approved and signed.

The date of the Autumn Quarterly Meeting was fixed for Wednesday, 3 November, 1954, at the Royal College of Physicians.

Dr. Dunne was congratulated on the honour done to himself and to the Division on being chosen as President-Elect for the coming year.

Dr. Eveleen O'Brien, who was elected Junior Representative on Council at the last Meeting, asked to be relieved of this appointment. For the time being she found that administrative duties would make it impossible for her to attend the Meetings regularly and she said she would prefer not to act in this capacity for the present. Her resignation was regretfully accepted, and Dr. J. FitzGerald, of Mullingar, was proposed and unanimously elected in her place.

The Secretary read a letter from the Minister for Health indicating that individual proposals from mental hospital managers in relation to the attendance of mental hospital staff at the 5th International Congress on Mental Health in Toronto in August, 1954, would be considered on their merits.

A discussion followed on a recent circular from the Minister for Health asking for views about establishing an ambulance service for mental hospitals to facilitate the admission of patients to mental hospitals. It was generally felt that a special ambulance service for this purpose was unnecessary and that this work should be co-ordinated with the general ambulance service for other medical purposes.

The Meeting then proceeded to the Clinical Session and Dr. F. McEvoy read his communication entitled "Demography and Mental Health".

Dr. McEvoy said that demography was defined as the movements of population, their statistics, with special reference to Malthusian principles—Malthus advocating the curtailing of families in regions where increase of population outstripped food supply. Large and small group movements were listed, and included large scale calamities, immigration and emigration, and from the country to urban and industrial areas. Motives for such movements and problems of mental adaptation were discussed. Problems that followed, some of which were tackled by Industrial Psychologists, were mentioned.

The dynamisms of groups were discussed and advantages and disadvantages of group participation were mentioned, group manipulation becoming more important in social, economic and political fields. A parallel was drawn between Medical Geography and Mental Health, and current psychological problems such as family restriction, divorce and adoption were shown to have some association with Demographic Studies.

A discussion followed the communication in which the following Members took part: Drs. Eustace, O'Sullivan, Moran, Cassin, Coyne, Dunne and Moore.

The Members of the Division, including their wives, were most hospitably entertained to a Sherry party by the Chairman, Dr. H. J. Eustace, after the Meeting.
