# Anglo-Saxon England

The only regular publication devoted solely to Anglo-Saxon studies and to fostering cooperation between them all. It is the editors' intention, by stimulating investigation of the less commonly considered forms of evidence and by bringing related specializations into direct communication, to promote fresh areas of knowledge and to invigorate growth in new directions. A bibliography covering publications in all branches of Anglo-Saxon studies for the previous year should help a reader to keep in touch with current work in specializations other than his own.

## Anglo-Saxon England 2

Place-names, charters, coins and manuscripts are among the forms of evidence studied in this volume. The topics range from the course of English settlement in the south-east to the power and influence of a leading aristocratic family in the tenth century and the possible presence of Jews in England in the eleventh. An important liturgical manuscript, the Bosworth Psalter, is more securely localized; the exemplars of the Vercelli Book and its probable area of origin are clarified. Several motifs in Old English literature are elucidated, and the influence of Christian doctrine on the poetry is considered in a survey of present opinion and in a lively discussion on *Beowulf*. Bede's achievements as a scholar and teacher are examined 1300 years after his birth. The bibliography for 1972 continues the annual series begun in volume 1.
