**Matthew D. Adler** is Richard A. Horvitz Professor of Law and Professor of Economics, Philosophy, and Public Policy at Duke University. He is the author of *Well-Being and Fair Distribution: Beyond Cost-Benefit Analysis* (Oxford University Press, 2012), and, with Marc Fleurbaey, the editor of the forthcoming *Oxford Handbook of Well-Being and Public Policy*. His current scholarship focuses on the theory and implementation of social welfare functions as a framework for evaluating governmental policies.

Urs Fischbacher is Professor for Applied Research in Economics at the University of Konstanz and head of the Thurgau Institute of Economics in Kreuzlingen (Switzerland). His research is focused on the investigation of non-selfish preferences, both experimentally and theoretically. For example, he provided important experimental findings on punishment behaviour, in particular on the role of intentions and responsibility. In addition, he developed the widely used software z-Tree, which allows the efficient implementation of lab experiments.

He is the author of *The Methodology of Experimental Economics* (2005) and co-editor, with Daniel Steel, of *The Philosophy of Social Science Reader* (2011). He works primarily on economic methodology and social ontology, using theoretical and empirical methods.

**Nicole Hassoun** is an Associate Professor in Philosophy at Binghamton University. From 2006–2012 she was an Assistant Professor in Philosophy at Carnegie Mellon University, affiliated with Carnegie Mellon's Program on International Relations and the University of Pittsburgh's Center for Bioethics and Health Law. In 2009–2010 she held a postdoctoral position at Stanford University and visited at the United Nation's World Institute for Development Economics Research. She has also been a visiting scholar
