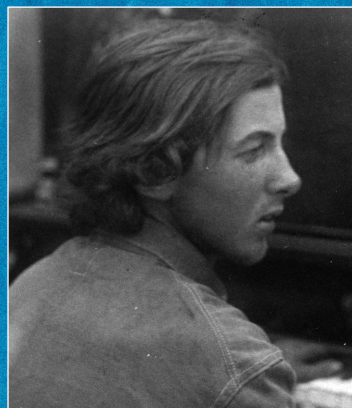

Contributors

Carrie Allen teaches Western classical music history, Christian music in the United States, and African American music at the University of Houston–Downtown. Allen’s work on black gospel music, hip hop, and rock ’n’ roll has appeared at conferences and in the *Black Music Research Journal* and the *Bulletin of the Society for American Music* and is forthcoming in the revised *Grove Dictionary of American Music* and the *Encyclopedia of Southern Culture*.

Julia Bullard is Associate Professor of Viola at the University of Northern Iowa and performs frequently as a chamber musician and soloist in the United States and abroad. She holds degrees in viola, string pedagogy, and music history from Temple University (B.M., M.M.) and the University of Georgia (D.M.A.). She is particularly interested in the music of twentieth- and twenty-first-century female composers.

Walter A. Clark is Professor of Musicology at the University of California, Riverside, and director of the Center for Iberian and Latin American Music. His books include *Isaac Albéniz: Portrait of a Romantic* (Oxford, 1999/2002) and *Enrique Granados: Poet of the Piano* (Oxford, 2006). He edited *From Tejano to Tango: Latin American Popular Music* (Routledge, 2002) and is the editor of the Oxford series *Currents in Latin American and Iberian Music*.

David García is Associate Professor of Ethnomusicology at the University of North Carolina at Chapel Hill. His research focuses on the music of Cuba and the United States. García’s book *Arsenio Rodríguez and the Transnational Flows of Latin Popular Music* was published in 2006 by Temple University Press. His second book will focus on the intersection of African American and Afro-Latino music in the mid-twentieth century.

Chad Hamill is an Assistant Professor of Ethnomusicology at Northern Arizona University. A descendant of the Spokane tribe, Hamill is currently working on a manuscript that explores the musical intersections between Jesuits and Native peoples of the Columbia Plateau region. The book will appear in the series *First Peoples: New Directions in Indigenous Studies*, a collaborative publishing initiative among Arizona, Minnesota, North Carolina, and Oregon State University presses.

Edward Pearsall is Associate Professor of Music Theory at the University of Texas at Austin. His research addresses subjects ranging from cognitive approaches to prolongation in tonal and post-tonal music to theories of rhythm, interpretation, and performance, the music of George Crumb, and biological explorations of music and the mind. He is coeditor (with Byron Almén) of *Approaches to Meaning in Music* (Indiana University Press, 2006).

John D. Spilker is Assistant Professor of Music at Nebraska Wesleyan University, where he teaches courses in the music history sequence, world music, American music, women and music, and the senior capstone seminar. He received the Ph.D. in Musicology from Florida State University in 2010. His current research investigates the resonance of “dissonant counterpoint” among various composers associated with Henry Cowell and the “ultra-modern” network.

Ann Morrison Spinney is the author of *Passamaquoddy Ceremonial Songs: Aesthetics and Survival* (University of Massachusetts Press, 2010) and has taught at Boston College, Brandeis University, and Franklin & Marshall College.

Benita Wolters-Fredlund has published on a wide array of cultural and political musical topics, including music of the Jewish left in North America, music of the Holocaust, and Canadian musical nationalism. She teaches at Calvin College (Michigan). She is an assistant professor of music at Calvin College.
