PROFESSOR TIM CONGDON, C.B.E.

Professor Tim Congdon is Chief Economist, Lombard Street Research Ltd. He is a former Member of the Treasury Panel of Independent Forecasters (the 'Wise Men').

He was awarded the C.B.E. for services to economic debate, and is visiting Professor of Economics, City University Business School and the author of several publications on economics.
