Hugh Last Fund

Applications for grants are invited for financial assistance towards the undertaking, completion or publication of work that relates to any of the general scholarly purposes of the Roman Society, excluding expenses in connection with archaeological or other excavations or surveys, or travelling, hotel, conference or other living expenses of scholars.

Applications, together with two references, should be made before 31 January and emailed to the Secretary (office@romansociety.org). It is the responsibility of applicants to arrange for their references to reach the Society by the same date; the absence of references may adversely affect the Committee's view of an application. Referees should — with the exception of applications from postgraduate students — come from outside the applicant's institution and not be connected with the project for which funding is sought.

Grants administered by the Schools Committee

Grants for Schools

The Society's Schools Committee makes grants to schools to help promote the teaching of Latin and Roman Studies. Most of the grants are awarded for the purchase of textbooks and other books on Roman topics, but the Committee also makes awards to groups, museums and schools organising lectures or study days on Roman themes. Applications from schools planning to start courses in Latin are particularly welcome.

The annual budget is *c.* £10,000, and the usual level of award is £50 to £500. The Committee meets three times a year. Applications should be sent to the Secretary, Roman Society, Malet Street, London WC1E 7HU, or by email (office@romansociety.org) to arrive by 1 February, 1 July or 1 November in any year. There is no special application form, but applicants should provide information about the level of their departmental budget, the type of courses taught, and in the case of applications for books, a list of the books wanted with their prices.

Museum Internship Bursaries

The Society offers a number of bursaries of £250 to support students undertaking an internship in a museum. Internships are normally held sometime during the summer vacation; the exact length and timing is to be agreed between the successful candidates and museum. Museums which have hosted internships recently include the British Museum, the National Museum of Wales, the Great North Museum, the Ashmolean Museum in Oxford, the Fitzwilliam Museum in Cambridge, Corbridge Roman site, and the Roman Baths in Bath. Details of the museums participating in the 2015 scheme will be available on the Society's website from January.

All undergraduate and MA students are eligible to apply. Candidates should apply by letter setting out their reasons for wishing to undertake an internship and outlining any previous experience of working in a museum, and providing the name and email address of a referee. Letters of application should be addressed to the Secretary of the Roman Society, and sent by email (office@romansociety.org) by 31 May 2015.

Hellenic and Roman Societies' Slides Collection

The slides collection contains over 6,700 coloured 35 mm slides covering a wide variety of subjects, including sites on the Greek mainland, the Greek islands, Cyprus, Rome, Italy and the Roman Empire, Etruscan tomb paintings, Greek vases, Roman frescoes and mosaics, the Roman army, and Roman Britain. Slides of artefacts form a large part of the collection and include bronzes, jewellery and vases as well as maps, plans, models and reconstructions. A subject index is available. A Greek slide catalogue is available at £7.50, a Roman slide catalogue at £6.50 *or* both for £12 (postage £1 extra for each catalogue).

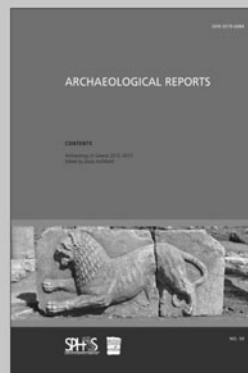

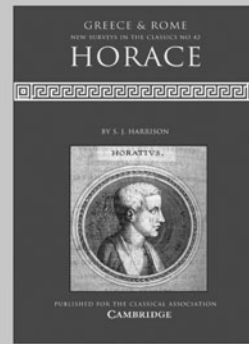
